Theodore Roosevelt banned Christmas trees in response to significant editorial opposition to the cutting down of trees. Despite his objections, Roosevelt's son defied the ban and smuggled in a small tree that was decorated and hidden in a closet in the upstairs sewing room. During his second administration, Roosevelt was told by Gifford Pinchot of the U.S. Forest Service that the practice was not harmful. He allowed a tree upstairs but it was not publicized or photographed.

Dear PRW Members and Friends,

It has been my privilege to serve as your Americanism Chair for 2018. I hope that the articles and trivia throughout this year have been entertaining, interesting, and ever reminding of the incredible privilege it is to be Americans; with the sacred duty to uphold our American Constitution

My first article of the year celebrated the First Ladies of America, who are owed tremendous respect for the magnitude of their role - a role that they all took on voluntarily, simply for the love of Family and Country. My final article for this year celebrates our beautiful, elegant, accomplished, and open-hearted First Lady Melania Trump.

The information below is taken from various White House Publications.

First Lady of the United States, Melania Trump, is the wife of President Donald J. Trump, the 45th president of the United States. Donald and Melania Trump have one child, Barron Trump. Melania Trump is the second First Lady born outside of the United States, and she is the only First Lady to become a naturalized U.S. citizen. Melania is fluent in Slovenian, English, French, Serbian, Italian and German..

Melania was born Melanija Knavs (Germanized to Melania Knauss) on April 26, 1970, in Novo Mesto, Slovenia (then part of communist Yugoslavia). Her father was a car dealer and her mother was a designer for children's clothing. She grew up in a modest home with her younger sister and later discovered she had an older half-brother, whom her father had from a previous relationship.

At age 16, she began what would soon become a highly successful modeling career, appearing in many high-profile ad campaigns, traveling extensively, and working with some of the most celebrated photographers in the fashion industry.

In 1996, Melania moved to New York and ten years later, she proudly became a United States Citizen. In 2005, she married Donald Trump. She has always been an active member of her community. Also in 2005, she was Honorary Chairwoman for the Martha Graham Dance Company, and additionally was awarded Goodwill Ambassador by the American Red Cross—a role she served in for four years. She served five years as Honorary Chairwoman for the Boys' Club of New York and was named Woman of the Year in 2006 by the Police Athletic League. Mrs. Trump has participated in National Love Our Children Day and National Child Abuse Prevention month, ringing the closing bell at NASDAQ.

In 2010, Mrs. Trump was the Chairwoman for the American Heart Association, which raised \$1.7 million for research. That same year she launched her own jewelry collection.

In her role as First Lady, Mrs. Trump focuses her time on the many issues affecting children. An unwavering characteristic of the First Lady is her aptitude for showing love and compassion in all that she does. Mrs. Trump spends much of her time meeting with children who are patients at hospitals and care centers. Recently, she took valentines to the Children's Inn at the National Institutes of Health and Cincinnati Children's Hospital. Over the Easter holiday, she made a surprise visit to St. Mary's Medical Center in Palm Beach, Florida, bringing Easter baskets to the children. Following the devastating hurricanes last year, Mrs. Trump visited Texas to meet with families that suffered greatly under Hurricane Harvey. In the wake of two horrendous mass shootings, Mrs. Trump traveled with her husband to Las Vegas and Parkland to be with the victims and families in their times of need. Internationally, Mrs. Trump has visited several hospitals and schools. One of her most memorable visits being at the Pediatric Hospital Bambino Gesù in the Vatican City, where she met a boy who had been waiting for a new heart. Upon arrival in Belgium the following day, Mrs. Trump learned that the hospital had found a transplant for the boy—Mrs. Trump celebrated the news in a press statement and said "my own heart is filled with joy over the news."

As First Lady, Mrs. Trump has made multiple visits to schools—both foreign and domestic. From participating in a Viking huddle class, which focuses on emotional learning at Orchard Lake Middle School in Michigan, to taking the Queen of Jordan to Washington, D.C.'s first public charter school for girls at Excel Academy in Southeast, Mrs. Trump is always bringing children to the forefront of her agenda. While traveling abroad, Mrs. Trump visited the American International School in Riyadh, Saudi Arabia, with Education Minister Ahmed Al Eissa, and took a calligraphy lesson with local children at Kyobashi Tsukiji Elementary School with Mrs. Abe while visiting Japan. Earlier this spring, Mrs. Trump invited a group of local students to the White House so she could talk with them, hear their stories, and understand the issues they are challenged with today. Mrs. Trump addresses those issues each opportunity she gets. From Governors' spouses' luncheons to the United Nations General Assembly, Mrs. Trump puts the emphasis on children and how we can protect them, teach them, and empower them.

In the midst of the opioid epidemic, Mrs. Trump has utilized her platform as First Lady to raise awareness about the dangers of opioid abuse—notably the devastating effects it has on infants and unborn babies. Mrs. Trump traveled to Huntington, West Virginia, where she visited Lily's Place, the Nation's first nonprofit infant recovery center that prioritizes the whole family to ensure infants born dependent on drugs are given the best

opportunity to thrive. More recently, in February, Mrs. Trump traveled to Ohio to visit Cincinnati Children's, a leading pediatric hospital where she learned more about the ongoing research around neonatal abstinence syndrome (NAS)—a harmful result of drug abuse in pregnant mothers. Mrs. Trump has participated in multiple opioid summits and continues to work with the Administration on raising the awareness of opioid abuse and how we can better protect children from it.

On May 7, 2018, Mrs. Trump unveiled her platform, "Be Best." The program focuses on three key objectives: well-being, fighting opioid abuse and positivity on social media. "As a mother and as first lady, it concerns me that in today's fast-paced and ever-connected world, children can be less prepared to express or manage their emotions and oftentimes turn to forms of destructive or addictive behavior such as bullying, drug addiction or even suicide," she said. "I feel strongly that as adults we can and should be best at educating our children about the importance of a healthy and balanced life."

Toys for Tots Toy Drive

In 1894, three years after electricity was introduced in the White House, **Grover Cleveland** became the first president to have electric lights on a Christmas tree.

William McKinley downplayed Christmas celebrations, and there is no evidence the holiday was marked during his four years in the White House. The President avoided discussions of Christmas because it was a sensitive topic with his wife. The McKinley's first daughter, Katherine ("Katie"), was born on Christmas Day in 1871 but passed away four years later of typhoid fever.

William Howard Taft lifted Roosevelt's ban on Christmas trees.

December PRWC Meeting



The tradition of the National Christmas Tree on the Ellipse began with **Calvin Coolidge** on Christmas Eve 1923, when he lit a 48 foot Balsam Fir from Vermont decorated with 2,500 electric bulbs in red, white, and green. The first official White House Christmas cards and the first Christmas message were both from Coolidge.

In 1923, **Franklin Roosevelt** first started sending out large numbers of Christmas cards. FDR collected Christmas cards and had over 3000 different designs. They are periodically put on display at his presidential library. Electric light was rationed during WW II, and there was no tree lighting ceremony.

The Religion of Leftism

Over the last decade, America has [moved drastically to the left](#). Not only are more people on the left than ever before, the left is [further left](#) than it's ever been. This radical brand of progressivism has come to be known as "leftism"—an extreme yet increasingly dominant segment of the political spectrum.

At the same time, America has grown more secular. According to Pew, "religious nones" are [rapidly growing](#) in number. These "nones" are most concentrated among millennials: 36% of millennials are religiously unaffiliated. Millennials happen to also be America's most politically progressive generation.

This probably isn't a coincidence, especially since the same trends have occurred in a similar way in other parts of the world, such as Europe. While correlation doesn't prove causation, politics and religion are so closely related that it's hard to believe the simultaneous popularization of extreme leftism and secularism is insignificant.

My theory is this: the country hasn't actually become less religious. Many people have simply replaced traditional religion with leftism. Rather than associating with Christianity, for example, which demands repentance and promises persecution, they have opted for a religion that conveniently offers a sense of righteousness but denies the need to take responsibility for their own actions.

Leftism provides many of the same comforts that religion does without the expectation of personal sacrifice. Its adherents can feel that they're caring for the "least of these" because they vote for policies that empower the government to offer more welfare to the poor. It is a lazy form of compassion, and it is appealing to those who want to pat themselves on the back without having to voluntarily spend of their own time, energy or money.

On a personal level, unlike Christianity, leftism doesn't worry its adherents with sin and life-change. The only sin is to say there's sin. The only wrong is to say there's wrong. The highest virtue is one's own happiness, and the only truth is that which one finds in themselves. This, of course, is antithetical to what the Bible teaches, which is part of why it is very difficult—if not altogether impossible—to be a Bible-believing Christian and a radical leftist.

But there's another reason. While leftism may not require personal responsibility, generosity or morality, it does demand everything of its devotees. It aims to conform the mind, the heart and the soul fully to its agenda. There is no room in leftism for disagreement on abortion, gender, sexuality, immigration, race or economics. All reasoning must be guided by intersectionality. All thoughts must be centered on some vague notion of social justice. There is no tolerance for defection.

That's a problem for religious people, who are bound to a higher calling than that of any political ideology, and whose values are often incongruent with the controlling ethics of leftism. Many religious people are against abortion. Many religious people are for traditional marriage. Many religious people fear that too much government will mean less religious liberty. So, these religious people have a choice to make: allow their spiritual principles to submit to leftism, or allow their politics to be guided by their spiritual principles, which, undoubtedly, disqualifies them from being a "good" leftist.

Christianity, in particular, is incongruent with this brand of leftism. Jesus asks his disciples to deny themselves, take up their crosses and follow Him (Luke 9:23). So does leftism. Jesus asks for Christians' whole hearts. So does leftism. No person can serve two masters (Matthew 6:24). Those who identify as Christians and as leftists have either not yet discovered the complete sacrifice that will eventually be asked of them by leftism, or they've already abandoned their religious views in favor of their political ideology.

Leftism is not just against traditional religion; it has replaced it. It is its own religion. And, like all religions, it excludes adherence to any competing value system. It is its religious nature that has made its believers so fiercely defensive. It is why they cannot stand disagreement. Those who disagree are not just wrong, they're blasphemers, heretics and apostates who must be dealt with accordingly.

Religious people can have legitimate differences on policy without forsaking their values. They can honestly disagree on taxation, immigration, guns, welfare and healthcare and still unite under the banner of their faith. Since God transcends political parties, and is therefore neither a "conservative" nor a "progressive," there is room for debate between religious people of various political views. But it is very difficult for religious people to ascribe to *any* ideology that both opposes their beliefs and demands all-consuming worship the way leftism does.

That is why so many, it seems, have abandoned the perceived strictness of religious institutions and opted instead for the religion of leftism, which simply requires that you leave all moral, social and economic decisions up to the progressive powers-that-be. What they may soon realize, however, is that the government is not—and never has been—a merciful god.

The first President to broadcast a Christmas message was **Herbert Hoover** in 1929.

From 1948 to 1952 there was no White House Christmas Tree for **Harry Truman**. The building was being re-constructed. Truman had a Blair House Christmas Tree.

Legislative Report

In Memory of President George H. W. Bush, 41st President of the United States - 1024-2018



George Bush brought to the White House a dedication to traditional American values and a determination to direct them toward making the United States “a kinder and gentler nation.” In his Inaugural Address he pledged in “a moment rich with promise” to use American strength as “a force for good.”

Coming from a family with a tradition of public service, George Herbert Walker Bush felt the responsibility to make his contribution both in time of war and in peace. Born in Milton, Massachusetts, on June 12, 1924, he became a student leader at Phillips Academy in Andover. On his 18th birthday he enlisted in the armed forces. The youngest pilot in the Navy when he received his wings, he flew 58 combat missions during World War II. On one mission over the Pacific as a torpedo bomber pilot he was shot down by Japanese anti-aircraft fire and was rescued from the water by a U. S. submarine. He was awarded the Distinguished Flying Cross for bravery in action.

Bush next turned his energies toward completing his education and raising a family. In January 1945 he married Barbara Pierce. They had six children— George, Robin (who died as a child), John (known as Jeb), Neil, Marvin, and Dorothy.

At Yale University he excelled both in sports and in his studies; he was captain of the baseball team and a member of Phi Beta Kappa. After graduation Bush embarked on a career in the oil industry of West Texas.

Like his father, Prescott Bush, who was elected a Senator from Connecticut in 1952, George became interested in public service and politics. He served two terms as a Representative to Congress from Texas. Twice he ran unsuccessfully for the Senate. Then he was appointed to a series of high-level positions: Ambassador to the United Nations, Chairman of the Republican National Committee, Chief of the U. S. Liaison Office in the People's Republic of China, and Director of the Central Intelligence Agency.



In 1980 Bush campaigned for the Republican nomination for President. He lost, but was chosen as a running mate by Ronald Reagan. As Vice President, Bush had responsibility in several domestic areas, including Federal deregulation and anti-drug programs, and visited scores of foreign countries. In 1988 Bush won the Republican nomination for President and, with Senator Dan Quayle of Indiana as his running mate, he defeated Massachusetts Governor Michael Dukakis in the general election.

Bush faced a dramatically changing world, as the Cold War ended after 40 bitter years, the Communist empire broke up, and the Berlin Wall fell. The Soviet Union ceased to exist; and reformist President Mikhail Gorbachev, whom Bush had supported, resigned. While Bush hailed the march of democracy, he insisted on restraint in U. S. policy toward the group of new nations.




In other areas of foreign policy, President Bush sent American troops into Panama to overthrow the corrupt regime of General Manuel Noriega, who was threatening the security of the canal and the Americans living there. Noriega was brought to the United States for trial as a drug trafficker.




Bush's greatest test came when Iraqi President Saddam Hussein invaded Kuwait, then threatened to move into Saudi Arabia. Vowing to free Kuwait, Bush rallied the United Nations, the U. S. people, and Congress and sent 425,000 American troops. They were joined by 118,000 troops from allied nations. After weeks of air and missile bombardment, the 100-hour land battle dubbed Desert Storm routed Iraq's million-man army.

George H. W. Bush passed away on November 30, 2018, at the age of 94.

Congressional Gold for Benghazi Ghosts: H.R. 2315

After a broadly contentious midterm elections season, I found it difficult to consider the shape of anything even remotely resembling bipartisanship in the United States Congress. Yet, when I least expected it, I was actually surprised by the United States Congress.

On November 17, 2018, I found out about a bill moving through the House floor that struck a personal resonance with me. It is H.R. 2315. It is sponsored by Congressman Stephen Lynch (D-MA 8) and was originally introduced on May 3, 2017. This bill seeks to posthumously honor the four victims of the Benghazi attacks, Ambassador Chris Stevens, Tyrone Woods, Glen Doherty and our nephew Sean Smith with the Congressional Gold Medal.

The Congressional Gold Medal is a high honor that has been bestowed on Americans as diverse as George Washington to George Gershwin. It is given to individuals that have made a mark in American history or culture.

I found out about H.R. 2315 from a dear friend of my mine, Lt. Col. Dennis B. Haney, USAF (Ret). Denny is a Vietnam era Jet Fighter Pilot, affectionately known as a United States Air Force Wild Weasel Pilot. I have known Denny for about five years when he and the folks at Special Operations Speaks were supporting the push by victim family members and fellow citizens who were seeking to establish an atmosphere of accountability about Benghazi. Denny is also a member of the Citizen's Commission on Benghazi and the Citizen's Commission on National Security, among many accomplishments. Denny is also a very true and wiser older brother by different parents.

So on the afternoon of November 17th, I left a message on Congressman Stephen Lynch's voice mail. On the 19th, I received a message from the Congressman's office asking me to call back. On the 20th, I spoke with one of his staff. To preserve their privacy, they shall remain nameless in the context of this article.

Speaking with one of Congressman Lynch's staff members, on December 20th, I advised them that by perusing congress.gov I was aware that the bill currently had 250 co-sponsors. I told them that I thought that a bill normally would pass with 218 votes. They advised me that as the Financial Services Office of Congress struck and paid for Congressional Gold Medals, they required 290 co-sponsors. That equals three quarters of the House of Representatives. That actually is fine with me as it left no room for this to be politicized.

Congressman Lynch's Staff was helpful, kind and informative. On November 20th, when there were 253 co-sponsors, I found a copy of Congressman Lynch's most recent, for the time, "Dear Colleague" letter. Congressman Lynch's language was straight forward and inspiring.

*"In view of the recent sixth anniversary of the September 2012 terrorist attack on the U.S Consulate and classified annex in Benghazi, Libya, it is important that Congress recognize those brave individuals that sacrificed their lives to defend our great nation and its values. To this end, we have introduced bipartisan legislation, H.R. 2315, to posthumously award the Congressional Gold Medal to **Ambassador J. Christopher Stevens**, former Navy Seal **Glen Doherty**, former Navy Seal **Tyrone Woods**, and U.S. State Department Officer **Sean Smith** in recognition of their lifetime commitment to the safety and security of the American people."*

Congressman Lynch's words are moving and I find his intent to be respectful with a sincere desire to offer tribute to the Benghazi victims. If only members of the previous administration had demonstrated that same commitment to the safety and security of all Americans deployed to foreign countries including the Benghazi Four and their Colleagues.

When I read the list of co-sponsors on this bill, I was amused and amazed. After all, some of the folks who signed on to H.R. 2315 were some of the same folks that called the Benghazi victim family members liars and worse. Individuals who compared Benghazi to a walking corpse and other statements too ridiculous to repeat here. I will not give the guilty any publicity by naming them here.

But whether one co-sponsors a bill out of guilt, over midnight worries about one's legacy or doing the right thing, it makes no matter to me. After all, in the past six plus years, I first sought more knowledge about Benghazi, than sought accountability for those responsible for the murders. Keeping a keen eye on this bill I saw the count for this bill climb to 295 and finally to 298. With the recent passing of President George H.W. Bush and the approaching holidays, it seemed the bill might roll into 2019. Than on December 12, 2018, approaching that 11th cocktail hour, H.R. 2315 passed the House, unanimously, by a voice vote.

H.R. 2315 moved from the House to the Senate on December 13th. It has been assigned the Senate bill number, S.1906. I am praying that S.1906 moves efficiently through the Senate. It is past time to honor the Benghazi Four.

By the way, and I have written and spoken about this before, all public schools should teach their students how to navigate the congress.gov website. It can teach current and future generations how to pay attention to the workings of the legislative process. A focused attention is vital for the strength of our people, so that we can remain vigilant and continue to combat tyranny.

The tragedy of Benghazi must not be swept away with this recognition but the need for accountability and justice are illuminated by this bright point of light. Sometimes one small point of light can fully illuminate the darkness. Sometimes truth, and it's close cousin justice, can make its presence known in the wake of that illumination. For myself and the other family members, may Almighty God engulf our world with the light of truth and justice. We have been on the path of justified suspicion for far too long. It is time for the illumination of accountability to be framed by the light of honor.

8:43 - The council equality officer arrived and threatened me with eviction.


8:45 - TV news crew from ABC showed up. I was asked if I know the difference between snowmen and snow-women? I replied "Snowballs" and am now called a sexist.


