President's Byline



In the past two weeks we have seen two major events relating to the second amendment of the constitution. One was an infringement on liberty, while the other was a victory for freedom. In the same week the United States Supreme Court (SCOTUS) affirms the second amendment is not a "second class right" and rules unconstitutional a 110 year old restrictive New York state gun law restricting citizens from carrying firearms outside their homes, our own Texas Senator John Cornyn (yes the same Senator nearly booed off the stage at the Texas GOP convention last week) led a campaign to weaken the second amendment by pushing through a gun control bill that President Biden signed into law on 6/25/22.

Let's start with the basics. The second amendment in the Constitution of these United States reads: "**A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.**"

The Infringement

The "Safer Communities Act", the title itself should have been our first clue this was a cave in to the "liberal we must do something" crowd that raises its shrill voice every time we have a tragedy. When a bill is presented to Congress with a title shouting "How can I vote against a bill protecting kids" and with no time to debate or re-view...giant red flags should be going off in your heads...but we will cover red flags later.

Why the "Safer Communities Act", the proposed legislation following the Uvalde Robb Elementary School shooting is harmful to the second amendment and to your liberty:

It does little or nothing to address recent violent crimes while adding additional burdens on the exercise of the Second Amendment freedom for law-abiding gun owners.

This new law includes grants for states that implement their own red flag laws, an abuse of due process, taking your guns at the whim of a bureaucrat before your day in court. It would expand background checks for gun buyers under 21 (Applying a burden and a de facto 21 day waiting period on citizens of legal age), creates penalties for straw purchases of firearms (We already have this law codified but it's not enforced so why add it again), requires more gun sellers to register as Federally Licensed Firearm Dealers (Forcing people who may sell an occasional gun at a gun show to become licensed dealers or become felons).

As the National Rifle Association, the oldest Civil Rights organization in the US said this; this legislation would "*use federal dollars to fund gun control measures being adopted by state and local politicians. This bill leaves too much discretion in the hands of government officials and contains undefined and overbroad provisions –inviting interference with our constitutional freedoms.*" Well stated."

Remember the last line of the second amendment: "**the right of the people to keep and bear Arms, shall not be infringed.**" As a conservative and a Republican, I personally view any new gun law as an infringement and this one certainly fits that definition. Guns have been present in our society for decades. We have changed as a people. Life is not valued; the family unit has been decimated by liberal policies. You cannot legislate morality.

Now that I have depressed you, let us move on to the positive developments to our second amendment freedoms.

The Court affirmed that the right to bear arms does not stop at a person's front door. This is the most significant positive for freedom, Second Amendment ruling in more than a decade. Please see a quote below from the NRA's Institute for Legislative Action which says it best:

"The case challenged New York's requirement that applicants for concealed carry licenses demonstrate "proper cause" to carry a firearm outside of their home. New York routinely used this requirement to deny law-abiding citizens the ability to properly protect themselves. New York is one of eight states that operate under such a "may issue" regime, and the NRA has long fought to abolish this practice in favor of "shall issue" or "constitutional carry" in which law-abiding citizens can exercise their right to carry if they meet certain objective criteria."

This is a true victory and needed in today's climate of increasing crime and "Woke" mobs rampaging through our streets like children every time a court upholds a traditional American value or the Congress a constitutional right. This ruling established the right to carry does not disappear at a person's front door but stays with the person in his / her daily life to allow the right to keep and bear arms. The Supreme Court's ruling marks the end of these subjective, unconstitutional permitting schemes.

Thank God and our past Republican Presidents for the Conservative Supreme court Majority! The current conservative supreme court justices should be protected and valued as the assets they are.

Legislative Report



As the Supreme Court of the United States heads into their summer travel time, they are dropping opinions electronically as often as every ten minutes today. Let's pray for our nation as these decisions are released, and for the safety of our Justices. If you want to watch for today's latest opinions, scroll down the page on this link.

While most folks, like me, are watching for the overturning of the Roe-v-Wade decision, there were a couple of other interesting decisions out of the Supreme Court yesterday that you will probably not hear about in the major press, but are very important to affirming election integrity and the second amendment. These are big wins for constitutional rights.

Here's the question: Who has the right to defend a bill passed by the legislature of a state? In North Carolina, for over three years, this has been the question. The bill in question is a Voter ID law that has faced challenges in both state and federal courts, and has not yet (more than three years later) gone into effect. The legislature passed the bill, the governor vetoed it, then the legislature passed it with enough majority to make the bill veto-proof. The voters in North Carolina then amended their state constitution in 2018 to make Voter ID the law. Litigants against the bill sued to stop the enforcement of the legislation, and it was, according to lower courts, only the State's Attorney General who could fight on behalf a state's legislation. But what if a State's Attorney General didn't like a bill? What if he or she disagreed with the legislation or thought the bill was not in the state's best interest, therefore only somewhat (or not at all) defended the bill in the court case?

In an 8-1 decision, the Supreme Court has ruled that legislators may intervene on behalf of the state and those they represent. Justice Neil Gorsuch wrote: "Through the General Assembly, the people of North Carolina have authorized the leaders of their legislature to defend duly enacted state statutes against constitutional challenge. Ordinarily, a federal court must respect that kind of sovereign choice, not assemble presumptions against it." Why is this important? It takes the only defense of bills away from a single individual if needed. Hope we never need it in Texas (we have a wonderful track record when it comes to our Attorney General), but glad that options are available for states that have a rogue Attorney General who will not enforce or defend the laws that are duly passed.

Another ruling by the Supreme Court yesterday struck down a New York law that has been around for a hundred years requiring anyone applying for a license to carry a concealed weapon to prove both "proper cause" and "good moral character." In this 6-3 decision, the majority opinion, written by Justice Clarence Thomas, states that the law's restrictions violate the Second and Fourteenth Amendments which "Protect an individual's rights to carry a handgun for self-defense outside the home." ... "The constitutional right to bear arms in public for self-defense is not a second-class right, subject to an entirely different body of rules than the other Bill of Rights guarantees,"... "We know of no other constitutional right that an individual may exercise only after demonstrating to government officers some special need. That is not how the First Amendment works when it comes to unpopular speech or the free exercise of religion. It is not how the Sixth Amendment works when it comes to a defendant's right to confront the witnesses against him. And it is not how the Second Amendment works when it comes to public carry for self defense."

When we in the Texas Legislature passed HB 1927 known as "Constitutional Carry" last session, it was opined by some that we would have the wild west here as a result of this bill. It just hasn't happened. In Texas, we understand that defending ourselves may be needed at any time, and it is not up to someone else to decide if we have "proper cause" and "good moral character". By the way, yesterday's Supreme Court decision will change the gun laws, not just in New York, but in 5 other states as well. Thank God for Texas!

LT. GOV. DAN PATRICK: STATEMENT CELEBRATING U.S. SUPREME COURT'S *DOBBS V. JACKSON WOMEN'S HEALTH ORGANIZATION* RULING

June 24, 2022

AUSTIN – Lt. Gov. Dan Patrick issued this statement today praising the U.S. Supreme Court's ruling in *Dobbs v. Jackson Women's Health Organization*, overturning *Roe v. Wade*:

"Today is a tremendous day for life. The U.S. Supreme Court's decision in *Dobbs v. Jackson Women's Health Organization* adheres to the constitution and returns the decision on abortion back to the states. Because of our trigger bill that we passed last year, in 30 days, abortion will be banned in Texas. I thank God for delivering us this day, and I am so proud that Texas has taken the lead to ensure that such evil can no longer live in our state.

"Since I first took office in 2007, protecting life has been my top priority. In 2011, I authored the Sonogram Law, and in 2021, I was proud to lead the Texas Senate in passing the Heartbeat Act, which dramatically reduced the number of abortions that occur in Texas.

"Media estimates report that as many as 62 million innocent lives have been ended since the Supreme Court decided *Roe v. Wade* in 1973. Words cannot do that unfathomable number justice. The left will surely fight to keep the abortion industry alive in Texas, but they will fail.

"The Supreme Court's ruling is an acknowledgement of the truth: when an abortion is performed, a human life is ended. This watershed victory is not just a victory for innocent life, but a victory for all of humanity."

Governor Abbott Statement On U.S. Supreme Court Decision To Uphold Biden Administration's Termination Of Remain-In-Mexico Policy

Governor Greg Abbott today issued a statement after the Supreme Court upheld the Biden Administration's decision to terminate the Remain-in-Mexico policy in *Biden v. Texas*:

"The Supreme Court's decision upholding DHS's termination of the Remain-in-Mexico policy will only embolden the Biden Administration's open border policies. More than fifty people recently died in a trailer—people who were allowed to cross our border illegally because of President Biden's policies. Reinstating and fully enforcing Remain-in-Mexico would deter thousands more migrants from making that deadly trek, and President Biden should take that simple step to secure the border because it is the only humane thing to do."

SENATOR TED CRUZ: 'THE ABILITY TO PRAY IS A GOD-GIVEN AND CONSTITUTIONAL RIGHT'

WASHINGTON, D.C. – U.S. Senator Ted Cruz (R-Texas), Ranking Member of the Subcommittee on The Constitution for the Senate Judiciary Committee, today issued the following statement on the U.S. Supreme Court's decision in *Kennedy v. Bremerton School District*.

"Today, the Supreme Court reversed the Ninth Circuit's decision that allowed Coach Kennedy, a high school football coach in the State of Washington, to be fired for silently kneeling and praying after his team's games. The legal question at the heart of this case was whether the Ninth Circuit Court of Appeals got it right when they ruled that the Establishment Clause of the First Amendment, which prevents government from establishing a religion, means that a government institution must fire a public employee who privately practices his or her faith if there's a chance someone may interpret the individual's expression of faith as government-endorsed religion. Not only is that conclusion patently absurd, it completely ignores the original understanding of the First Amendment and Supreme Court precedent. That's what the Supreme Court corrected today.

"The Establishment Clause is frequently misunderstood—it's not some kind of disinfectant used to silence individuals who exercise their faith or to remove faith from the public square. Rather, both the Establishment Clause and the Free Exercise Clause are meant to operate in tandem to stop government from persecuting faith, as we saw the Bremerton School District do to Coach Kennedy. I am proud to be part of a group of 11 Senators and 14 Representatives that filed an amicus brief with the Court that argued in defense of Coach Kennedy's free exercise of his faith. I'm thankful the Supreme Court fully enforced the First Amendment—in a major victory for religious liberty—and upheld our God-given right to practice our faith."



Constitutional Minute Series

The Recent Notion That Rights Are Not Absolute

Americans Should Not Be Stripped of Their Ability to Defend Themselves Against Lawlessness Recently many in government and politics, in reaction to a violent and lawless few, have reignited the cry to “limit the legal ability” of Americans to buy and possess certain firearms. The states must protect the people from such federal overreach.

President Biden and others have said that our Rights are “not absolute” therefore those in government possess the authority to limit, define, and regulate away our Rights. If this rhetoric is true, then no one in America possesses ANY rights, they only have privileges granted at the pleasure of government. How is it that inherent rights endowed to man by the Creator are “not absolute,” but the crisis-driven dictates from the ever changing turnstile of elected officers ARE absolute?

Here's the truth: that which is absolute in our republican form of government is the Constitution (Article 6, Clause 2). It is the Constitution of the United States that limits and defines the authority delegated to the federal government. The Constitution and its underlying principles DEFINE the limits of government authority. Within that Constitution there is NO AUTHORITY resting in the federal government to regulate, define, or limit the Rights of the People. This is particularly true with the Right to Keep and Bear Arms. Not only is there no power delegated to the federal government to create any law or regulation regarding the purchase or possession of firearms (no, that's not where the commerce clause kicks in), the Second Amendment has very absolute language prohibiting the federal government from limiting or regulating this right (Not to mention that to guard against a tyrannical federal government is the core reason WHY this inherent right is enshrined within the Constitution). It is not “the will of the majority,” as politicians and pundits suggest, that is the basis of government. When the majority's will advocates the suspension of due process and the revocation of a person's natural rights (rights which all officials involved in this debate swore an oath to uphold), that is how slavery gets its legal foothold.

The solution to a federal government overreaching its delegated authority as presented by those who drafted our government's blueprint is straightforward: the States must refuse to impose and enforce these laws and prevent the federal government from doing the same within their State. The Supreme Court of the United States quoted James Madison's explanation of this action in *Mack,Prinz v. US*:

“Hence a double security arises to the rights of the people. The different governments will control each other, at the same time that each will be controlled by itself...” Federalist 51

“The local or municipal authorities form distinct and independent portions of the supremacy, no more subject within their respective authorities than the general authority is subject to them, within its own sphere.” Federalist 39

The States are a “double security” to the preservation of the people's rights because the State will be a control on the unconstitutional exercise of power by the federal government against pretended power within the states' jurisdictions.

The Supreme Court of the United States reiterated this principle in the majority opinion of *NFIB v. Sebelius*, when Justice John Roberts wrote:

“In the typical case we look to the States to defend their prerogatives by adopting the “the simple expedient of not yielding” to federal blandishments when they do not want to embrace federal policies as their own. The states are separate and independent sovereigns. Sometimes they have to act like it.”

The right to individually secure our life, liberty, and property is no different than our rights to freedom of speech, freedom to peaceably assemble, or freedom to worship and live out our faith. A law that prohibits a person from possessing any degree of property, but especially property essential to the personal security of individual rights, without due process, ought to be rejected. Capricious legislature moved by the tragedy du jour should not be the model for sound and stable government charged with protecting liberty. Rather than removing liberty under the guise of protecting children, we should protect liberty so that people can be free to protect themselves. Remember, violent criminals don't obey gun bans and the victim is always the first person on the scene so why not empower the would- be victim to protect themselves rather than removing their ability to do so. The cold reality is that gun-free zones is a stripping of Americans' natural right to defend themselves and has led to the death of many innocent children, as violent criminals ignore the signposts and slaughter the law-abiding. State Governors, Legislators, and Sheriffs must declare publicly and openly that they will uphold their oath to the Constitution of the United States and the Constitution of their State by refusing to enforce and refusing the federal government the jurisdiction to enforce any limit upon the Rights of the People, to include the Right to keep and bear arms. I do solemnly swear (or affirm) that I will support the Constitution of the United States and the Constitution and laws of the State of (name of State), and that I will faithfully discharge the duties of the office of (name of office) to the best of my ability. Background:

The Declaration of Independence lays before us the premise and purpose of all governments, past, present, & future. It states:

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.— That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed.

Sole Purpose of Government:

Secure the Rights of All People Equally and Individually

It is evident that the entire purpose of any form of government is to secure the rights of the individual citizen. The Rights our foundational documents refer to are those classified as “inherent rights:” and they consist of life, liberty, property, and the right to personally secure them in the best manner possible. The most basic of natural rights is the right to self-preservation, to which the natural right to secure property is connected. No person is secure in their life if they cannot also personally secure that life and the property upon which life is dependent. If a person is in danger of loss of life, liberty, or property and has not the personal right, along with the individual ability, to secure these essential rights, then each person is dependent upon someone else’s desire to protect them, reducing every person to that of an indentured or tributary slave, indebted in life to those who are tasked with its security.

Origin of Legislative Power:

Individual Rights Precede Legislative Power, Therefore Legislative Power Exists Solely To Ensure Individual Rights.

The legislator with his delegated responsibility, cannot be exalted above the inherent rights of the individual which he is charged to protect. The majority of Americans would agree that a single dictator with the power to oppress all is a wicked and unjust government. Please then explain, how the tyranny of the majority is any different than the despotism of one in the lives of those whose rights are violated?

Majority Rule is synonymous with Tyranny of the Majority Not with Liberty

The “Rule of Law” is a term that has been understood throughout history to mean a standard to limit the overreach of government and curb lawlessness. It does not mean the authority of the government to rule over the people. The independent states of America and their central

government were created with written Constitutions to maintain a written limited standard for government to prevent the will of the majority and those who govern to usurp the rights of the individual. The so-called "will of the majority" cannot be synonymous with the rule of law. 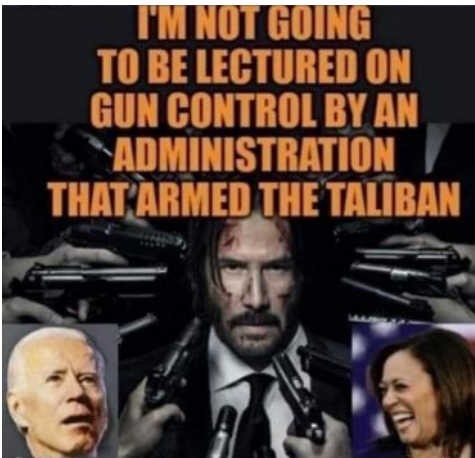

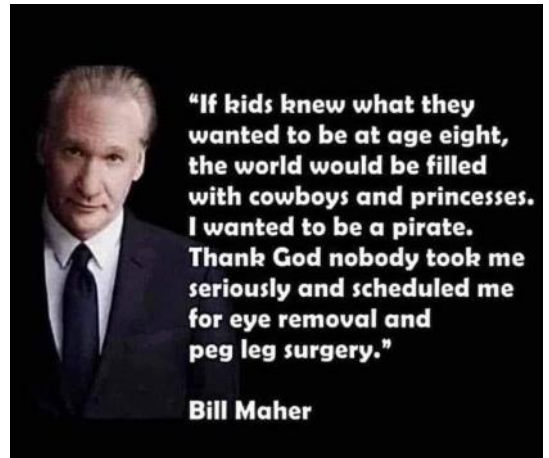
It becomes the duty of all who love and respect the Rights of their children to protect the citizen from the unjust operation of government.

Cornyn Dismisses NRA Opposition to Senate Gun Control Bill

The top Republican negotiator for the Senate's newly unveiled gun control bill signaled on June 22 that the National Rifle Association's (NRA) opposition to the bill did not matter.

"We worked with the NRA to listen to their concerns. But in the end I think they have a membership and a business model that will not allow them to support any legislation," Sen. John Cornyn (R-Texas) told reporters on Capitol Hill in Washington.

"And so I understand where they're coming from, but I think most people will not allow any outside group to veto good public policy," he added.

The 80-page legislative proposal, which drew initial support from 14 Republicans and all Democrats, would alter federal law on gun ownership for those convicted of domestic violence, add funding for so-called red flag laws, and intensify background checks for people under 21 trying to get a firearm.

The NRA said it would support legislation "that improves school security, promotes mental health services, and helps reduce violent crime" but that the group opposes the proposal "because it falls short at every level. It does little to truly address violent crime while opening the door to unnecessary burdens on the exercise of Second Amendment freedom by law-abiding gun owners."

"This legislation can be abused to restrict lawful gun purchases, infringe upon the rights of law-abiding Americans, and use federal dollars to fund gun control measures being adopted by state and local politicians. This bill leaves too much discretion in the hands of government officials and also contains undefined and overbroad provisions—inviting interference with our constitutional freedoms," the group added.

All Democrats and nominal independents are poised to support the bill when it is voted on this week, while Republicans are divided on the proposal.

Cornyn and other GOP members involved in the negotiations, including Sens. Roy Blunt (R-Mo.), Richard Burr (R-N.C.), and Mitt Romney (R-Utah), voted to advance the legislation to the final vote, and are expected to support the bill during the final vote.

Others are on the fence, including Sen. Rick Scott (R-Fla.), who voted no in the procedural vote.

"We just got the text. I want to review it, I think details matter," Scott told reporters at a breakfast in Washington on Wednesday.

"I am not interested in taking away somebody's Second Amendment rights. I do believe in state's rights. I believe states ought to be where most things happen because up here, as you know, once something passes it is very difficult to change it. At the state level, it's much easier to change things, and so I think we have to be very cautious about doing things nationally," Scott added. When he was governor of Florida Scott signed a gun control bill after the mass shooting in Parkland.

Sen. Josh Hawley (R-Mo.), another no vote, said on Twitter that the legislation "ignores the national crime wave & chips away instead at the fundamental rights of law abiding citizens."

Senate Minority Leader Mitch McConnell (R-Ky.), though, joined Cornyn in defending the bill.

The bill will "protect the Second Amendment rights of law-abiding citizens," he said on the Senate floor, while not "touch[ing] the rights of the overwhelming majority of American gun owners who are law-abiding citizens of sound mind."

The Senate on Thursday night passed a bipartisan bill to address gun violence that amounts to the first major federal gun safety legislation in decades. The final vote was 65 to 33 with 15 Republicans joining Democrats in support of the measure.

There is grave concern the legislation's red flag provision will be a Trojan horse for government leaders to disarm law-abiding gun owners.

The bill will next go to the House for a vote before it can be sent to President Joe Biden to be signed into law.

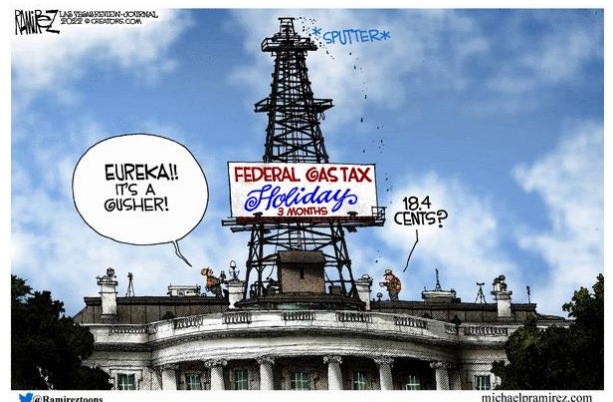

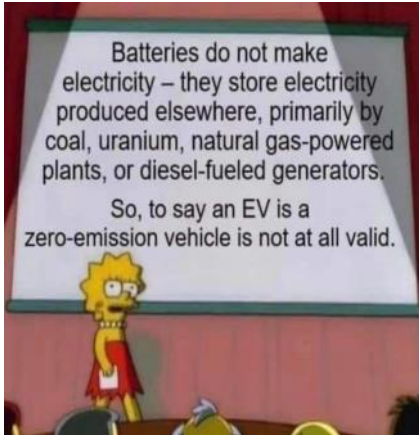

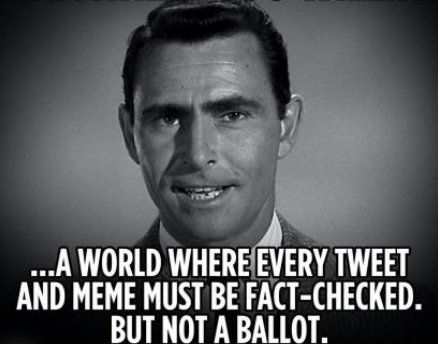

The Struggle Against Tyranny Is Endless

President Joe Biden's ambitions to strip Americans of their constitutional right to bear arms should be seen as part of a wider campaign. Over the past several years, America's oligarchy, comprising political and corporate elites and the national security establishment, has dismantled the constitutional order designed to bind Americans together as one nation under one law.

The ruins of that order are plain to see—from open borders to vaccine mandates, and open election fraud to the prosecution of political opponents. These are evidence not of a coming conflict but the reality that war is already upon us. What replaces that order will be decided by the victors, whose prerogative it is to forcibly disarm the losing side.

And this is the crucial point: Without a comprehensive victory, the oligarchy dares not try taking Americans' guns without risking a catastrophic loss. And so at present, America's warring sides are at a stalemate. It's clear the authors of the Constitution foresaw this likelihood.

Gun opponents say that the historical circumstances in which the Second Amendment was written is long past. They fix on the first clause—"A well regulated Militia being necessary to the security of a free State"—and argue that citizen militias are no longer relevant in an age when the United States is defended by a professional military.

But that's a weak reading. The main clause—"the right of the people to keep and bear Arms, shall not be infringed"—has to be understood in its proper context: Tyranny. The Second Amendment articulates Americans' right not only to defend their lives but also preserve their liberty.

The Second Amendment was drafted shortly after the Founding Fathers had waged war for eight years against a tyrant. The Constitution they wrote, limiting the powers of government, and the Bill of Rights they added enumerating citizens' rights, are evidence they believed the struggle against tyranny is endless. The war against the British crown was over, but it wouldn't be the last time the new country would have to face down despotic rule. Any generation might be called upon to face it down, at home or abroad.

Tyranny is a constant throughout history because it's in the nature of man, and also therefore the political institutions that men make, to seek more power. As author of the Second Amendment James Madison put it, "The truth is that all men having power ought to be mistrusted."

To ensure that no man or institution became too powerful, the Founders created a system of checks and balances—for instance, dividing federal power into three branches of government, executive, judiciary, and legislative. The Second Amendment is best understood as part of that righteous design deterring the rise of tyrants. Should Americans govern each other unjustly, citizens' God-given right to defend their liberty is enshrined in the supreme law of the land.

In the past six years, Americans have learned that the Founders' concerns weren't theoretical, or ideological souvenirs of a time long past. Tyranny is real. The assault on our rights has caused real casualties. The oligarchy has bled Americans while laying siege to the Bill of Rights.

The First Amendment enshrines the right to free speech, including religion, and freedom of assembly. And yet Jan. 6, 2021, defendants were charged with trespassing even when law enforcement invited them into the Capitol building.

Jan. 6 defendants have been forced to renounce their political views. Biden prosecutors have used political speech (Trump banners, anti-Biden "memes," and so on) as evidence to obtain convictions of Jan. 6 defendants. Courts have conditioned the release of some Jan. 6 defendants on whether they accept Biden as president.

Social media platforms, in partnership with U.S. intelligence agencies, censored media reporting on Hunter Biden's laptop. The same platforms and government agencies censored and deplatformed accounts promoting viewpoints on COVID-19 and COVID-19 vaccines not sanctioned by the oligarchy. Anti-lockdown and anti-vaccine protests were criminalized under the pretext of COVID-19 guidelines, which were also used to shut down houses of worship.

In violation of the Second Amendment, the firearms of Jan. 6 defendants charged with nonviolent offenses have been confiscated.

Although the Fourth Amendment expresses the right of citizens "to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures," the FBI spied on the 2016 Donald Trump presidential campaign and then the Trump White House. Biden tasked the FBI to spy on parents objecting to public schools' campaigns to groom and radicalize their children. And the National Security Agency allegedly spied on opposition journalist Tucker Carlson.

While the Sixth Amendment guarantees that "in all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial," Biden's Justice Department has repeatedly delayed the trials of Jan. 6 defendants to gather more evidence while still holding the accused in prison.

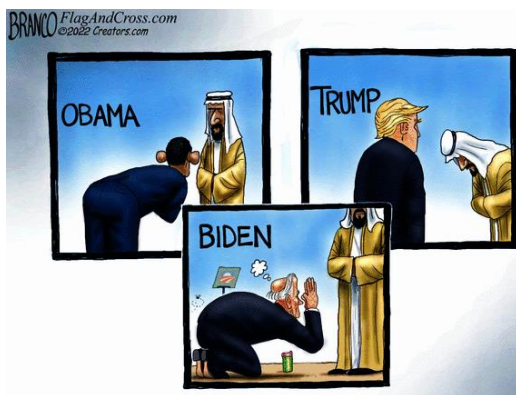
The Eighth Amendment provides that "excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted," but Biden prosecutors have denied bail to Jan. 6 defendants charged with nonviolent offenses. Further, Jan. 6 defendants have allegedly been beaten by prison guards and denied medical care.

From Russiagate through COVID-19 lockdowns to Jan. 6 prosecutions, the oligarchy has used its serial operations against Americans and their chosen leaders as experiments to acclimate a free people to bitter subservience. And that's why the Second Amendment is Americans' most essential right: Without it, every other right belonging to a free people is vulnerable to the intolerable whim of tyranny.

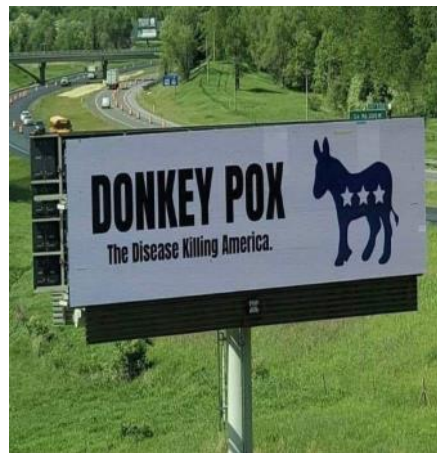

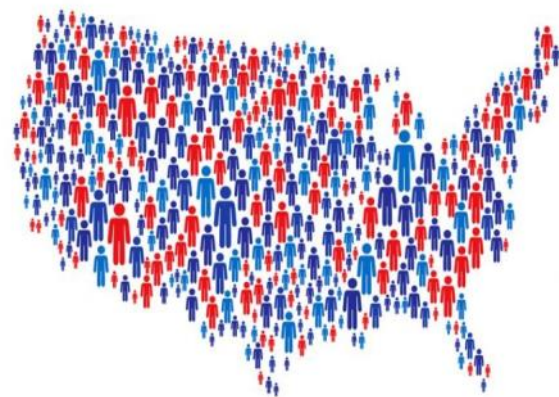

The Common Denominator of Violence in America

The result of fatherlessness becomes even more tragically evident when the data connecting that absence to violence is irrefutable

“The foundation of national morality must be laid in private families. ... In vain are schools, academies, and universities instituted, if loose principles and licentious habits are impressed upon children in their earliest years.” —John Adams (1778)

Rhetorical question: “Why is our culture suddenly producing so many young men who want to murder innocent people? Could things like fatherlessness, the breakdown of families, isolation from civil society, or the glorification of violence be contributing factors?” —Sen. Mike Lee (R-UT)

In advance of Father’s Day each year, I am reminded, first and foremost, of the role I’m called to be by God the Father — a father to my children. But when I think about “fatherhood,” the word invokes my relationship with the person who indelibly imprinted my own life as a father. My “Old Man,” as I affectionately called him (and as my sons call me today), was the “founding father” in our home. My father was always a devoted husband to my mom, and he was always there for my siblings and me. He was a real man, a man’s man in every sense of the word, and I thank God for his influence in my life.

My father had flaws, as do I. In fact, I may have perfected some of his flaws. But these he always endeavored to make right, as do I. I’ve said it many times: It is my objective to avoid repeating generational mistakes, but inevitably that means I will make “new and improved” mistakes.

But my father was always there — loving, providing, leading, and disciplining.

Unfortunately today, intact families are becoming the exception rather than the long standard rule.

Looking at the data of the past decade, our Thomas Gallatin noted last year, “In 2014, data showed that over 40% of babies were born out of wedlock, with that number jumping to an upsetting 70% of black babies.” He added, “Furthermore, for women under the age of 30 bearing children, 65.7% of babies were born out of wedlock.” And children growing up in fractured homes are more likely to repeat the same destructive patterns.

Family researcher Tim Goeglin notes: “When politicians, activists, and social commentators talk about inequality, they often leave out the critical role married parents play in keeping children above the poverty line. There is evidence that the breakdown of the nuclear family in American society is, in fact, the primary reason why the gulf between the ‘haves’ and ‘have-nots’ has widened over the past fifty years.”

Our culture analyst Willie Richardson quotes actor and family advocate Denzel Washington: “If a father is not in the home, the boy will find one in the streets.” Willie, who has spent years working with troubled juveniles, has documented the consequences of fatherless homes. According to the latest data on the importance of fathers:

- 90% of all homeless and runaways come from fatherless homes
- 85% of all fatherless children exhibit behavioral disorders
- 85% of youth in prison come from fatherless homes
- 75% of adolescents being treated for drug abuse are from fatherless homes
- 75% of adolescent patients in substance abuse centers don’t have involved dads
- 75% of rapists motivated by misplaced anger don’t have a dad while growing up
- 71% of all high school dropouts don’t have a dad
- 70% of juveniles in state-regulated institutions come from fatherless homes
- 63% of youth who commit suicide do not have a father in the home
- 57% of the fatherless homes are black households, 31% are Hispanic, and 20% are white.

He concludes: “Working with juveniles in detention over the years has confirmed what I knew statistically, that dads are critical to the well-being of the next generation. Without exception, 99% of black juveniles I work with have no involved fathers. Fathers provoke their children to wrath and discouragement when they exit stage right and leave them behind.”

Moreover, in light of all the political lip service from Joe Biden and his ilk in recent weeks devoted, ostensibly, to stopping violence, the connection between the surge in violence, which they call a “gun problem,” is irrefutably linked, at its core, to the absence of fathers in families. And the absence of fathers is irrefutably linked to disastrous social policies and failed government programs supported primarily by suburban white leftists, which are responsible for keeping generations of poor, mostly black Americans ensnared and enslaved on urban poverty plantations.

The Democrat Party has both seeded and institutionalized poverty over the last half-century. Democrats are, simultaneously, the historical author and political beneficiary of keeping poor people in bondage to the welfare state — the most enduring racial exploitation architecture in America.

As Thomas Sowell observed: “Many successful political careers have been built on giving blacks ‘favors’ that look good on the surface but do lasting damage in the long run. One of these ‘favors’ was the welfare state. A vastly expanded welfare state in the 1960s destroyed the black family, which had survived centuries of slavery and generations of racial oppression.”



There was a time not too long ago when a *Democrat* president, Barack Obama, acknowledged the importance of fathers: “Of all the rocks upon which we build our lives ... family is the most important. And we are called to recognize and honor how critical every father is to that foundation. They are teachers and coaches. They are mentors and role models. They are examples of success and the men who constantly push us toward it. ... But if we are honest with ourselves, we’ll admit that what too many fathers are is missing — missing from too many lives and too many homes. They have abandoned their responsibilities, acting like boys instead of men. And the foundations of our families are weaker because of it. You and I know how true this is

in the African-American community. We know that more than half of all black children live in single-parent households, a number that has doubled — doubled — since we were children. We know the statistics — that children who grow up without a father are five times more likely to live in poverty and commit crime; nine times more likely to drop out of schools and 20 times more likely to end up in prison. They are more likely to have behavioral problems, or run away from home or become teenage parents themselves. And the foundations of our community are weaker because of it.”

Obama stated further, “Yes, we need more cops on the street.” But he insisted, “We also need families to raise our children.” He concluded: “We need fathers to realize that responsibility does not end at conception. We need them to realize that what makes you a man is not the ability to have a child — it’s the courage to raise one.”

The understanding that intact families are the foundation of society is time honored. In the words of Marcus Tullius Cicero (circa 50 BC): “The first principle of society consists in the marriage tie, the next in children, the next in a family within one roof, where everything is in common. This society gives rise to the city, and is, as it were, the nursery of the commonwealth.”

Obama’s affirmation of fatherhood and family starkly contrasts the progressive policy outcomes sought by his feckless successor, Biden, and his leftist cadres.

Today, leftists are accelerating their attack on families because they know the most effective method to erode Individual Liberty, the first pillar of Liberty, is to undermine the integrity of faith and family.

Consequently, Democrats and their failed socialist policies pose the greatest domestic threat to American Liberty. The implications are devastating for black families.

Typical of their deluded mindset is this from a Rutgers University radical black feminist, Brittney Cooper: “We don’t need traditional nuclear families for Black thriving. As one raised by my mother, grandmother, and aunts, I can attest.”

Cooper, like other adherents of “Critical Race Theory” who seek to undermine families, especially the notion of the nuclear black family, is in deep denial related to her own fatherlessness.

In response, culture analyst Delano Squires declared: “I don’t know why they are so committed to going against the natural Family unit, men and women raising their biological children, which is the bedrock of any society. People like Brittany Cooper dismiss the importance of fathers, particularly the black fathers. They mockingly refer to them as ‘the Magical black daddy myth.’ They promote the idea of individual reparations accounts for Black people that white people will pay into. And that gets at the heart of this problem. The left thinks that the biggest issues facing the black community are racism and wealth inequality. And that is why their preferred solutions are bigger government and better white people. Children need their fathers, they need strong families, and the bigger and stronger the family grows, the less need they have for government and their individual daily lives.”

So, what does the data on fatherless homes tell us about who is committing the vast majority of violent crime in America?

Sociologist Brad Wilcox at the University of Virginia affirms: “Sen. Mike Lee is right to wonder if fatherlessness and family breakdown are factors in the tidal wave of violence that has engulfed America since 2020. We know that young men who are raised without the benefit of good fathers are more likely to engage in violent behavior.”

Mary Eberstadt, one of our nation’s foremost culture analysts, notes in her study “Critical Father Theory: “America’s crime problem is a father problem. This is one of our country’s deepest and most denied family secrets. Everybody knows it, and everybody has known it for a very long time.”

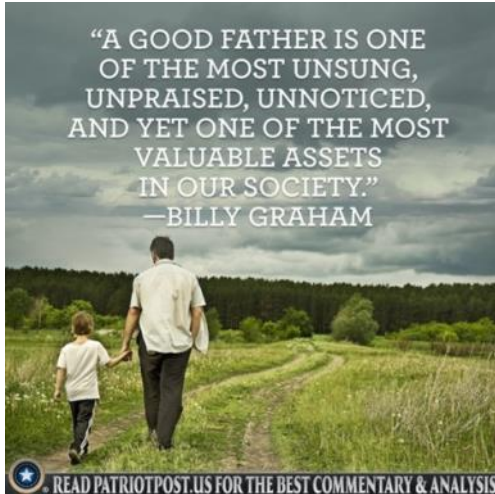
This bears repeating and remembering: “America’s crime problem *is* a father problem.”

Lynne Marie Kohm, professor of family law at Regent University School of Law, notes that there are five family factors common to those who commit violent acts: “very little parental involvement; some kind of stress on the child; a whole lot of time alone; loss of a sense of truth; and an incredible lack of remorse.”

Our friend Tony Perkins at the Family Research Council had this to say about the next time some young sociopath is involved in a mass assault: After asking, “Where did he get a gun?” we need to be asking, “Where did he lose a father figure?”

When it comes to the propensity for sociopathic violence, the most significant red flag is missing fathers. The lack of fathers in families is irrefutably connected to criminal violence.

Today, 57.6% of black children, 31.2% of Hispanic children, and 20.7% of white children are living in homes without their biological fathers.

And the consequence of the epidemic of fatherlessness to black children?

Black people commit 90% of interracial felonies — black on white, Hispanic, or Asian — despite representing just 13% of our population, and despite the age group of the assailant profile representing just 3% of the population. That would include the commission of 21% of hate crimes, as defined by the Department of Justice. Further, 88% of the suspects who murdered black people are also black. Almost half of the 21,000 people murdered last year were black, and almost all of them were killed by other black people. Those grim statistics describe the real epidemic of violence.

But there is a glimmer of light on the horizon. In a recent report from the Institute for Family Studies, researcher Nicholas Zill writes, “A funny thing happened on the way to extinction: although not out of intensive care, the supposed corpse of the two-parent family seems to be breathing new life.”

He observed that recent data indicates the percentage of children living in two-parent homes has risen to 70%, while the percentage of children living in single-parent homes dropped from 28% to 25%. Within the black community, the number of high school seniors living in a home with their biological fathers rose from 24% to 30%. That’s still a very low number, but it indicates movement in the right direction.

However, according to the latest U.S. Census data, 18.3 million children, one in four, live without a biological, step-, or adoptive father in the home.

While Father’s Day should be a day of celebration, it urgently needs to be a call to action. An almost universal common denominator for all the manifestations of social entropy afflicting our nation today is homes without fathers.

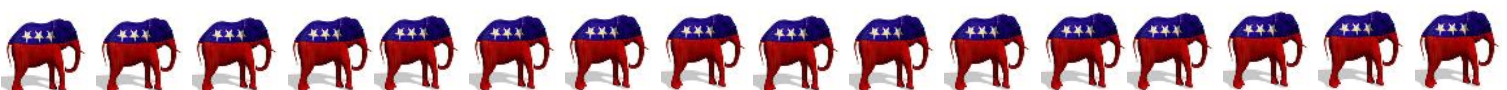
Finally, I’ll leave you with this observation from Lieutenant Governor Winsome Sears of Virginia, a Republican woman who is also black, which is to say an imminent threat to the Demo status quo: “America is in a battle for her children. We weep for the breakdown of the family. We weep for fatherless homes. We weep for the lack of respect for fellow men. We weep over the countless Black men murdering each other. We weep at the onslaught against the Liberty of thought and expression. Indeed we have left goodness, gentleness, and kindness behind, only to be left loathing, crudeness, greed, and sloth.”

Political Action Hours

Our Grandparent organization the National Federation of Republican Women has change the guidelines for what counts as political action hours. The biggest change is we can now count our time spent at our general meetings. The following are the new guidelines.

1. All hours count for activities that are political in nature or support the Republican philosophy. This includes in person and conference or web-based events.
2. Paid hours count if not your primary income. Hours as Election Judge, Clerk Poll watcher, door knocking, phone bank calling and other activities.
3. Hours for elected officials who receive a stipend salary can be counted. Such as Texas State Senators and Representatives, some city council and school board members. Don't forget to count the hours of time they spend out and about the community.
4. Hours for your club meetings, general monthly meetings, board, committee meetings including travel time.
5. Work done for campaigns, including all work for mailings, preparing signs, telephoning, door knocking, poll greeting etc. Work can be performed at any location, home, campaign headquarters, GOP offices, polling locations. Include any travel time.
6. Hours spent at a special event, including all organizing, planning and cleanup. Even events you pay for or are compensated for.
7. All hours at Texas Federation board meetings, events, conventions, training, includes event preparation and travel time.
8. Any hours spent as a precinct chair or assisting your precinct chair.
9. Travel and time spent at Republican Party events, including County Executive meetings, SREC meetings, Precinct conventions, County/SD Conventions, State convention, National Convention.
10. Party Committee work, local or state. Includes any committee meetings, and preparation.
11. Volunteering at TFRW headquarters or local GOP headquarters
12. Committee work performed for appointments made at the local, county or state level. Includes travel time, preparation and associated activities.
13. Political candidates may count all campaign hours.
14. Work on local "non" partisan elections counts, if work is done for known Republican candidates, this includes city and school board elections.
15. SREC work, including time spent creating reports, committee work, quarterly meetings, updating local CEC and clubs.
16. Voter registration work, include time and travel to become certified, and drop off forms. Set up and work on Voter registration drive booth/events, include clean up.
17. Time spent voting.

Tracking of Political Calls

You will track your the number of political calls separately from your hours. Note: the time spent making calls counts under your political action hours

1. Calls of a political nature or for club activities
2. Calls made to elected officials
3. Calls made for voter registration, GOTV
4. Calls made for campaigns
5. Calls to remind members of club meetings/events/membership
6. Calls in support or opposition to legislation
