## President's Byline



What a difference a year makes. Last November the US was energy independent, gas prices were low, GDP grew by 33.1% in the third quarter, the supply chain was working, and inflation was only up 1.2%. Today we are energy dependant, gas prices are high, GDP only grew 2% in the 3<sup>rd</sup> quarter, we are having major supply chain problems, and inflation is up 6.2% (a number we have not seen since 1990). The economic differences between November 2020 and November 2021 is striking and is totally President Biden's fault. How can one person cause all this economic chaos? By putting policies into effect that directly cause inflation.

President Biden's energy policy has reduced the supply, and potential supply, of oil in the US. This has once again made us dependent on oil from nations who are controlled by OPEC (Organization of the Petroleum Exporting Countries). Since we have to once again buy oil from nations that are a part of OPEC, that reduces the global supply which raises the price.

Biden's COVID policies have also caused inflation. It is generally caused by too much money chasing too few goods. Another way to look at it is too much demand but not enough supply. This causes prices to go up.

This brings us to our supply chain problems. We have goods that are not getting from the manufacturer to the store shelves. Whether it is goods sitting on ships off the coast of CA that can't dock, or goods waiting to be off loaded into a warehouse, the cause of the jam in the chain is simply too few workers. That is caused by the federal government paying people to stay home, something it started doing after the lock downs began in order to slow the spread of COVID. Even though the nation has opened, the Biden Administration is still paying people to stay home.

Another reason for the worker shortage, is Biden's and employer's COVID shot mandate. People are refusing to get the shot and getting laid off.

Lastly, inflation is also caused by government printing too much money. When government prints too much money it reduces its value, and our government is now printing money to give to people. It is spending so much money that other nations are no longer loaning us money. This has not stopped politicians from spending, though, as amazing as that sounds. As such, our Federal Reserve is now left to loan money to the government.



## **Office of the Texas Governor | Greg Abbott**



### **Governor Abbott Approves Funding To Launch Election Audit Division Within Texas Secretary Of State's Office**

Governor Greg Abbott today approved a Legislative Budget Board proposal transferring the funding needed for the Texas Secretary of State's office to establish a new Election Audit Division. This division will be conducting comprehensive forensic audits in the State of Texas. Currently, the Texas Secretary of State is conducting the largest forensic audit in the country. The Governor requested these funds on Thursday. The Lt. Governor and Speaker issued a proposal for the transfer this morning and the Governor approved it.

"Ensuring the integrity of our elections is critical to our democracy, and the Texas Secretary of State's office deserves the resources and support needed to thoroughly complete this ongoing task," said Governor Abbott. "The people of Texas must have trust and confidence in the election process, as well as the outcomes of our elections, which is why the state of Texas will transfer funding needed so that the Texas Secretary of State can create a division dedicated entirely to this important issue."

### **Governor Abbott Urges President Biden To Protect American Assets And Secure Southern Border In Talks With Mexico**

Governor Greg Abbott today sent a [letter](#) urging President Joe Biden to begin an aggressive dialogue during his upcoming meeting with Mexican President Andrés Manuel López Obrador regarding border security and recent operational threats against American energy companies by the Mexican government. President Biden and President López Obrador are set to meet at the White House on Thursday, November 18.

"As a result of the inaction by your administration and the Mexican government, I launched Operation Lone Star in early March to help secure the border and combat the smuggling of people and drugs in Texas," reads the letter. "I urge you to engage the Mexican government about ways to prevent the smuggling of individuals, drugs, and the continued flow of illegal immigrants into Texas. Additionally, I urge you to take action to protect American assets from seizure by the Mexican government, potentially in violation of international trade laws. Accordingly, I ask that your administration immediately engage in a dialogue with Mexican officials to discuss the immediate withdrawal of the Mexican military from U.S. owned business interests and convey that no further actions to undermine energy development, production or transmission activities will continue."

The Wall Street Journal [recently reported](#) that the Mexican National Guard was deployed to shut down fuel storage assets owned by Texas-based Monterra Energy. Other American companies face similar operational threats, remain closed, and are under the supervision of the militarized police force despite their continued efforts to work with Mexican regulators.

### **Governor Abbott Challenges OSHA's COVID-19 Vaccine Mandate**

Governor Greg Abbott today filed a petition in the U.S. Court of Appeals for the Fifth Circuit challenging the COVID-19 vaccine mandate imposed by the Occupational Safety and Health Administration (OSHA). In the petition, the Governor urges the court to vacate OSHA's unlawful mandate and confirm that his Executive Order GA-40 is not preempted.

"This Court should vacate OSHA's Mandate, which 'runs afoul of the statute from which it draws its power and likely, violates the constitutional structure that safeguards our collective liberty,'" reads the petition. "OSHA is trying to deliver on President Biden's empty threat that 'if these governors won't help us beat the pandemic, I'll use my power as President to get them out of the way.' Governor Abbott's Executive Order GA-40 need not yield to President Biden's unconstitutional power grab."

### **Governor Abbott Touts Limited Government, Individual Liberty, Free Enterprise At Goodman Institute Gala In Dallas**

### LEGISLATIVE REPORT - November 2021



**Congressional Veteran Commendation Ceremony:** Congressman Taylor honored fifteen deserving veterans at the 2021 Congressional Veteran Commendation (CVC) Ceremony on Saturday, October 30th in Plano. #### **Congressman Taylor Meets with Border Patrol and DPS in Rio Grande Valley**

On October 11, 2021, Representative Taylor met with United States Customs and Border Protection (CBP) agents to tour a migrant processing facility in Donna and a temporary outdoor processing site in McAllen.

Representative Taylor also met with the Texas Department of Public Safety (DPS) for a boat tour of drug and human smuggling routes. CBP officials have stated 1.5 million people illegally crossed along the southwest border in FY21, which is three times as many in FY20.

#### **Congressman Taylor Cosponsors Legislation Prohibiting IRS from Surveilling Bank Accounts**

On October 15, 2021, Representative Taylor cosponsored H.R. 5586, the *Prohibiting IRS Financial Surveillance Act*. Specifically, the bill would prevent any new requirements on banks to disclose information on individuals' private bank account deposits or withdrawal activity to the IRS.

In order to pay for the \$3.5 trillion budget resolution currently being negotiated in Washington, the Biden Administration has proposed forcing financial institutions to report transactions for accounts over \$600 to the IRS every year.

#### **Congressman Taylor Cosponsors Legislation Addressing NPRC Veteran Backlog**

On October 26, 2021, Representative Taylor cosponsored, H.R. 3710, the *RECORDS Act of 2021*, legislation that directs the National Personnel Records Center (NPRC) to fully re-open and issue a report to Congress on efforts to eliminate the backlog of benefits for veterans. NPRC is responsible for processing veterans' service records necessary for veterans to access benefits.

In November 2020, Representative Taylor lead a letter with 233 members of Congress urging the NPRC to implement new policies so that they may resume processing military personnel, health, and medical records requests and address the growing backlog of requests due to the closure of the facility amidst the COVID-19 pandemic. Unfortunately, the NPRC has not fully reopened and maintains a growing backlog.

#### **Congressman Taylor Joins Letter Calling to Reopen Social Security Offices**

On October 12, 2021 Representative Taylor joined colleagues in sending a letter to the Social Security Administration and the American Federation of Government Employees (AFGE) urging them to work together to immediately develop a plan to reopen in-person Social Security services in more than 1,500 locations around the nation.

Most Social Security field offices have been closed for in-person services due to the pandemic. The lack of in-person appointments has made it difficult for individuals and seniors to apply for and receive proper benefits, appeal errors, and request new Social Security cards.

## A December Tradition Called Kwanzaa.

### What is it? And Why Was It Created in 1966?



Happy Holiday Season Plano Republican Women and Friends. There are many holidays being celebrated during the months of November and December, and so much time we get to spend with family. Some of the times may be stressful, and some of the times may be full of excitement. Or maybe it becomes a blast after we bring out the spiked cider. Regardless of your Holiday festivities, we have much to celebrate during these months! This article is not going to focus on Christmas or Hanukkah tradition or history, we are going to focus on Kwanzaa. Which I would guarantee you have heard of before but are not aware of the history.

**First let's ask the question, what religion is Kwanzaa?** It is not considered a religious holiday. Some consider it an alternative to Christmas; however, it does not represent the birth of Christ. Kwanzaa is more of a cultural holiday that represents a historical moment.

**How long has the tradition of Kwanzaa been around?** Kwanzaa began in 1966. (The Watts Riots were a large series of riots that lasted for days in Los Angeles. These riots were the result of two stepbrothers who were pulled over by a police officer, the driver of the car failed a sobriety test. This man was afraid to go to jail, so he started to resist arrest and fought with the police officer, and then his brother joined in the fight against the police officer. The drivers of the car who were breaking the law were black and the police officer was white, which caused the riots based on 'social justice.') Maulana Karenga became a college professor and named his holiday from the Swahili phrase kwanza, 'first fruits'. He admitted adding a second 'a' because of seven children who each wanted to represent a letter of his created holiday, so he called Kwanzaa.

**When is Kwanzaa celebrated?** Kwanzaa is a week-long celebration that will begin on December 26, 2021 and will end on January 1, 2022. Those who honor Kwanzaa light a candle to represent each day, and the candle holder is called a kinara.

As we all gather around the Christmas Tree, Menorah, or kinara this holiday season, may you enjoy the comfort and tradition that your family holds near and dear. As we sing our songs and celebrate with family, may your holiday season be full of joy!

# Constitutional Minute Series

## *Why the Ninth Amendment is my Favorite*

*The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people. - Amendment IX*

In the beginning, there was the *Ninth Amendment* and the Ninth Amendment was the beginning of these United States. It's the genesis of America.

If we start the story at the beginning, we understand that all the rights in the universe belong to the people, as Constitutional scholar *KrisAnne Hall* likes to say. And these rights came from our *Creator*.

From that, the people created government and gave it certain powers to guarantee our rights. It's important to remember that only the people have rights because rights come from God rather than from people.

That's why government possesses no rights, but only powers delegated by the people. This is an important distinction because men can't rightfully take away what our Creator has given us. But people can properly take away any power it has delegated to the government.

On the flip side, men can't grant each other rights because we're not the Lord. And government can't grant each other more power because it's not the people. That which is created is not superior to its creator.

This line of reasoning is known as "Rules of Construction" in legal arguments. "They tell us how to 'construe' the powers delegated to the federal government," explains *Michael Maharrey*, communications director with the *Tenth Amendment Center*.

That's what makes the Ninth and *Tenth Amendments* in the *Bill of Rights* different than the first eight, which list and guarantee individual rights. Instead, they are statements of first principles.

KrisAnne Hall calls the Ninth Amendment "the most important clause in the entire *Constitution*" because it's the foundation upon which all the rest stand.

It's also important to understand what the Constitution is, and what it does. The Constitution is a compact among the States that primarily does three things: (1) It sets up the structure of our federal government; (2) It limits the power of our federal government; and (3) It guarantees our rights against government encroachment.

The States (representing the people) strengthened our sovereignty by creating the federal government to essentially be an ambassador to other nations, a referee among the States, and an armed guard for national defense.

All this emphasis on personal liberty makes these United States unique in the history of nations.

America was founded on ideas that put the people above the government. The first is a theological maxim that we are all born free and in God's image. Inherent in our humanity is Liberty, and it came from our Creator. Second, is the political application of a Constitutional Republic that puts the Rule of Law above the Law of Rulers.



The Ninth Amendment is that rock-solid foundation we can stand upon to remind politicians that all rights belong to the people. And that it's government's job to protect those rights.

After all, we were here first. And then the States. And then the federal government. And the rules of construction dictate who's the boss and who's the servant.

So when any government servant tells us to move from that rock of Liberty, it's our job to plant our feet firmly where they belong and say, "No - YOU move."

## Texas Hospital Suspends Doctor's Privileges After She Voices Concerns Over Vaccine Mandates

A Texas hospital announced that it has suspended the privileges of a doctor who posted concerns on social media about COVID-19 vaccine mandates and suggested that ivermectin may be able to treat the virus.

Dr. Mary Bowden, an ear, nose, and throat doctor at Houston Methodist Hospital, posted what was called “dangerous misinformation” that’s “not based in science” about the virus, the hospital announced on Twitter. The firm didn’t elaborate on the so-called misinformation and didn’t explain how her social media claims aren’t scientifically factual.

“Dr. Mary Bowden, who recently joined the medical staff at Houston Methodist Hospital, is using her social media accounts to express her personal and political opinions about the COVID-19 vaccine and treatments,” Houston Methodist, which drew national headlines for becoming one of the first hospital systems in the United States to mandate vaccines for all its employees earlier in 2021, wrote on Twitter.

Patty Muck, a spokesperson for the hospital, confirmed to media outlets over the weekend that Bowden’s privileges were suspended.

“The physician’s privileges at Houston Methodist have been suspended,” Muck wrote in an email to the Washington Post.

When contacted by The Epoch Times, a separate spokesperson for the hospital sent a statement that echoed several of its Twitter posts. The spokesperson didn’t elaborate on the suspension.

Last week, Bowden wrote on her Twitter account that “vaccine mandates are wrong” and included a screenshot of a message that apparently came from an individual who told her that “what the government is doing to its citizens in the United States is incomprehensible.” She also used her account to suggest that the anti-parasitic drug ivermectin may be able to treat COVID-19 symptoms.

In recent weeks, podcaster Joe Rogan and Green Bay Packers quarterback Aaron Rodgers both publicly confirmed that they took ivermectin after they were each diagnosed with COVID-19. The Food and Drug Administration (FDA) and the Centers for Disease Control and Prevention (CDC) haven’t recommended the drug to be used for treating the virus.

“Ivermectin might not be as deadly as everyone said it was. Speak up!” Bowden said on Nov. 10.

Bowden’s attorney, Steve Mitby, told local media outlets that the doctor has treated more than 2,000 COVID-19 patients and said she isn’t against vaccines.

“Like many Americans, Dr. Bowden believes that people should have a choice and believes that all people, regardless of vaccine status, should have access to the same high-quality health care,” Mitby said.


Speaking to local media outlet Click2Houston, Bowden, who also runs her own private practice, BreatheMD, said she had a “great relationship” with Houston Methodist.

But the “issues with vaccines and ivermectin really go against patient autonomy and their right to choose their treatment,” she said.


“All of my comments are backed by clinical experience,” Bowden told the Houston Chronicle. “I have been open seven days a week since the pandemic began, performing over 80,000 COVID tests and treating over 2,000 patients with COVID.”

Mitby’s law firm didn’t respond to a request for comment by press time.

# Catherine Gibb's Father Honored by Congressman Taylor



## Ceremony Honoring First Lieutenant William Jennings Bryan Duncan

*Congressman Taylor presents Catherine Gibb with an original Prisoner of War medal for her father 1st Lt. Duncan*



On Wednesday, November 10, 2021 at 11:30 A.M. we had the honor of celebrating the posthumous award of the Prisoner of War Medal to the family of First Lieutenant W.J. Bryan Duncan. The celebration was held at the Flags of Honor Event where over 1,000 US flags were displayed, each with the history of one of our veterans.

Bryan Duncan joined the United States Army Air Force on September 7, 1940 and served until July 3, 1946. He was promoted from Private eventually to 1<sup>st</sup> Lieutenant and served as the Quarter Master, where he commanded and supervised personnel engaged in transporting ammunition and food supplies by pack animals. He supervised the care, conditioning and feeding of horses and mules in the Unit when he was arrived in Manila on November 1, 1941, having been on the last ship of soldiers to be sent there.




On the morning of April 9, 1942, following three months of intense battle and no hope of reinforcements, approximately 75,000 American troops on the Bataan Peninsula of the Philippines surrendered to the Japanese. 1<sup>st</sup> Lt. Duncan was among those captured and these men were then subjected to the Bataan Death March, a tortuous march of more than 65 miles in tropical temperatures of over 100 degrees, given no food or water, and rarely rested for 7 days. Thousands died and those who didn't were sent to various prisoner of war camps. 1<sup>st</sup> Lt. Duncan was one of many that were sent to Camp Cabanatuan.



Toward the end of the war, the Japanese were exterminating the prisoners in the various camps. It was determined that there would be an attempt to rescue the survivors in Camp Cabanatuan, who were just days away from being murdered by the Japanese. On January 30, 1945, the 500 survivors were rescued by Colonel Henri Mucci, Captain Robert Prince and the 6<sup>th</sup> Ranger Battalion of the U.S. Army. Philippine guerillas were instrumental in this rescue, the most successful POW rescue in history. This rescue inspired the 2005 movie *The Great Raid*.

The Prisoner of War Medal is a military award of the United States Armed Forces which was authorized by Congress and signed into law by President Ronald Reagan on November 8, 1985. Since this medal was not in existence in 1946, this was an original presentation to Catherine and her sister, Liz Duncan on behalf of their father.



## Governor Abbott Appoints Ward to State Commission on Judicial Conduct

# A Victory Against Tyranny

On Nov. 17, the federal Occupational Safety and Health Administration (OSHA), complying with a federal court order, suspended enforcement of its COVID-19 mandate that would have forced about 31 million unvaccinated Americans working for private businesses essentially to choose between getting themselves vaccinated against the virus or jeopardizing their jobs.

The order, issued by the Fifth U.S. Circuit Court of Appeals decision on Nov. 12, was a constitutional victory against using the power of the federal government to dictate people's individual health decisions. But it was also something more: a moral victory against the Biden administration's unrelenting campaign, fully supported by the mainstream media, to punish people for dissenting from the administration's particular medical stance on COVID.

It was, in short, a victory against tyranny. I write this as someone who promptly got vaccinated as soon as the vaccines became widely available and would urge others to do so as well. But there are people who object, whether for religious reasons (there's no specific religious exemption in the OSHA mandate), or because they have already had COVID-19 and are naturally immune, or because they don't want to be experimented on with vaccines hastily rushed to approval. The last category may account for the outsize proportion of blacks resisting vaccination; they have long memories of the Tuskegee syphilis experiments. Many of these people are health workers and first responders who put their lives on the line during the first, highly ravaging months of COVID-19 in early 2020. They deserve respect for their personal decisions.

But the Biden administration's response has been, let's show 'em who's boss. The text of Biden's Sept. 9 [speech](#) announcing his intention to crack down on vax-refusers reads like a despot's edict: "We've been patient, but our patience is wearing thin."

He sounded like the King in The Wizard of Id. Since there's no constitutional or statutory cover for the federal government to order individuals directly to get the shots, he ordered OSHA, whose domain is workplace safety, essentially to manufacture one. On Nov. 4 OSHA duly issued an "emergency" mandate ([pdf](#)) telling all private businesses with more than 100 employees to require their workers either to be vaccinated or to undergo weekly COVID-19 tests, often at their own expense, and to wear masks throughout the workday—or get fired. The masking requirement alone would stigmatize vax-noncompliers as pariahs to be shunned. [Fines for noncompliance](#) could total nearly \$14,000 per incident, including failure to keep vaccination records, with up to 10 times the penalty for "willful" flouting of the mandate. Employers would have two months, until Jan. 4, 2022, to set up vax-or-test protocols.

Two days later, on Nov. 6, the Fifth Circuit, in a lawsuit filed by five states along with companies, individuals, and religious groups, issued a temporary stay on enforcing the mandate. The White House breezily announced that it had no intention of complying with the order.

"If OSHA can tell people to wear a hard hat on the job, to be careful around chemicals, it can put in place these simple measures to keep our workers safe," Biden's chief of staff, Ron Klain, [declared](#).

White House Deputy Press Secretary Karine Jean-Pierre advised employers to go ahead with requiring their employees to get vaccinated or tested regardless of what the court said.

The mainstream media reveled in the administration's defiance. [Vox](#) dubbed the three Fifth-Circuit judges "right-wing" and said the stay was "premature, improper, and appears to be motivated by partisanship." "How about saving lives?" asked [Washington Post](#) columnist Ruth Marcus. Some commentators, such as [The Atlantic](#)'s David Frum, urged the federal government to get even more punitive in its stance against the unvaccinated: Why not bar them from flying or taking trains and buses? (In fact, Sen. Dianne Feinstein (D-Calif.) has introduced [just such a bill](#).) Why not deny them student loans? "Will blue America ever decide it's had enough of being put medically at risk?" Frum asked.

The Fifth's Circuit's Nov. 12 decision, extending the stay until a full trial on the merits, threw a bucket of cold water on this idea that the federal government can do whatever it wants to force its citizens to comply with its favored medical strategies—and punish them for not doing so.

The lead opinion ([pdf](#)), by U.S. Circuit Judge Kurt D. Engelhardt, pointed out that the OSHA mandate obviously had little to do with workplace safety, nor was it a genuine "emergency" measure. It excluded businesses with 99 employees—aren't they as at much risk of contracting COVID-19 from the unvaccinated as their friends who work for businesses with 100 employees? The Biden administration had

simply “pored over the U.S. Code” looking for some statute that might enable it to bypass the Constitution and impose a national vaccine mandate directly, Engelhardt wrote. And it came up with the Occupational Safety and Health Act, enacted in 1970 to deal with slippery factory floors and exposure to toxic chemicals. The OSHA mandate “grossly exceeds OSHA’s statutory authority,” Engelhardt said.


The Constitution makes it clear that the federal government is a government of limited powers, and it’s especially limited in its ability to impose direct obligations upon its citizens. The Fifth Circuit’s ruling made it clear that these limits are real. And fortunately, as the Fifth Circuit also made clear, the federal government is limited in its ability to issue decrees that would destroy the livelihoods of, or make social outcasts of, dissenters from prevailing ideologies, medical or otherwise.

Of course, as might be expected, the Biden White House is still pretending that court rulings don’t mean anything, and that businesses should pretend likewise and forge ahead to meet the Jan. 4 vaccination deadline.

“That was our message after the first stay issued by the Fifth Circuit,” White House Press Secretary Jen Psaki told reporters on Nov. 18, the day after the deadline got suspended. “That remains our message and nothing has changed.”

The most famous words of Franklin Roosevelt, America's longest-serving president, were, "The only thing we have to fear is fear itself."

One wonders if any world leader would or could say that today. We live in the Age of Fear.

All of my life, I thought love and hate were the two most powerful human emotions.

But owing to recent events, I have changed my mind.

I now understand that for most people, *fear* is the strongest emotion.

In fact, I've come to realize that it is possible to get people to do anything if you instill enough fear in them. Specifically, irrational fear.

Fear of COVID-19, for example, is rational. But media and governments induced irrational fears. That's why millions of healthy people stayed indoors for a year or more, why a vast number of people wore masks while walking or sitting alone outdoors, and why so many parents did not allow their young children to play with other children for a year or more, even though the COVID-19 mortality rate among children was considerably less than the flu's mortality rate among children.

All of this was caused by irrational fear. It turns out that fear is not only more powerful than love and hate; in most people it is more powerful than reason. And when it is, it is far more destructive—to the individual and to society—than rational fear.

What is rational fear? When a soldier fears going into battle, that is rational. Soldiers cannot allow fear to control their behavior, but their fear is not irrational. If a mugger points a gun at you, it is rational to feel fear. If you are diagnosed with cancer, it is rational to experience fear.

Rational fear is not necessarily a bad thing. It is irrational fear that does the most harm—to yourself, to others and to all of society.

The Salem witch trials of the 17th century exemplified irrational fear leading to evil: the killing of women who were believed to be witches.

You would think that the Enlightenment of the 18th century, with its focus on reason and science, would have led to a great lessening of irrational fear.

It hasn't.

To cite a number of examples, an unknowable (but not small) number of Americans—usually among the best educated—prohibited their parents from seeing their grandchildren, either because the grandparents or the grandchildren were not vaccinated. They did this despite the fact that the number of young people infected with COVID-19 was close to zero and despite the fact that there were extremely few cases of children infecting adults. Sweden kept its schools open for all students under the age of 16 throughout the pandemic, and studies have since confirmed that the risk to Swedish teachers of infection by students was extremely low. Such is the power of irrational fear.



To take another contemporary example, many people have decided not to have children because they fear that a warming planet represents an "existential threat" to life. Now, it is rational to be concerned about climate change, but it is irrational not to have children because of it. And it gets even more irrational. Their parents often support this decision, despite their deep yearning to be grandparents.

Irrational fear is also a major source of hatred. People hate what they fear. It was Germans' irrational fear of Jews—people who made up under 1 percent of the German population—that led to the unique evil known as the Holocaust.

Given the awful power of fear, what can you do to be less fearful?

The first thing you must do is determine whether your fears are rational or irrational.



# Gay Pariahs, Unvaccinated Pariahs, the Left, and the Truth

Last week in an interview on Newsmax, I said:

“During the AIDS crisis, can you imagine if gay men and intravenous drug users, who were the vast majority of the people with AIDS, had they been pariahs the way the non-vaccinated are? But it would have been inconceivable. And it should have been inconceivable; they should not have been made pariahs. But this (banning those not vaccinated from bars, restaurants, salons, etc.) is kosher, this is OK.” The reason I raised the comparison of gay men and IV drug users as pariahs to the current-day unvaccinated is that I took for granted that those two groups, were, in fact, made pariahs at that time. My whole point was they were not made pariahs *in the same way the unvaccinated are today*. No AIDS-infected people were the subject of government-issued edicts to bar them from private businesses such as restaurants, bars, and hair salons.

Had gay men and IV drug users never been made pariahs in the beginning of the AIDS crisis, there would have been no point in raising them as a point of comparison. To any honest person hearing or reading that statement, it is therefore clear that I did not say gays were not pariahs during the AIDS crisis. I said the opposite: I said that they should *not* have been made pariahs and that it should have been inconceivable to make them pariahs. I compared gays as pariahs then to the unvaccinated as pariahs today. I said they were not pariahs “like the unvaccinated are today.” There’s a reason people use qualifiers.

The Left went into its standard mode of operation—lie, smear, get hysterical, and incite the mob.

Some examples:

MSNBC devoted a segment to what I said. They played the Newsmax video of me—but, tellingly, they played only part of what I said. They dropped, “And it should have been inconceivable; they (gays) should not have been made pariahs.” If you watch the video of me speaking as played on MSNBC, you actually see me mouthing those words, but MSNBC made sure you can’t hear me say them. Dropping those words changes the entire meaning of what I said.

And change the meaning of what I said is precisely what The Independent, Slate, Politifact, the Advocate, Media Matters, The Bulwark writers and every other [left-wing](#) individual and organization that covered this story did.

Gays with AIDS were indeed pariahs, and some awful things were done to and said about them. This was especially true in the first years of the AIDS outbreak, and especially after Dr. Anthony Fauci announced that AIDS may be transmittable through casual household contact (rather than solely by the exchange of body fluids), and most especially after the media hyped the myth that AIDS was as easily transmitted and common among heterosexuals as it was among gay men and intravenous drug users. As a result, many Americans panicked.

Consequently, almost everyone with AIDS—not only gay men—were rendered pariahs. One of the most famous examples was Ryan White, a 10-year-old boy who was not gay (to anyone’s knowledge), who was kicked out of school in 1986 because he had contracted AIDS from a tainted blood transfusion.

Now let’s compare that pariah status to that of the unvaccinated today.

Were there government mandates to fire every gay man with AIDS, as there are today for every company in America with 100-plus employees?

Did government edicts deprive AIDS patients of their incomes and pensions? Were gay policemen, nurses, and firefighters fired?

Was there a ban on gay men (with or without AIDS) entering movie theaters, restaurants, hair salons, etc., unless they could prove they did not have AIDS? Such bans exist at this moment on the unvaccinated.

Was there any talk about banning anyone with AIDS from using all public transportation? Such a ban on the unvaccinated exists in Canada and is being seriously discussed by the Biden administration. Last week, Austria barred unvaccinated people who do not have natural immunity from restaurants, hotels, hair salons and large public events.

Here’s more on the treatment of the unvaccinated:

The former premier of New South Wales, Bob Carr, has called on the Australian government to follow Singapore’s decision to discontinue free COVID-19 treatment for unvaccinated patients. He said it was time unvaccinated Australians should be forced to “pay for your willful stupidity.”

Howard Stern said: "I'm really of mind to say, 'Look, if you didn't get vaccinated and you got Covid, you don't get into a hospital.'"

MSNBC host Mehdi Hasan supports segregating the unvaccinated and denying them access to basic goods and services.

Noam Chomsky said that the unvaccinated should be pushed into isolation. When asked how the unvaccinated would then be able to get food, Chomsky responded, "How can we get food to them? Well, that's actually their problem."

"Noam Chomsky is trending because he wants to get tough on people who choose to stay unvaccinated," Mehdi Hasan said on MSNBC. "Good for him."

Leana Wen, a visiting professor of health policy at George Washington University, Washington Post columnist, and medical analyst for CNN, told Chris Cuomo on CNN:

"We need to start looking at the choice to remain unvaccinated the same as we look at driving while intoxicated. You have the option to not get vaccinated if you want, but then you can't go out in public."

Jimmy Kimmel said this: "Dr. Fauci said that if hospitals get any more overcrowded, they're going to have to make some very tough choices about who gets an ICU bed. That choice doesn't seem so tough to me. Vaccinated person having a heart attack? Yes, come right on in, we'll take care of you. Unvaccinated guy who gobbled horse goo? Rest in peace, wheezy."

My comments were about the government-imposed pariah status of the unvaccinated today; they in no way denied the social pariah status of gays with AIDS in the 1980s. But facts do not matter to the angry and the hate-filled.

Tim Miller, writer-at-large for The Bulwark, said on the MSNBC program that featured my Newsmax interview:

"His (Prager's) revisionist history is a central tenet of right-wing victimhood. They love the victim status ... and to pretend like the suffering of people didn't exist."

Miller simply lied about what I said. I never pretended the suffering of people didn't exist. I compared the pariah status of the unvaccinated today to the pariah status of gays during the AIDS epidemic and said the former is worse. That is demonstrably true: Not one of these commentators cited an example of government or commentators calling for banning AIDS victims from working, from eating out, from getting a haircut or a plane ticket or from receiving medical care.

As noted above, every left-wing outlet that covered the issue lied:

The Independent: "Right-wing radio host claims gay men weren't 'pariahs' during Aids crisis—but unvaccinated are now."

Poynter Institute for Media Studies: "Dennis Prager's claim that it was 'inconceivable' that gay men were seen as 'pariahs' in the 1980s is extraordinarily inaccurate."

Politifact (a so-called fact-checker): "To suggest that gay men and intravenous drug users were not considered pariahs during the AIDS crisis of the 1980s is entirely inaccurate .... We rate the statement Pants on Fire."

The Advocate (perhaps the most long-standing and prominent gay site): Like MSNBC, it dropped the last two sentences when it quoted me.

Tampa Bay Times headline: "The Pants on Fire claim that it was 'inconceivable' gay men were seen as 'pariahs.'"

Another writer at The Bulwark, Jonathan V. Last, asked: "Is Dennis Prager Stupid or Evil?" To support this, he printed the truncated quote of what I said, just like MSNBC and the others.

Why did the Left lie about what I said?

For two reasons.

The first is something I have known and written about since I studied communism in graduate school: Neither liberty nor truth is, or has ever been, a left-wing value. Both are liberal values, and both are conservative values. But neither is a left-wing value.

The second is that on the Left, victim status is everything. Only left-wing approved groups can be deemed victims, and gays are, of course, one of those groups. Whatever the price—including truth—the Left must maintain its monopoly on victimhood.




