## President's Byline



I am writing this after Thanksgiving, and we still don't know whose electors will be voting in the Electoral College. Like most of you I am disgusted by the way this election was handled. The blatant fraud and ignoring of laws is horrifying. I am also shocked by the lack of Constitutional knowledge by the media and of those running for political office.

First, let's talk about the fraud. In many states we had dead people who voted. People who died recently and those who died years ago. That is nothing new, but we also had thousands of people show up to the polls to vote, only to be told they already voted by mail. Some could have been people who were trying to vote twice. Others could have been people who had their votes stolen from them. Then we had people vote in states they were not residents of, and illegal harvesting of ballots.

Next, we had election officials ignore election laws of their states. Some officials illegally threw out poll watchers from observing the count, while others illegally back dated mail in ballots, ignored ID requirements, illegally cured ballots, accepted ballots after the deadline, and ignored signature requirements.

Third, we had courts, Governors, and State Secretary's of States change election laws. Only the legislature of each state has the power to change the election law of its state.

Lastly, we have people in the media and running for office who don't have an understanding of basic Constitutional civics. The media has prematurely called the election for Joe Biden. The former VP is even calling himself the Presidential Elect. However, the Presidential election is not over. In reality the election has not even happened yet.

On November 3<sup>rd</sup> we went to the polls to vote for Presidential and Vice Presidential electors. A majority of Texas voters choose President Trump and VP Pence electors. On December 14<sup>th</sup> those electors will go down to Austin and cast a vote for President Trump and VP Pence. 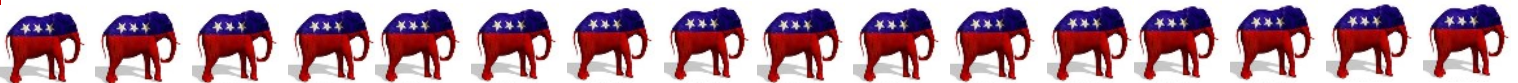

 But their legacy lives as time marches on

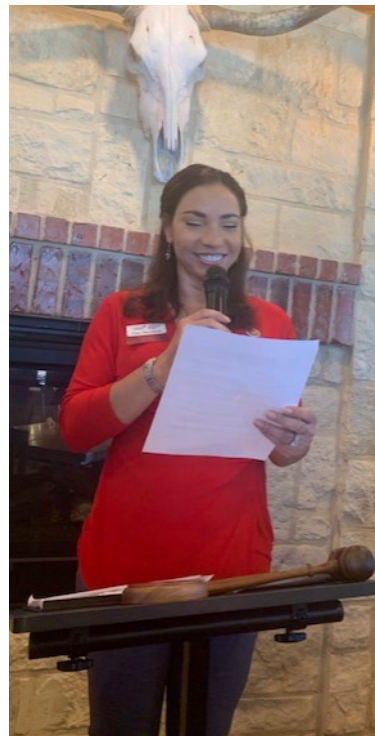
White crosses in rows

# The Founders Outsmarted the Presidential Election Fraudsters

## Who chooses the President of the United States?

This question is by no means rhetorical. For example, the mass disinformation media has chosen Joe Biden as the winner of the 2020 election. Many people liked this news, but I must disappoint them – the television broadcasters have, according to the U.S. Constitution, nothing to do with who will live in the White House for the next four years.

Maybe the Supreme Court chooses the President? No, the Constitution does not provide for this. Could it be that the citizens of America choose their President? Following the U.S. Constitution, no. So, who then chooses the President?

Before answering this question, let us note that, contrary to popular misconception, the President of the United States is not a representative of the American people. State legislators and governors are representatives of the people, and at the federal level so are the members of the House of Representatives of the United States Congress. (Currently, senators are also representatives of the people, but before the ratification of the 17th Amendment to the Constitution in 1913, they were appointed by state legislators). So, who does the President of America represent?

The President of the United States of America, according to the Constitution, represents state legislators' interests and no one else.

In general, the federal government's structure in America reflects the numerous attempts of the Founding Fathers of the United States to introduce a system of effective state control over the federal government. The fact is that the main difference between our country and all other countries, without exception, is that it was organized "from the bottom up," that is, individual colonies voluntarily united against a common enemy – the British Empire. All other "republics" on the planet were created "from the top down," when the already existing provinces were graciously granted some independence by the already existing central government.

In building the American state, the fundamental principle was state control over the newly created federal power structure. Therefore, from the Founding Fathers' point of view, the federal government in Washington should consist of both representatives of the people (congressmen) and representatives of the state leadership – the federal President and senators. This is how the institution of the Electoral College was invented and implemented. The electors are appointed by the state legislatures, and they are the ones who elect the President of the country.

So why do American citizens need to participate in the presidential elections? Well, strictly speaking, it is not necessary. It is just that there is a long tradition in America – state legislators appoint electors in such a way that these appointments correspond to the mood of the people (in some states, this is even enshrined by law). This is a tradition, but according to the U.S. Constitution, the participation of the people in presidential elections, generally speaking, is not required. According to the Constitution, the people participate in the direct elections of their legislators, which is quite enough.

There is nothing reprehensible in this – after all, the President of America is not the representative of the American people. He is the representative of state legislators. From the point of view of the states, the President (and pre-1913, two senators from each state) are the "overseers" of the federal government. In other words, the President, from the point of view of state legislators, is "our man in Havana" (that is, in Washington), who is responsible for the observance of state rights by the federal government.

Thus, under the Constitution, state legislators have the right to generally ignore the results of the voting of citizens of their state and appoint those who they deem necessary to the Electoral College. Why did the Founding Fathers of the United States give state legislators such unprecedented power? Because most of the Founding Fathers were geniuses with impressive foresight. They did not know precisely when this would happen, but they knew it would eventually happen: the election's published results would have nothing to do with how the citizens voted.

This is exactly what happened in 2020.

Of course, there have been falsifications in the counting of votes in America before. However, in 2020, the Democrats went all-in with a scam, and for the first time in American history, they were close to success. Actually, they simply had no other choice. They knew very well that another Trump term would be enough to crush the American left to its core. (However, even if Trump does not manage to stay in the White House, his departure from politics will be such that the left will not be envied.)

Now, more than a week after the elections, it is already clear what the Trump team is doing. They are working in two directions.

First, they sue in states where there was a clear violation of the electoral law. Violations include the counting of votes that came after polling stations closed, turnout of more than 100%, the use of computer systems that were systematically "wrong," always in favor of Biden, the thousands of Pennsylvania voters born on January 1, 1900 (or even on January 1, 1800), and much more.

For example, election results in some Democrat-controlled states violate fundamental laws of both mathematics and physics. The votes cast for Biden do not comply with the statistical law of distribution of digits ([Benford's Law](#)), while the ballots cast for Trump do adhere to this law. Thousands of mailed ballots were received even before they were officially sent. Thus, the 2020 election showed compelling evidence of the possibility of time travel.

Secondly, the Trump team calls on state legislators to use their constitutional powers to rectify the local executive authority's criminal actions to the point of

completely ignoring the falsified voting results.

These are the expected steps. Any presidential candidate would and should take such measures. Al Gore did the same in 2000, but then the case concerned only the state of Florida. In 2000, the country did not know the name of the winner for 35 days, and in 2020 we should not expect a faster resolution of the issue because now we are talking about at least six "problem" states.

Only now is the reason for the frenzy with which the Democrats attacked the three Trump-nominated Supreme Court justices is becoming clear. The fact is that the Trump-nominated current U.S. Supreme Court justices – Gorsuch, Kavanaugh, and Barrett – were on Bush's legal team that secured the Supreme Court case in favor of Bush in 2000.

But the main difference between the 2020 elections and the 2000 elections is the involvement of the federal government's apparatus in investigating violations. The investigation is carried out by both prosecutors of the Department of Justice and FBI agents.

According to the Constitution, all courts and all other voting problems must be resolved by the first Monday after the second Wednesday of December, which falls on December 14 this year. If on December 14, the Electoral College fails to elect a president, then the Constitution also provides for this scenario. Per the 12th Amendment to the Constitution, in this case, the President and Vice President will be elected by the House of Representatives (however, if for some reason the Vice President cannot be elected by the House of Representatives, then the right of his choice is transferred to the Senate.)

In the House of Representatives, state delegations will be voting, not the individual congress-men themselves. Now in the House of Representatives, the majority of delegations – 26 – belong to Republicans. In the Senate, the Republicans also have an advantage. So, the only reason Trump can lose the election now, a week after the election, is his own admission of defeat. But such a strange decision by Trump is unlikely – this guy is from Queens, and if he gets involved in a fight, he will see it through to the end.

It is also unlikely that Trump does not understand that if the chronic vote-rigging by Democrats is not stopped now, America will end. The Trump team is well aware that such an opportunity to end the creeping socialist revolution may no longer be presented.

As a result, Democrats will likely not recover from this fraud. The disinformation media (which Fox News joined on the election night) will not recover from deliberately covering up this fraud, this attempted coup. If the Democrats went for broke, then Trump could, most likely, also go for broke.

Trump may have already destroyed the Democratic National Committee, but they just do not know it yet.

In military terms, Trump's team conducted careful reconnaissance and intelligence on the enemy for a week. They collected numerous affidavits about the electoral fraud of Democrats, witnesses who confirm their testimony under oath. But on the evening of November 10, the reconnaissance was completed, and massive artillery bombardment began in the form of lawsuits in several key states and the initiation of criminal investigations into violations by the Department of Justice. If this does not help, Trump will bring into the battle the strategic reserves available only to the President of the American state apparatus – for example, in the form of a complete declassification of Obamagate. In any case, our country is by no means at the end; we are at the very beginning of this process.

From a legal perspective, Biden is an impostor, a false president, at least until December 14 of this year. If Biden can declare himself President-elect without any legal basis, then any other American citizen can also declare himself President-elect.

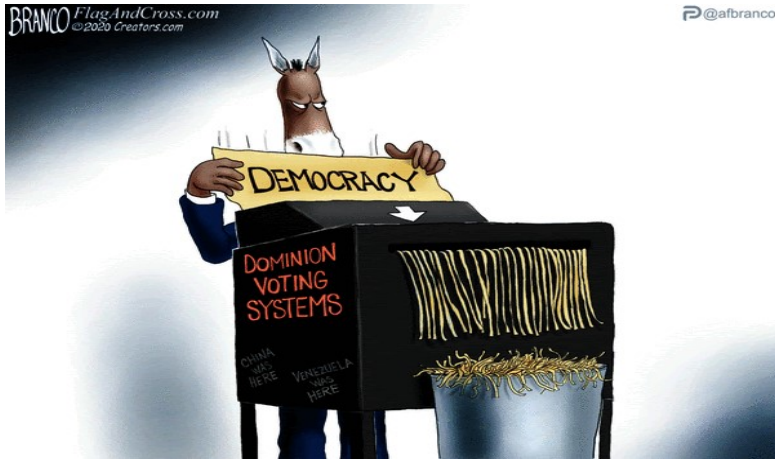

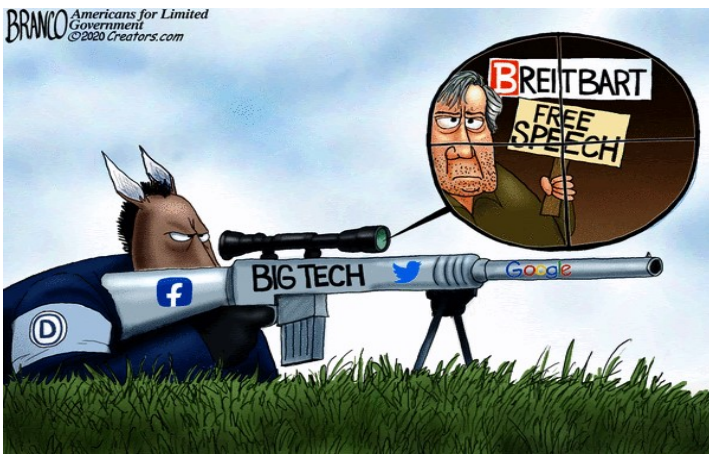

# America Is Drowning in the Lies of the Left

There are conservatives who lie, and there are liberals who lie, but both conservatism and liberalism hold truth to be a supreme value.

This is not true for leftism.

Truth is simply not a left-wing value.

Lying is to the left what breathing is to biological life. That is why the father of modern leftism, Vladimir Lenin, named the Soviet communist newspaper “Pravda,” the Russian word for “truth.” Truth is what a leftist says it is. It is not an objective reality.

The left has always relied on lies to gain and retain power. This is as true today in the United States as it was in the Soviet Union.

Here are examples of lies Americans are told they must hold lest they be removed from social media, shamed, ostracized, and even fired from their jobs.

In no order of importance:

**Men menstruate.** American Civil Liberties Union tweet, Nov. 19, 2019: “Men who get their periods are men. Men who get pregnant and give birth are men.” If this is not a lie, the word has no meaning.

**It is fair when males who identify as females compete in girls’ and women’s sports.** In Connecticut, two biological men who are trans women have combined to win 15 girls state indoor or outdoor championship races since 2017. According to The Wall Street Journal, “19 state athletic conferences ... allow athletes to compete based solely on their expressed gender identity.” No one with a passing acquaintance with truth could say this is fair.

**To be colorblind is to be racist.** This left-wing assertion is the opposite of the basic liberal ideal to end racism: to have everyone colorblind, meaning we are all to view and judge people solely as individuals irrespective of race.

“Colorblind is racist” is not just a lie; it is an Orwellian lie. But it is actually normative on the left. See, for example, “Color-Blindness Is Counter-productive” (The Atlantic, Sept. 13, 2015) or the book “Colorblind Racism” by Meghan Burke, associate professor of sociology at Illinois Wesleyan University.

**The 2016 Trump campaign colluded with Russia to win the election.** This lie has permeated the American media for more than three years. There was never any truth to it. But those on the left—the Democratic Party and the mainstream media—found it a very useful claim, and they are doing so again in the 2020 campaign.

**President Donald Trump said there were “very fine” Nazis.** This is “the Charlottesville lie.” First, the media spread it, and now Joe Biden has run with it, claiming repeatedly that this was the reason he decided to run for president. Of course, what Biden said is a lie; he has wanted to run for president all his life.

At Trump’s press conference on Aug. 15, 2017, right after the Charlottesville march and demonstrations, Trump made it clear he wasn’t referring to the neo-Nazis when he said there were “very fine people on both sides.” He told the press, “I’m not talking about the neo-Nazis and the white nationalists because they should be condemned totally.” He was referring to the two sides at the protest over statues. See the video “The Charlottesville Lie” by former CNN reporter Steve Cortes at PragerU.com.

**Donald Trump is a dictator.** This lie has been told since before Trump was elected. It is repeated by virtually every left-wing commentator and politician. See, for example, “10 Ways Trump Is Becoming a Dictator, Election Edition” by Harvard professor Stephen M. Walt (Foreign Policy, Sept. 8, 2020) or “Donald Trump Wants To Be a Dictator” by Guardian columnist Jonathan Freedland (The Guardian, July 5, 2019). It is a lie.

The fact is no conservative American politician is a likely dictator because one of the fundamental goals of American conservatives is to shrink the power of the government. A dictatorship in America is far more likely to come from the left, which seeks to massively increase government power.

For example, as reported in Politico on Aug. 21, Biden has already pledged, “I would shut it down,” referring to the American economy and Americans’ freedom of movement to combat the COVID-19 virus.

**America is a racist society.** This is the greatest national lie since the medieval blood libel, in which Christians accused Jews of slaughtering Christian children to use their blood to bake matzo for Passover. America is, in fact, the least racist country in history. That’s why, for example, there are so many race hoaxes; the real thing is so hard to find. Jews didn’t need to concoct anti-Jewish hoaxes to prove there was widespread anti-Semitism in Germany in the 1930s.

**Ferguson was an example of racist police brutality.** The Ferguson lie is frequently cited by the left as an example of police racism, including by figures as prominent as Barack Obama. # Blackwell: The Greatest Electoral Heist in American History

The pieces are finally coming together, and they reveal a masterpiece of electoral larceny involving Big Tech oligarchs, activists, and government officials who prioritize partisanship over patriotism.

The 2020 election was stolen because leftists were able to exploit the coronavirus pandemic to weaken, alter, and eliminate laws that were put in place over the course of decades to preserve the integrity of the ballot box. But just as importantly, it was stolen because those same leftists had a thoroughly-crafted plan, and because they were rigorous in its implementation and ruthless in its execution.

Let's not forget that liberals have been consumed by a fixation with removing Donald Trump from office for longer than he's actually been in office. The sordid story of the 2020 election heist begins all the way back in January 2017, when Barack Obama's former campaign manager and senior advisor, David Plouffe, took a job leading the policy and advocacy efforts of the Chan Zuckerberg Initiative, a "charitable" organization established by Facebook founder Mark Zuckerberg and his wife, Priscilla Chan.

Earlier this year, just as it was becoming clear that Joe Biden would be the Democratic Party's nominee for president, Plouffe published a book outlining his vision for the Democrats' roadmap to victory in 2020, which involved a "block by block" effort to turn out voters in key Democratic strongholds in the swing states that would ultimately decide the election, such as Philadelphia, Milwaukee, Detroit, and Minneapolis.

The book was titled, *A Citizen's Guide to Defeating Donald Trump*, and it turned out that the citizen Plouffe had in mind was none other than his former boss, Mark Zuckerberg. Although Plouffe no longer officially managed Zuckerberg's policy and advocacy efforts at that point, the political operative's influence evidently remained a powerful force.

Thanks to the extensive efforts of investigators and attorneys for the Amistad Project of the nonpartisan Thomas More Society, who have been following Zuckerberg's money for the past 18 months, it is still possible to expose the inner workings of this heist in time to stop it. Perhaps even more importantly, these unsung heroes of American democracy are dedicated to making sure that such a travesty will not become a permanent feature of our elections.

Under the pretext of assisting election officials conduct "safe and secure" elections in the age of COVID, Zuckerberg donated \$400 million — as much money as Congress appropriated for the same general purpose — to nonprofit organizations founded and run by left-wing activists. The primary recipient was the Center for Tech and Civic Life (CTCL), which received the staggering sum of \$350 million. Prior to Zuckerberg's donations, CTCL's annual operating expenses averaged less than \$1 million per year. How was Zuckerberg even *aware* of such a small-potatoes operation, and why did he entrust it with 7/8 of the money he was pouring into this election cycle, despite the fact that it had no prior experience handling such a massive amount of money?

Predictably, given the partisan background of its leading officers, CTCL proceeded to distribute Zuckerberg's funds to left-leaning counties in battleground states. The vast majority of the money handed out by CTCL — especially in the early days of its largesse — went to counties that voted overwhelmingly for Hillary Clinton in 2016. Some of the biggest recipients, in fact, were the very locales Plouffe had identified as the linchpins of the Democrat strategy in 2020.

Zuckerberg and CTCL left nothing to chance, however, writing detailed conditions into their grants that dictated exactly how elections were to be conducted, down to the number of ballot drop boxes and polling places. The Constitution gives state lawmakers sole authority for managing elections, but these grants put private interests firmly in control.

Amistad Project lawyers tried to prevent this unlawful collusion by filing a flurry of lawsuits in eight states prior to Election Day. Unfortunately, judges were forced to put those lawsuits aside without consideration of their merits because the plaintiffs had not yet suffered "concrete harm" in the form of fraudulent election results. The law had no remedy to offer because the left's lawless schemes had not yet reached fruition.

In the meantime, CTCL continued splashing Zuckerberg's cash — only now, the organization was intent on finding Republican-leaning jurisdictions to give its donations a veneer of bipartisanship. Of course, the number of votes in play in those counties paled in comparison to those in the liberal counties. Philadelphia County alone, for instance, projected that the \$10 million grant it received from CTCL would enable it to increase turnout by 25-30 percent — translating to well over 200,000 votes.

The left didn't put all of its eggs into the CTCL basket, though. High-ranking state officials simultaneously took significant steps to weaken ballot security protocols, acting on their own authority without permission or concurrence from the state legislatures that enshrined those protections in the law.

In Wisconsin, Democrat Secretary of State Doug La Follette allowed voters to claim “indefinite confinement” in order to avoid having to provide a photocopy of their ID when requesting an absentee ballot. The exemption was intended for legitimate invalids, but COVID offered a convenient excuse for circumventing the law, despite the fact that Wisconsin had no pandemic-related lockdown rules that would have rendered anyone “indefinitely confined.” The impact was far-reaching. About 240,000 voters claimed the exemption in 2020, compared to just 70,000 in 2016.

In Michigan, Democrat Secretary of State Jocelyn Benson unilaterally voided the legal requirement that voters provide a signature when requesting an absentee ballot, establishing an online request form. She then took things a step further by announcing that she would “allow civic groups and other organizations running voter registration drives to register voters through the state’s online registration website,” granting partisan groups such as Rock The Vote direct access to Michigan’s voter rolls.

In Pennsylvania, election officials in heavily-Democratic counties that received CTCL funding allowed flawed mail-in ballots to be “cured” — that is, altered or replaced — prior to Election Day. In other counties, officials rightly interpreted this as a flagrant violation of state law. On the night before Election Day, less than 24 hours before polls were due to close, Democrat Secretary of State Kathy Boockvar sought to imbue this illegal practice with the appearance of validity by issuing a statement authorizing counties to contact voters who had cast improper ballots. Even if Boockvar had the statutory authority to do this, which she did not, the timing of her memo made it impossible for rural counties to take advantage of it to nearly the same extent as urban counties.

In numerous states, officials also absurdly consolidated the vote-counting and ballot-curing process in sporting arenas and other large venues, rather than the ward- and precinct-level offices that normally handle the job. This made absolutely no sense as a pandemic-related safety measure, but that didn’t stop the officials from citing COVID as their rationale.

Consolidating the vote-counting tied the other efforts together. Instead of a manageable number of ballots being transported to small offices and counted in the immediate presence of observers from both parties, truckloads of ballots were brought to a single location, inevitably resulting in confusion and commingling of ballots from various sources. Securing those ballots from the time they left voters’ hands to the time they were officially counted should have been the top priority of election workers, but it’s not even clear whether there were logs kept identifying which ballots were delivered by which trucks and when. If such logs even exist, they have not been disclosed.

At the same time, election officials could claim that they were adhering to legal requirements that observers be “in the room” during the counting process while using COVID as an excuse for relegating those observers to the “penalty box,” far from the actual counting and curing.

This was particularly egregious when it came to ballot “curing,” a process that actually involves election workers filling out brand new ballots on behalf of voters whose ballots purportedly could not be read by machine. This could have been due to something the voter themselves did, such as spilling coffee on the ballot. It also could have been due to something that election workers themselves did, such as crumpling ballots to prevent the machines from receiving them, just as a vending machine rejects crumpled bills.

It’s impossible to know exactly what happened, because Republican observers were denied meaningful access to the process — and in some cases literally locked out of the counting rooms while election workers obscured the windows with cardboard.

These election workers, it should be noted, were paid directly by CTCL’s grants. These supposedly impartial arbiters of our electoral process are supposed to work for the people, but they were on Zuckerberg’s payroll.

All of this sounds like the stuff of fiction — the sort of thing one would expect from a cinematic thriller or a spy novel. Sadly, it’s the reality that our country is faced with after years of placidity in the face of increasingly aggressive intervention into our electoral process on the part of Big Tech oligarchs and activists with deep pockets and shallow motivations.

Of course, it was The New York Times editorial board that was so "terrified" of Cotton's opinions that it slapped an apology on an editorial he wrote for it about riots and fired the editor responsible for publishing it to appease woke staffers.

Omar's comment, as utterly unserious as it was, demonstrates the great crisis confronting modern Americans.

She is not alone in dismissing the Pilgrim story or Thanksgiving as a whole. Many of our elite institutions—and now, elected officials—have a knee-jerk reaction to attack or dismiss much of our history.

Clearly, a steady drumbeat of woke ideologues in the media and on Twitter have convinced enough people to view the Pilgrim story as another example of oppressor against oppressed, of racist versus antiracist.

How did this happen?

It's unclear what "actual history" Omar was referring to, but perhaps something akin to it is Howard Zinn's "A People's History of the United States," a work often celebrated by her left-wing allies. In this book, Zinn created a dishonest, distorted, and ultimately shallow picture of the Pilgrim arrival in America.

As Mary Grabar, author of "Debunking Howard Zinn," wrote for The Federalist in 2019, Zinn deconstructs the Pilgrims' "first" Thanksgiving to advance his Marxist ideas of oppressors versus oppressed.

In these simplistic narratives, the Pilgrims are portrayed as wicked oppressors and the native people as angelic, oppressed victims. This is the narrative now being peddled in elementary schools around the country.

In her critique of Zinn-inspired literature used in Portland, Oregon, public schools, Grabar wrote:

*It makes a cartoonish presentation of myriad people groups from the Bahamas and South America to New Mexico and New England. They are falsely oversimplified as universally peace-loving, Mother Earth-respecting, generous, and welcoming. All Indian tribes are lumped together as a mass of childlike people oppressed by the greedy capitalist explorers and settlers.*

It's no surprise that in 2020, Portland became an epicenter of Jacobin-like rioters, who targeted statues of George Washington and countless others while making absurd demands to abolish the police.

Here we see the fruits of a generation raised on Zinn.

While it is likely pointless to convince the vandals who attack statues and businesses that their views are misguided, we need to take the propaganda that has undermined our country and driven fellow citizens to lunacy and extremism seriously.

Thanksgiving is in the beginning stages of receiving the Columbus Day treatment. We can't underestimate the threat of a few militant voices

amplified by America's elite culture-shaping institutions.

Columbus was once nearly universally admired in America, his holiday only questioned by an odd collection of left-wing radicals and, at an even earlier date, white nationalists who resented the celebration of a Catholic and Italian-born hero.

Now, the holiday has nearly collapsed. Even his statues are going undefended by the descendants of Italian immigrants who helped construct them.

Columbus may receive a revival someday, and I firmly believe the spirit of his holiday will. But for now, the radicals have mostly won.

Thanksgiving is much harder to cancel at the moment, but it is clear that leftists want it on the chopping block.

As I wrote in my book "The War on History: The Conspiracy to Rewrite America's Past," the real target here isn't really the Pilgrims and Puritans, it's the very heart of the Thanksgiving holiday, a holiday that—from its more modern origin in the 19th century—stands for faith, family, and patriotism.

All of these virtues are anathema to woke social justice warriors, who want to purge religion from the public square, obliterate the "Western-prescribed" traditional nuclear family, and redefine love of country as a mask for hatred of others.

This year's Mayflower anniversary, as Cotton eloquently explained, is particularly noteworthy:

*[T]he Thanksgiving season is upon us and once again we have much to give thanks for. But this year we ought to be especially thankful for our ancestors, the Pilgrims, on their four hundredth anniversary. Their faith, their bravery, their wisdom places them in the American pantheon. Alongside the Patriots of 1776, the Pilgrims of 1620 deserve the honor of American founders.*

As Cotton noted in his speech, prominent Americans of ages past have made speeches marking the centuries since the landing at Plymouth. Perhaps the most famous is by New England statesman Daniel Webster, whose Plymouth Oration of 1820—delivered on "Forefathers Day"—was one of the most important steps in turning the New England story into a national story.

Webster's speech was both deeply conservative and "progressive" at the same time. He explained how the Pilgrim forefathers laid down the foundation, the building blocks of what would become a country attached to both self-government and religious liberty.

The Pilgrim experience of fleeing religious repression and inaugurating their newly founded community in the New World with a simple, 200-word Mayflower Compact affirming the rule of law set in motion the inertia for a people rooted in but diverging from their European origins.

However, Webster's speech was not merely a celebration of the past. He called on his generation and the generations to come to perpetuate and extend what we had been given: the great gift of free government.

The speech was mixed with a general, genuine, and unquestionable love of country, with a specific demand for what needed to be changed—the abominable institution of slavery in particular.

It is perhaps a symbol of Webster's triumph that it is a senator from Arkansas, a Southerner and not a New Englander, who delivered a great oration in celebration of the Pilgrims for the fourth-century mark in a republic where slavery has long been buried.

In his own words, Cotton proudly declared:

*Some—too many—may have lost the civilizational self-confidence needed to celebrate the Pilgrims ... But I for one still have the pride and confidence of our forebears, so here today, I speak in the spirit of that cabin and I reaffirm that old Compact.*

The future of our country, and the continuity of ideas and institutions that we should all be deeply grateful for, depend on Thanksgiving.

If we fail to cherish the special achievements of 1620, Americans a century from now will look forward through the lens of grievance and back with a feeling of contempt.

This war cannot be lost, or our country is lost.

**But if Mr. Trump tries to undo the legal process or disrupts a peaceful transition to Biden, the CEOs discussed making public statements and pressuring GOP legislators in their states** who may try to redirect Electoral College votes from Biden to Trump, said Yale Management Professor Jeffrey Sonnenfeld, who convened the meeting. [Emphasis added]

"They're all fine with him taking an appeal to the court, to a judicial process. They didn't want to deny him that. But **that doesn't stop the transition,**" said Sonnenfeld. "They said if that makes people feel better, it doesn't hurt anything to let that grind through." [Emphasis added]

The CEOs decided to wait for the November 20 certification of votes in Georgia before meeting to decide their next moves. **Action could include threats to stop donations to political action committees or even corporate relocations**, Sonnenfeld said. [Emphasis added]

The big business lobby and Wall Street have been looking to undermine Trump's economic nationalist agenda for years. The U.S. Chamber of Commerce and the Business Roundtable — both representing some of the nation's largest multinational corporations and fighting Trump — [congratulated Biden](#) and Sen. Kamala Harris (D-CA) days after the November 3 election.

"The U.S. Chamber stands ready to work with the Biden administration and leaders on both sides of the aisle to restore public health, revitalize our economy, and help rebuild American lives and communities," the Chamber's statement reads.
