Professor Jeffrey F. Addicott

Professor of Law; Director, Center for Terrorism Law, St. Mary's University School of Law

Lt. Colonel (U.S. Army, ret.) Jeffrey F. Addicott is a Professor of Law and the Director of the Center for Terrorism Law. An active duty Army officer in the Judge Advocate General's Corps for twenty years, Addicott spent a quarter of his career as the senior legal advisor to the United States Army's Special Forces. As an internationally recognized authority on national security law, Addicott not only lectures and participates in professional and academic organizations both in the United States and abroad (more than 700 speeches), but he has also testified before Congress on a variety of legal issues. He has also been a regular contributor to national and international news media outlets to include FOX NEWS Channel, MSNBC, CNN, BBC, New York Times, Washington Post, Wall Street Journal, USA Today, (more than 4,000 media interviews). Addicott is a prolific author, publishing over 60 books, articles and monographs on a variety of legal topics.

His latest book, *Trump Judges-Protecting America's Establishment Pillars to Make America Great Again* is a must read. At a time when the country is exposed to endless negativity this book provides a welcomed reminder that America is truly a land of opportunity and tolerance where the rule of law is best protected by originalist judges.

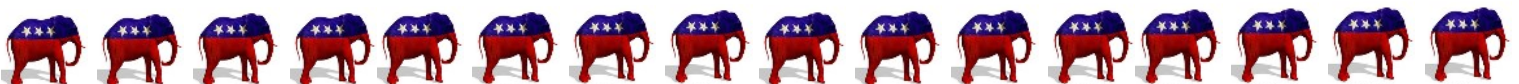

Patriot Day

The tragic attack on 9/11 resulted in more than one hero emerging from the rubble and ashes of the devastation including the rescue dogs. Over 300 of these rescue dogs were called upon to search through the debris for survivors in the days and weeks after the attack. In the years that have passed these dogs have crossed the rainbow bridge to dog heaven but let us never forget the wonderful role they played during that terrible event.

RILEY

This search and rescue Golden Retriever was formally trained to locate survivors of the attacks, desperately searching the World Trade Center through the nights following as part of FEMA's Pennsylvania Task Force 1. Iconic photos of Riley being transported alone through the debris onsite have been shared thousands of times since 2001. His image as a beacon of hope at Ground Zero brought motivation and comfort to the firefighters and police officers tirelessly working through the tragedy.

Riley provided his owner, Chris Selfridge, and his nation with over 13 years of love and support. Riley's passing in 2010 helped inspire a study of the long-term effects this type of rigorous search and rescue work can have on canine health.

APOLLO

German Shepherd Apollo graduated from the NYPD Canine Special Operations Division when he was two years old. He was one of New York City's top dogs throughout the 1990s and worked with the first NYPD K-9 Urban Search and Rescue team. Apollo and his handler, Peter Davis, were the first K-9 search and rescue team to answer the call on September 11, arriving at the South Tower merely 15 minutes after its collapse.

From that moment on, Apollo looked for survivors 18 hours a day for weeks on end. His search and rescue work earned him one of the first AKC Humane Fund Awards for Canine Excellence (ACE) in 2001 as well as the Dickin Medal, on behalf of all Patriot Day search and rescue dogs,

"for tireless courage in the service of humanity during the search and rescue operations in New York and Washington on and after 11 September 2001. Faithful to words of command and undaunted by the task, the dogs' work and unstinting devotion to duty stands as a testament to those lost or injured. "

SAGE

Sage was 2 years old when the search and rescue Border Collie and her handler, Diane Whetsel, worked at the Pentagon after the 9/11 attacks. With the highest-level recognition from the Federal Emergency Management Agency, Sage was one of the nation's top 50 dogs in the search and rescue field. She and her handler continued their careers in SAR by rescuing animals stranded by Hurricane Rita and Hurricane Katrina before their deployment to Iraq in 2007.

Once retired, Sage became a part of the 9/11 search and rescue dog study done by the University of Pennsylvania, funded by the AKC Canine Health Foundation. She was also honored with the 2009 Search and Rescue Award for Canine Excellence before crossing the Rainbow Bridge in 2012 at the age of 13.

BRETAGNE

Bretagne (Brit-nee) was known as the last living search and rescue dog to have worked at Ground Zero. Bretagne and her owner-handler Denise Corliss worked 12-hour shifts on rescue and recovery for 10 days straight after the attacks on September 11. This Golden Retriever's career training began at just eight weeks old, making her a lifelong veteran of rescue missions including Hurricanes Katrina, Rita, and Ivan.

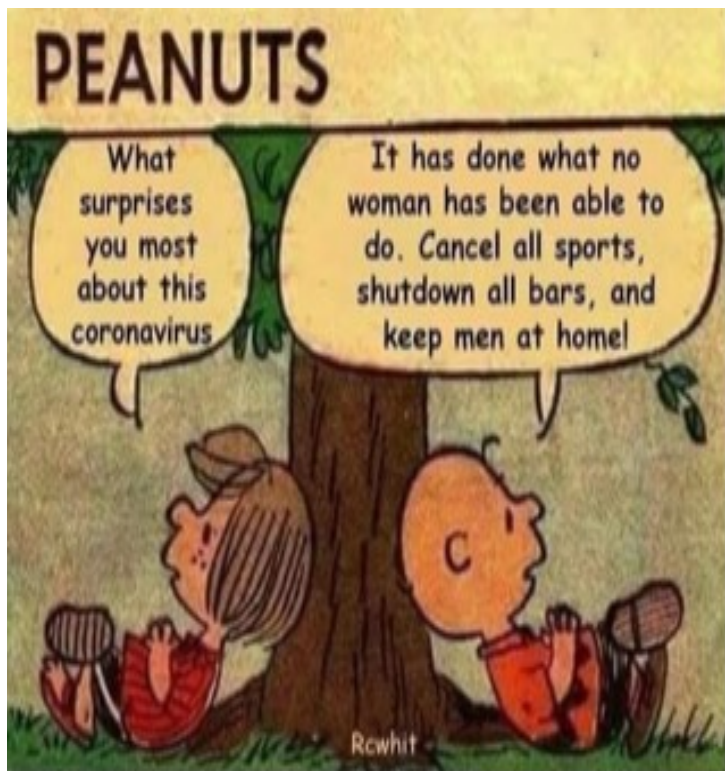
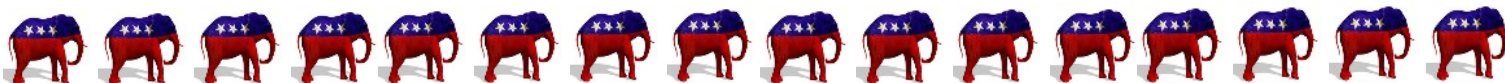
After her retirement from the workforce at age 9, Bretagne took her talents to a local elementary school where she helped first-graders as a reading assistance dog for her remaining years. Bretagne crossed the Rainbow Bridge with her owners by her side at the age of 16 in Texas, where she was saluted by representatives from the armed forces and local fire departments.

TRAKR

Trakr was a German Shepherd who answered the call for action that fateful day with his Canadian police officer and handler, James Symington. The duo is credited with finding the last remaining survivor from the World Trade Center after she had been trapped for 26 hours. TIME magazine awarded Trakr the sixth spot on their published list of Top 10 Heroic Animals.

Seven years later, Symington entered Trakr in a BioArts International contest where the winner's DNA would be cloned. Trakr had what it took as an exceptional canine specimen and was cloned five times before his passing in 2009 at the age of 14. The Trakr puppy clones (Trustt, Solace, Valor, Prodigy, and Deja Vu) are continuing Trakr's legacy and all started their training as search and rescue dogs in 2011.

These dogs along with their owners and handlers are indeed heroes. I'm glad we take this day to remember and honor all the many heroes that worked that tragic time.

REMARKS BY PRESIDENT TRUMP IN ANNOUNCING HIS NOMINEE FOR ASSOCIATE JUSTICE OF THE SUPREME COURT OF THE UNITED STATES

THE PRESIDENT: Thank you very much. Thank you. Thank you. I stand before you today to fulfill one of my highest and most important duties under the United States Constitution: the nomination of a Supreme Court Justice. This is my third such nomination after Justice Gorsuch and Justice Kavanaugh. And it is a very proud moment indeed.

Over the past week, our nation has mourned the loss of a true American legend. Justice Ruth Bader Ginsburg was a legal giant and a pioneer for women. Her extraordinary life and legacy will inspire Americans for generations to come. Now we gather in the Rose Garden to continue our never-ending task of ensuring equal justice and preserving the impartial rule of law.

Today, it is my honor to nominate one of our nation's most brilliant and gifted legal minds to the Supreme Court. She is a woman of unparalleled achievement, towering intellect, sterling credentials, and unyielding loyalty to the Constitution: Judge Amy Coney Barrett. We're also joined by Amy's husband, Jesse thank you, Jesse, very much and their seven beautiful children. Congratulations to you all. A very special day. With us as well are the First Lady thank you, First Lady along with Vice President Mike Pence and his amazing wife, Karen. Thank you very much, Mike.

Judge Barrett is a graduate of Rhodes College and the University of Notre Dame Law School. At Notre Dame, she earned a full academic scholarship, served as the Executive Editor of the Law Review, graduated first in her class, and received the law school's award for the best record of scholarship and achievement.

Upon graduation, she became a clerk for Judge Laurence Silberman on the U.S. Court of Appeals for the District of Columbia. Amy then received one of the highest honors a young lawyer could have, serving as a clerk on the Supreme Court for Justice Antonin Scalia. A highly a very highly respected law professor at Notre Dame wrote to Justice Scalia with a one-sentence recommendation: "Amy Coney is the best student I ever had." That's pretty good. Justice Scalia hired her shortly thereafter.

And we are honored to have his wonderful wife, Maureen — where is Maureen? Maureen Scalia — with us today. Thank you. And our great Secretary of Labor, thank you very much. Thank you, Mr. Secretary. Very good genes in that family, I will say. Very good genes.

Before joining the bench, Judge Barrett spent 15 years as a Professor at the University of Notre Dame Law School. She was renowned for her scholarship, celebrated by her colleagues, and beloved by her students. Three times, she was selected at Notre Dame, Distinguished Professor of the Year.

When I nominated Judge Barrett to serve on the U.S. Court of Appeals for the Seventh Circuit in 2017, every law clerk from her time at the Supreme Court endorsed her and endorsed her nomination, writing, quote, "We are Democrats, Republicans, and independents...yet we write to support the nomination of Professor Barrett to be a Circuit Judge...Professor Barrett is a woman of remarkable intellect and character. She is eminently qualified for the job."

And I can tell you, I did that too. I looked and I studied, and you are very eminently qualified for this job. You are going to be fantastic. Thank you. Really fantastic. The entire Notre Dame Law facility and faculty, everybody at that school also we got so many letters also wrote letters of support of Amy's nomination to the Seventh Circuit. They wrote, in effect: "Despite our differences, we unanimously agree that our constitutional system depends upon an independent judiciary staffed by talented people devoted to the fair and impartial administration of the rule of law. And we unanimously agree that Amy is such a person."

For the last three years, Judge Barrett has served with immense distinction on the federal bench. Amy is more than a stellar scholar and judge; she is also a profoundly devoted mother. Her family is a core part of who Amy is. She opened her home and her heart, and adopted two beautiful children from Haiti. Her incredible bond with her youngest child, a son with Down Syndrome, is a true inspiration.

If confirmed, Justice Barrett will make history as the first mother of school-aged children ever to serve on the U.S. Supreme Court. That's good. To her children Emma, Vivian, Tess, John Peter, Liam, Juliet, and Benjamin, thank you for sharing your incredible mom with our country. Thank you very much.

Amy Coney Barrett will decide cases based on the text of the Constitution as written. As Amy has said, "Being a judge takes courage. You are not there to decide cases as you may prefer. You are there to do your duty and to follow the law wherever it may take you." That is exactly what Judge Barrett will do on the U.S. Supreme Court.

I want to thank the members of the Senate. We have so many of them here today. Thank you very much. I see you in the audience, and you're so proud. But I want to thank you for your commitment and to providing a fair and timely hearing. I know it will be that.

Judge Barrett was confirmed to the Circuit Court three years ago by a bipartisan vote. Her qualifications are unsurpassed and her record is beyond reproach. This should be a straightforward and prompt confirmation. It should be very easy. Good luck. It's going to be very quick. I'm sure it'll be extremely non-controversial. We said that the last time, didn't we? Well, thank you all very much, and thank you for being here. That's really great. Thank you.

I further urge all members of the other side of the aisle to provide Judge Barrett with the respectful and dignified hearing that she deserves and, frankly, that our country deserves. I urge lawmakers and members of the media to refrain from personal or partisan attacks. And the stakes for our country are incredibly high. Rulings that the Supreme Court will issue in the coming years will decide the survival of our Second Amendment, our religious liberty, our public safety, and so much more.

To maintain security, liberty, and prosperity, we must preserve our priceless heritage of a nation of laws, and there is no one better to do that than Amy Coney Barrett. Law and order is the foundation of the American system of justice. No matter the issue, no matter the case before her, I am supremely confident that Judge Barrett will issue rulings based solely upon a fair reading of the law. She will defend the sacred principle of equal justice for citizens of every race, color, religion, and creed.

Congratulations again to Judge Barrett. I know that you will make our country very, very proud. Please, Amy, say a few words. Thank you very much. Congratulations. Congratulations.

JUDGE BARRETT: Thank you very much, Mr. President. I am deeply honored by the confidence that you have placed in me. And I am so grateful to you and the First Lady, to the Vice President and the Second Lady, and to so many others here for your kindness on this rather overwhelming occasion.

I fully understand that this is a momentous decision for a President. And if the Senate does me the honor of confirming me, I pledge to discharge the responsibilities of this job to the very best of my ability. I love the United States, and I love the United States Constitution. I am truly I am truly humbled by the prospect of serving on the Supreme Court.

Should I be confirmed, I will be mindful of who came before me. The flag of the United States is still flying at half-staff in memory of Justice Ruth Bader Ginsburg to mark the end of a great American life. Justice Ginsburg began her career at a time when women were not welcome in the legal profession. But she not only broke glass ceilings, she smashed them. For that, she has won the admiration of women across the country and, indeed, all over the world. She was a woman of enormous talent and consequence, and her life of public service serves as an example to us all. Particularly poignant to me was her long and deep friendship with Justice Antonin Scalia, my own mentor.

Justices Scalia and Ginsburg disagreed fiercely in print without rancor in person. Their ability to maintain a warm and rich friendship, despite their differences, even inspired an opera. These two great Americans demonstrated that arguments, even about matters of great consequence, need not destroy affection. In both my personal and professional relationships, I strive to meet that standard.

I was lucky enough to clerk for Justice Scalia, and given his incalculable influence on my life, I am very moved to have members of the Scalia family here today, including his dear wife, Maureen. I clerked for Justice Scalia more than 20 years ago, but the lessons I learned still resonate. His judicial philosophy is mine too: A judge must apply the law as written. Judges are not policymakers, and they must be resolute in setting aside any policy views they might hold. The President has asked me to become the ninth justice, and as it happens, I'm used to being in a group of nine: my family.

Our family includes me, my husband Jesse, Emma, Vivian, Tess, John Peter, Liam, Juliet, and Benjamin. Vivian and John Peter, as the President said, were born in Haiti and they came to us, five years apart, when they were very young. And the most revealing fact about Benjamin, our youngest, is that his brothers and sisters unreservedly identify him as their favorite sibling.

Our children obviously make our life very full. While I am a judge, I'm better known back home as a room parent, carpool driver, and birthday party planner. When schools went remote last spring, I tried on another hat. Jesse and I became co-principals of the Barrett e-learning academy. And, yes, the list of enrolled students was a very long one.

Our children are my greatest joy, even though they deprive me of any reasonable amount of sleep. I couldn't manage this very full life without the unwavering support of my husband, Jesse. At the start of our marriage, I imagined that we would run our household as partners. As it has turned out, Jesse does far more than his share of the work. To my chagrin, I learned at dinner recently that my children consider him to be the better cook.

For 21 years, Jesse has asked me, every single morning, what he can do for me that day. And though I almost always say "nothing," he still finds ways to take things off my plate. And that's not because he has a lot of free time — he has a busy law practice — it's because he is a superb and generous husband, and I am very fortunate.

Jesse and I Jesse and I have a life full of relationships, not only with our children, but with siblings, friends, and fearless babysitters, one of whom is with us today. I am particularly grateful to my parents, Mike and Linda Coney. I spent the bulk of I have spent the bulk of my adulthood as a Midwesterner, but I grew up in their New Orleans home. And as my brother and sisters can also attest, Mom and Dad's generosity extends not only to us, but to more people than any of us could count. They are an inspiration.

It is important at a moment like this to acknowledge family and friends. But this evening, I also want to acknowledge you, my fellow Americans. The President has nominated me to serve on the United States Supreme Court, and that institution belongs to all of us.

If confirmed, I would not assume that role for the sake of those in my own circle, and certainly not for my own sake. I would assume this role to serve you. I would discharge the judicial oath, which requires me to administer justice without respect to persons, do equal right to the poor and rich, and faithfully and impartially discharge my duties under the United States Constitution.

I have no illusions that the road ahead of me will be easy, either for the short term or the long haul. I never imagined that I would find myself in this position. But now that I am, I assure you that I will meet the challenge with both humility and courage.

Members of the United States Senate, I look forward to working with you during the confirmation process, and I will do my very best to demonstrate that I am worthy of your support. Thank you.

THE PRESIDENT: Come on up, family. Come on up, family. I want to acknowledge Attorney General Bill Barr. Bill, thank you very much for being here. Chief of Staff thank you very much, Chief. You're doing a great job. And all of the senators please, we really appreciate it. And I know you're going to have a busy couple of weeks, but I think it's going to be easier than you might think. So, thank you very much for being here. Thank you all. Thank you all very much. Thank you. Congratulations, Amy.

Sen. Lindsey Graham lays out a swift schedule for confirming Trump's Supreme Court nominee

He's setting up Judge Amy Coney Barrett for a full Senate vote before the end of October.

Senate Judiciary Committee Chair Lindsey Graham laid out a swift timeline on Sunday for confirming President Donald Trump's Supreme Court nominee, Judge Amy Coney Barrett, telling Fox News his committee will approve Barrett by October 22. That could tee up her nomination for a full Senate vote before the end of the month.

Graham's schedule is putting the Senate on track for what could be one of the fastest Supreme Court justice confirmations in modern American history, and there's not much that Democrats can do about it.

Graham told *Sunday Morning Futures* host Maria Bartiromo that the confirmation process would begin October 12. A day of introduction would be followed by two days of questioning, and a review of the committee's recommendation would begin October 15, he said.

"We'll report her nomination out of the committee on October 22," Graham said. "Then it will be up to [Senate Majority Leader Mitch] McConnell as to what to do with the nomination."

If Graham is able to stay on that schedule, McConnell will have the option to hold Barrett's confirmation vote before Election Day — or during the lame-duck session after the elections.

As Vox's Andrew Prokop has explained, this would be an expedited process, but it would be fully within the rules:

In recent decades, the Supreme Court confirmation process — from nomination to the final vote — has lasted two to three months. Typically, this time is taken up by vetting of the nominee's history, writings, and career, and then hearings in the Senate Judiciary Committee (which can last several days), before Senate leaders attempt to line up sufficient support for a floor vote.

But there's no reason other than decorum that all this *has* to take so much time. If Republican senators are unconcerned about the appearances of an unseemly rush to a vote, they can certainly hold a quicker vote should they so desire.

The speed of the process Graham outlined has rankled Democrats and defenders of deliberative propriety in the Senate because it implies the outcome of the committee process is preordained — and has led to Democratic concern that Barrett will not be vetted properly in the rush to confirm her.

The proximity of the vote to Election Day is also unusual. No Supreme Court nominee has been confirmed after July during a presidential election year before. Democratic lawmakers have criticized McConnell for choosing to hold a confirmation so close to an election, particularly after he blocked former President Barack Obama's Supreme Court nominee in March 2016, arguing that a president should not nominate a new justice within several hundred days of a presidential election.

Democrats have limited tools at their disposal for stopping the confirmation process. Senate Minority Whip Dick Durbin (D-IL) said Sunday on ABC's *This Week* that Democrats have some procedural weapons with which they can slow down the process, but that their arsenal isn't powerful enough to derail the nomination process altogether.

Subject: Civil War

This is a fascinating (and disturbing) read. One of the best "nutshell" descriptions of the United States current political situation Dr. Jack Devere Minzey, born 6 October 1928, died 8 April 2018, was the Department Head of Education at Eastern Michigan University as well as a prolific author of numerous books, most of which were on the topic of Education and the Government role therein. (Editor's note) This was the last of his works:

Civil War: How do civil wars happen? By Dr. Jack Devere Minzey

Two or more sides disagree on who runs the country. And they can't settle the question through elections because they don't even agree that elections are how you decide who's in charge. That's the basic issue here. Who decides who runs the country? When you hate each other but accept the election results, you have a country. When you stop accepting election results, you have a countdown to a civil war.

The Mueller investigation was about removing President Trump from office and overturning the results of an election. We all know that. But it's not the first time they've done this. The first time a Republican president was elected this century, they said he didn't really win. The Supreme Court gave him the election. There's a pattern here.

What do sure odds of the Democrats rejecting the next Republican president really mean? It means they don't accept the results of any election that they don't win. It means they don't believe that transfers of power in this country are determined by elections. That's a civil war.

There's no shooting. At least not unless you count the attempt to kill a bunch of Republicans at a charity baseball game practice. But the Democrats have rejected our system of government.

This isn't dissent. It's not disagreement. You can hate the other party. You can think they're the worst thing that ever happened to the country. But then you work harder to win the next election. When you consistently reject the results of elections that you don't win, what you want is a dictatorship.

Your very own dictatorship.

The only legitimate exercise of power in this country, according to Democrats, is its own. Whenever Republicans exercise power, it's inherently illegitimate. The Democrats lost Congress. They lost the White House. So what did they do? They began trying to run the country through Federal judges and bureaucrats. Every time that a Federal judge issues an order saying that the President of the United States can't scratch his own back without his say so, that's the civil war.

Our system of government is based on the constitution, but that's not the system that runs this country. The Democrat's system is that any part of government that it runs gets total and unlimited power over the country.

If the Democrats are in the White House, then the president can do anything. And I mean anything. He can have his own amnesty for illegal aliens. He can fine you for not having health insurance. He can use the IRS as his own police force and imprison citizens who speak against him. The Left's Dangerous Delegitimization of the Election

A recent article in The Washington Post's Outlook section, "What's the Worst That Could Happen?"—which explores various potential outcomes of the 2020 presidential election—found that in "every scenario except a [Joe] Biden landslide, our simulation ended catastrophically." According to the Post, any other outcome is destined to spark "violence" and a "constitutional crisis."

Or, in other words, nice country you got there...

Every assumption in the article, written by Rosa Brooks, a Georgetown University law professor and co-founder of the Transition Integrity Project, is awash in the conspiratorial paranoia. It's a world where Trump officials are "ruthless and unconstrained right out of the gate" but the genteel statesmen of Team Biden "struggled to get out of reaction mode."

It is a place where Republicans aren't only reflexively seditious and autocratic, but where a "highly politicized" Supreme Court tries to steal the election.

In their "war game" scenarios, however, it's the Democrats who refuse to accept the will of courts to adhere to the constitutionally prescribed system rather than hysteria, and it's the Democrats who wish-cast the wholly imaginary "popular vote" into existence.

One of the scenarios, we learn, "doesn't look that different from 2016"—a contest in which, it must be pointed out, not one vote has been proven to be uncounted or altered. In that outcome, America is confronted with "a big popular win for Mr. Biden, and a narrow electoral defeat."

In the real world, incidentally, that scenario is called a "Trump victory."

In the fictional war game, however, John Podesta, playing the role of Biden, contends that his party won't let him concede the race, and instead alleges "voter suppression"—the catchall go-to every time a liberal loses—and persuades the Democratic governors of Trump-won states such as Wisconsin and Michigan to send pro-Biden electors to the Electoral College.

In the meantime, California, Oregon, and Washington threaten to secede from the union if Trump takes office. The Democrat-led House unilaterally names Biden president. "At that point in the scenario," The New York Times' Ben Smith explains, "the nation stopped looking to the media for cues, and waited to see what the military would do."

This scenario is what a real-life "coup" might resemble. It is, needless to say, utterly insane that the left would destroy the nation's longstanding and peaceful transition because they refuse to accept the mandated process of electing the president. All of which is to say the proactive—and retroactive—delegitimization of the Trump presidency has been a successful four-year project. It permeates the entire Democratic Party's information complex.

First, liberals convinced millions of Americans that a handful of inept and puerile social media ads were enough to overturn a presidential election in the most powerful nation on earth. By 2017, a majority of Democrats believed that vote tallies had been tampered with by Russians, somehow without a trace of evidence.

Since then, the left has been working to convince themselves there is no legitimate way in which Trump could win the election again. A large number of high-profile left-wing columnists have laid the groundwork to make this case and high-profile politicians have joined them.

Hillary Clinton's advice to Biden not long ago was to not concede defeat on the night of the Nov. 3 election no matter what happens. In January, during the impeachment trial, Rep. Adam Schiff, D-Calif., said, "The president's misconduct cannot be decided at the ballot box, for we cannot be assured that the vote will be fairly won."

House Speaker Nancy Pelosi, D-Calif., has noted that to "let the election decide" is a "dangerous position" because Trump is already "jeopardizing the integrity of the 2020 elections."

It's worth pointing out as well that the dynamics of the presidential election would be completely different if the popular vote actually existed. But candidates do not compete for the popular vote, so they can neither "win" nor "lose" it. If they did try to win the popular vote, they would cater to the largest population centers, and no one else, and elections would look very different.

I'm not sure that that setup would work out for Democrats exactly as they imagine, but it doesn't matter. A popular vote undercuts Federalism, one of the foundational ideas of the founding. And that's the point.

A recent USA Today poll found that 28% of Biden's supporters say they aren't prepared to accept a Trump victory as "fairly won," and 19% of Trump's supporters say the same about a potential Biden victory.

So a significant minority of American voters don't believe the next election will be legitimate before it has even been conducted. What happens when every long line at the polls and every Facebook meme and every delayed mail-in ballot is turned into a nefarious plot by the enemy to snatch democracy from the rightful winner?

It's going to be ugly, indeed. If their "war games" are to be believed, then that's what the left is counting on.

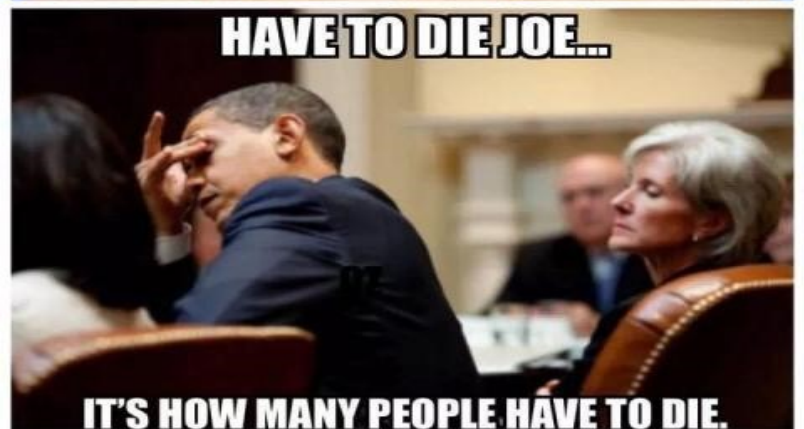
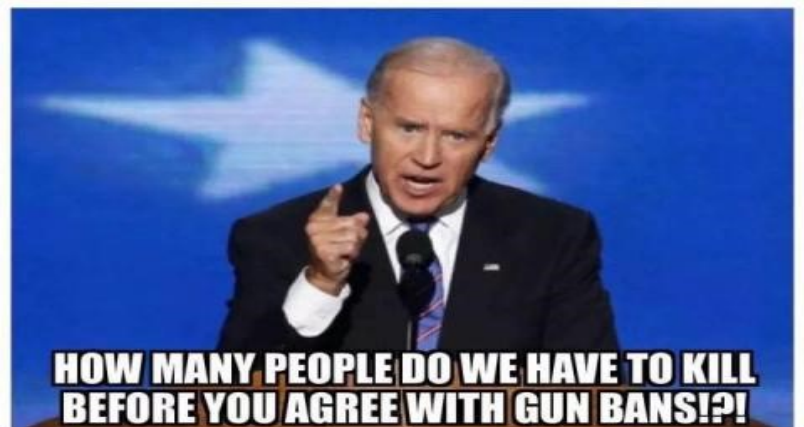
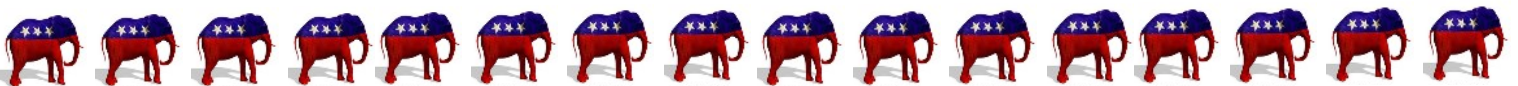
