From Green Icons to Targets: The Irony of Attacks on Tesla

Just a year ago, Tesla stood as a beacon for environmental progress, championed by activists and eco-conscious consumers alike. Its electric vehicles symbolized a collective stride toward a sustainable future. Fast forward to today, and the narrative has taken a perplexing sharp turn into Leftist

extremism. In cities across the U.S. and abroad, Tesla vehicles and facilities have become targets of vandalism and protest.

In March of 2025, Sen. Mark Kelly sold his Tesla for a Chevy Tahoe. Sen. Kelly and Musk once had a friendly relationship; this is part of the backlash against Elon Musk. It shows a growing problem in Democrat party, when they don't get what they want, they riot and try to dox people who have left the mindless Democrat Plantation.

In March 2025, nine protesters were arrested at a Tesla dealership in New York amid demonstrations against Elon Musk's political affiliations. On March 28th in Frisco, an unhinged driver plowed his truck into 7 parked cars to hit a Tesla Cybertruck parked at the Star. These actions starkly contrast with the company's environmental mission and highlight a shift in Democrat perception of Tesla. He has been named public



We have one month left in the legislative session. Some bills that have passed so far are....

House Bill 14 which creates the Texas Advanced Nuclear Energy Office.

House Bill 2 passed. It has \$7.7 billion more dollars in public education funding and a teacher pay raise.

Senate Bill 1 The State Budget Passed both chambers and is on its way to the governor's desk at the time of the writing of this report.

Senate Bill 689 passed the Senate. It bans DEI (Diversity, Equity, and Inclusion) which is a nice term for racism.

Senate Continuing Resolution 42 passed the Senate. It declares there are only two sexes, male and female.

Senate Bill 964 passed the Senate will require driver licenses obtained by non-citizens to say, "not eligible to vote" on them.

THE BIRTH OF THE REPUBLICAN PARTY: FREEDOM'S NEW CHAMPION

MAY 1, 2025

The story of the Republican Party is one of conviction, moral clarity, and a steadfast commitment to American ideals. From its very founding, the Republican Party stood against the moral evil of slavery, championing the inalienable rights of life, liberty, and the pursuit of happiness for all people. This unwavering commitment to human dignity and individual freedom remains central to the party's identity today. While the specific challenges have evolved—from the abolition of slavery to defending the sanctity of life, religious freedom, and property rights—the underlying principles endure. The Republican Party continues to be the party of traditional American values, rooted in faith, family, and freedom. Republicans stand as guardians of America's founding principles, believing that rights are granted not by government, but by God, and that it is the duty of every generation to defend them. Understanding the party's origins deepens our appreciation for the ongoing struggle to preserve American's God-given freedoms. As in 1856, the fight for unalienable rights calls for courage, conviction, and a steadfast commitment to the founding principles that make America exceptional.

A New Party Rises from Crisis (1854)

Amid the chaos of [Bleeding Kansas](#) and fierce national debate over slavery, a new political force emerged. On March 20, 1854, in Ripon, Wisconsin, anti-slavery activists, former Whigs, [Free Soilers](#), and concerned citizens gathered to confront the [Kansas-Nebraska Act](#), which had overturned the Missouri Compromise and opened new territories to slavery.

The idea that each territory could decide the fate of slavery through "popular sovereignty" sparked violence across Kansas and left a void in national leadership. **The Republican Party was born** to fill it.

From Ripon to Jackson: Taking Shape

Just months after the Ripon meeting, the first official Republican state convention convened in Jackson, Michigan, on July 6, 1854. There, the party formally adopted its name and mission: to halt the spread of slavery.

1856: A Platform of Bold Principles

By June 1856, the fledgling party gathered at [Philadelphia's Musical Fund Hall](#) for its first national convention. Here, John C. Frémont was nominated for president, and a platform of freedom and national progress was declared.

Key Planks of the 1856 Republican Platform

- **Stopping Slavery's Spread:**
The party called for Congress to ban slavery in U.S. territories, arguing it was both a moral imperative and constitutional duty. Echoing the Declaration of Independence, it insisted that *"all men are endowed with the inalienable right to life, liberty, and the pursuit of happiness."*
- **Twin Relics of Barbarism:**
The platform condemned slavery and polygamy (then practiced by some Mormons in Utah) as threats to the moral fabric of the nation.
- **Defending Rights in Kansas:**
Republicans denounced President Franklin Pierce's administration for trampling settlers' rights in Kansas, listing violations that included:
 - Infringement of the right to bear arms.
 - Suppression of free speech and press.
 - Denial of due process and fair elections.

The platform pledged to bring those responsible to justice, accusing the Pierce administration of complicity in these abuses.

- **Uniting the Nation with Infrastructure:**

Beyond fighting slavery, Republicans promoted national development, calling for:

- A transcontinental railroad to link East and West.
- Federal investment in rivers and harbors to bolster commerce and security.

- **Welcoming All Who Value Freedom:**

The platform invited Americans from all parties to join this new cause—uniting under the shared belief in liberty, conscience, and constitutional rights.

Frémont's Campaign: The Spark That Caught Fire

Although Frémont lost the 1856 election to James Buchanan, he won 11 Northern states, signaling the Republican Party's rapid rise. This groundwork paved the way for Abraham Lincoln's victory in 1860 and the abolition of slavery that followed.

What do the struggles of 1856 have to do with today's America?

Why This Still Matters

The Republican Party's founding was more than political strategy—it was a moral stand. By framing its cause in the language of America's founding documents, the party positioned itself as the defender of freedom, human dignity, and constitutional rights.

Today, remembering these beginnings reminds us that America's promise of liberty and justice for all requires vigilance—and sometimes bold new leadership.

In every generation, new challenges arise to test these freedoms—whether in the form of government overreach, attacks on religious liberty, or suppression of speech. The spirit that founded the Republican Party remains essential today. We are the party of freedom and liberty, given to us by God, which no man shall take away.



Restoring Our Industrial Base to Combat China: The key to countering China requires restoring our industrial might at home.

U.S. intelligence predicts a Chinese invasion of Taiwan by [2027](#), just two short years away. The fall of Taiwan would ensure China corners the world's market for semiconductor chips—used in everything from cars to smartphones to satellites. A victory here for the Chinese Communist Party (CCP) would also no doubt embolden the authoritarian regime's expansionist ambitions elsewhere.

The CCP has made it abundantly clear that its goal is to challenge U.S. global dominance and undermine the West politically, economically, and militarily. It's no secret that China's military expansion is proceeding at an alarming rate, even after you account for Beijing's propaganda campaigns. Without a robust navy, the U.S. will be unable to project power in the Indo-Pacific and maintain the capability to deter CCP belligerence. In fact, while the U.S. Navy currently holds a technological advantage in terms of the ships and weapons systems at its disposal, China's navy currently holds a four-to-one advantage in terms of ships deployed to the region. The United States would likely struggle to replace the loss of even a portion of its fleet should it become involved in a hot conflict with China in the near future.

How do we prevent this bleak scenario? By restoring America's defense industrial base now, before it's too late.




