## Why the Democratic Party Is Continuing with the Government Shutdown

Understanding the political strategy and motivations of a party who has lost its way in American politics can be perplexing. The ongoing government shutdown has become a focal point in American politics, with Democrats defending their positions,

many of which are causing pain to working class families and problems across multiple government agencies. Even the mainstream news outlets who are normally friendly to the Dems are asking why the Democratic Party is continuing with the shutdown, refusing to yield to common sense legislation from the Republicans party. If you ask a Democrat socialist, they will say the problem is complex, and they care about all "citizens" not just the rich. But let's take a look at their reasons and see if they are worth the real financial pain people are going through under them.

#### **Principled Stance on Policy Issue**

One of the main reasons Democrats have held their ground is their commitment to specific policy issues. Their beliefs are fundamental to their socialist platform, the Dems have moved further left over the last two decades to the point they do not respect the US Constitution, and they openly embrace Marxist ideology as the path forward for Americans. 

to be a temporary measure yet has persisted for over a century. By maintaining the shutdown, Democrats are shouting loud and proud that they are unwilling to compromise on their "core values" of supporting illegal aliens over US citizens and expiring Obamacare subsides right before the midterms over opening the government for everyone else.

#### **Political Leverage**

Democrats see the shutdown as a way to gain political leverage. By refusing to pass a budget or funding bill that contradicts their positions, they want to put pressure on the Republicans to make concessions first. Chuck Schumer and the Democrats are using the Politics of Pain. They want the shutdown to be so painful that everyone says okay. Let the illegals have all their government funded goodies so I can get paid, so I can get my much-needed benefits, so we can fund our military and bring back welfare programs like SNAP for legal citizens. Chuck Schumer and Hakeem Jeffries care more about their far-left fringe base than you. They are the worst type of politicians, making decisions based on how to keep their political power. #### **Messaging and Accountability**

Andy Kahan joined Crime Stoppers of Houston in June 2018 as its first-ever Director of Victim Services and Advocacy.

Prior to Crime Stoppers, Andy served as the Victim Advocate for the Mayor's Office and Houston Police Department for 26 years before retiring and joining Crime-Stoppers of Houston to resume his career as a Victim Advocate.

Andy Kahan received his Bachelor of Science in Criminal Justice in 1983 from the University of Houston. He worked as both a Parole and Probation Officer before becoming the first victim advocate in the country to work in a Mayor's Office. His responsibilities included working with local crime victim's rights organizations to facilitate the pooling of resources and the exchange of information, accompanying and representing victims before the Parole Board, putting crime victims in touch with local crime victims support and advocacy groups, and court accompaniment.

## Legislative Report

The Plano City Council has made the cost of living higher as of October 1<sup>st.</sup> The council has passed the largest property tax increase in the last three years. The average homeowner will see a \$249.00 increase in their property tax bills.

The council also passed increases on residents' heat, water, trash, and sewer bills. All these increases plus the property tax increase will cost the average homeowner \$521.96 a year. Not one council member fought against these raises.

## JAMES MADISON: ARCHITECT OF A FRAGILE REPUBLIC NOVEMBER 1, 2025

James Madison wasn't the loud revolutionary or the glamorous general. He was small, shy, chronically ill — a man who spoke so softly people leaned in to hear him. But behind that quiet exterior was one of the sharpest minds in history. His weapon wasn't a sword or fiery speeches — it was structure.

By 1787, the young United States was faltering under the Articles of Confederation. Madison, just 36 years old, steeped himself in Aristotle, Montesquieu, and Locke, then arrived at the Constitutional Convention with the Virginia Plan — a blueprint that became the backbone of the Constitution. He championed checks and balances, separation of powers, and federalism, not as abstract ideas, but as a system designed to restrain ambition itself. As he wrote in Federalist No. 51: "If men were angels, no government would be necessary."

Madison feared both tyranny and anarchy — mobs on one side, monarchs on the other. In 1792 he observed, "All men having power ought to be distrusted to a certain degree." His genius lay not in trusting men, but in designing a system to withstand their flaws.

Though Madison initially opposed a bill of rights, he later changed course. He drafted amendments that became the **Bill of Rights**, recognizing that even a brilliant structure required guardrails.

Still, Madison often stood in the shadows of Washington's gravitas, Jefferson's eloquence, and Hamilton's fire. Yet he outlasted them all. As Jefferson's Secretary of State and later as president, Madison faced the crisis he had long dreaded: war with Britain.

The War of 1812 nearly broke the nation. British troops burned Washington, D.C., including the White House. Dolley Madison famously saved Gilbert Stuart's portrait of George Washington — an artifact that truly did outlast them all. Madison, usually the frail philosopher, was the only sitting president to ride toward advancing enemy troops, though historians debate whether he came under actual fire.

In later years at Montpelier, Madison reflected on the fragility of the republic. He warned that partisan divisions could poison democracy, that ignorance was as dangerous as tyranny, and that gross inequality could threaten liberty. "Knowledge will forever govern ignorance," he wrote. "And a people who mean to be their own governors must arm themselves with the power which knowledge gives."

When he died in 1836, his last recorded advice was simple: "Cherish the Union."

Madison never claimed perfection. He knew liberty could be lost both by its abuse and by unchecked power. His true legacy was not just writing the Constitution but building a system with enough humility to survive human weakness.

Timeless Conservative Principles Worth Revisiting: The Sharon Statement

I am often asked, "What are the guiding principles by which a free society can be governed while preserving individual liberty?"

"The Sharon Statement," a short yet powerful declaration of conservative principles, was adopted by the founding members of Young Americans for Freedom (YAF) in Sharon, Connecticut, at the home of William F. Buckley Jr. in September 1960. Though originally written over six decades ago, it remains a timeless reminder for all who call themselves conservative.

I encourage you to read this statement and share it with others who may need to be reminded—or refreshed—of these enduring ideas. As the document addressed the crises of its own time, its truths may be even more relevant today.

#### The Sharon Statement

In this time of moral and political crises, it is the responsibility of the youth of America to affirm certain eternal truths. We, as young conservatives, believe: That foremost among the transcendent values is the individual's use of his God-given free will, whence derives his right to be free from the restrictions of arbitrary force; That liberty is indivisible, and that political freedom cannot long exist without economic freedom; That the purpose of government is to protect those freedoms through the preservation of internal order, the provision of national defense, and the administration of justice; That when government ventures beyond these rightful functions, it accumulates power, which tends to diminish order and liberty; That the Constitution of the United States is the best arrangement yet devised for empowering government to fulfill its proper role, while restraining it from the concentration and abuse of power; That the genius of the Constitution—the division of powers—is summed up in the clause that reserves primacy to the several states, or to the people, in those spheres not specifically delegated to the Federal government; That the market economy, allocating resources by the free play of supply and demand, is the single economic system compatible with the requirements of personal freedom and constitutional government, and that it is at the same time the most productive supplier of human needs; That when government interferes with the work of the market economy, it tends to reduce the moral and physical strength of the nation; that when it takes from one man to bestow on another, it diminishes the incentive of the first, the integrity of the second, and the moral autonomy of both; That we will be free only so long as the national sovereignty of the United States is secure; that history shows periods of freedom are rare, and can exist only when free citizens concertedly defend their rights against all enemies; That the forces of international Communism are, at present, the greatest single threat to these liberties; That the United States should stress victory over, rather than coexistence with, this menace; and That American foreign policy must be judged by this criterion: does it serve the just interests of the United States?

In conclusion, The Sharon Statement stands as a powerful testament to the core principles that define conservative thought - reminding us of the enduring importance of individual liberty, economic freedom, and the proper role of government in safeguarding both. As we confront the challenges of our time, embracing the timeless truths articulated in this document can renew our commitment to defend freedom and promote a just and prosperous society. Let us continue to uphold these values and engage in meaningful dialogue, ensuring that the ideals of The Sharon Statement endure to guide future generations.


