
DECLARATION OF MARIELLE RAMOS

I, MARIELLE RAMOS, under penalty of law, do hereby declare as follows:

1. I have personal knowledge of the following facts and am competent to testify to them.

2. I am the Elections Administrator for the County of Maui, Office of the County Clerk.
3. As noted in my previous declaration, I am very familiar with the laws and administrative rules relating to elections, and I oversee the signature verification and cure process.
4. For the 2024 General Election, the total number of deficient return envelopes remaining at the end of the cure period on November 13, 2024, at 4:30 p.m. was 939, as follows:
  - a. 803 envelopes with signatures that did not correspond with a reference signature image using the provisions of HAR §3-177-652;
  - b. 133 with no signature; and
  - c. 3 with other conditions that would not allow for the counting of the contents of the return identification envelope.
5. None of the in-person voter service centers required a matching signature in order to register to vote or vote in-person.
