

## **Elite Resumes - Client Service Agreement**

This Client Service Agreement ("Agreement") outlines the terms and conditions between you ("Client") and Elite Resumes, LLC ("Elite Resumes," "Company," "we," or "our"). By proceeding with payment, you acknowledge that you have read, understood, and agree to the terms outlined below.

#### 1. Services Offered

Elite Resumes provides customized career services including, but not limited to:

## 2. Client Responsibilities

### Clients agree to:

### 3. Project Timeline

Typical timelines vary by project type and complexity. Draft I is generally delivered within 7-14 business days after receipt of all required documentation and payment. The project is considered active for 14 calendar days following delivery of Draft I. Clients who fail to respond within this timeframe will experience delays and reactivation fees.

## 4. Revisions Policy

Each service includes up to two rounds of reasonable revisions within the 14-day project window. Additional revisions beyond scope or timeline may be billed at \$75/hour.

Revisions must align with the original project scope discussed during the introduction call.

### 5. Payment Terms

Payment is due in full prior to project commencement. Elite Resumes accepts payment via GoDaddy secure checkout, PayPal, or Venmo. A 3.5% processing fee applies to all electronic transactions. A 25% military discount is available to verified veterans or activeduty service members.

## 6. No Guarantee of Employment or Compensation
