MWCoL Antique, Vintage and More Market Days (MWCoL AV&M) is a monthly outdoor event held rain or shine unless canceled by the show director, Cindy Maness. Event will be March through December. Booth fees are to be paid by the 15th of the month prior to the show date and are non-refundable. Show hours are 10-6pm on Saturday and 10-4 on Sunday. Set up is open between 4pm and 10pm on Friday unless otherwise stated or prearranged. **Covid Guidelines as approved by the City of Mineral Wells for events must be adhered to at all times.** Vendors are required to have a Texas State Sales and Use Tax number posted at their booth. To obtain a permit go to:

It is the responsibility of the vendor to collect and report sales tax from MWCoL Antique, Vintage, and more Market Days in the name of the taxing authority of the city of Mineral Wells. You do not need a separate vendor permit/license/event from the city of Mineral Wells since you are covered under the Market Days vendor/license/event under MWCoL vendor/license/event agreement for the event days. Food vendors are required to have **AT LEAST ONE FOOD SERVER** in the booth with a Certified Food Handler. **NO alcoholic beverages will be sold on MWCoL premises.**

Booth locations are marked and numbered by tape. Vendors will be sent a map of their location. Vendors are required to use a canopy and bring their own tables. Each canopy/tent must be attached to anchors for each leg. **YOU MUST PORIVDE THE ½" EYEBOLTS. (If you forget the eyebolts, you can purchase them from MWCOL for \$8.00 each, as supplies last. NO HAMMERED OR STAKES ALLOWED.** Tables are to be draped or covered. **ALL VENDORS MUST HAVE A FIRE EXTINGUISHER IN BOOTH, REQUIRED BY MINERAL WELLS FIRE DEPARTMENT.**

BATHROOMS are on the north side of MWCoL. (located by the Caboose)

Early breakdown is prohibited before 4pm on Sunday. Security is provided Friday and Saturday nights from 7pm to 7am. the following morning. The vendor retains liability and assumes all risk of loss and/or damage on site or in connection with transportation, display, storage, and sale of merchandise at MWCoL AV&M Market Days. All vendors are responsible for the cleanup of trash from their booth area each day and at the end of the event. Trash containers are located throughout the event. Dumpsters are located on the west side of MWCoL.

Events of MWCoL AV&M Market Days, Palo Pinto County, or City of Mineral Wells and associated persons or contactors assume no liability for any reason for vendor property, merchandise or actions or vendors and their helpers, vendor merchandise or equipment that is lost or damaged due to circumstances beyond their control. Vendors agree to indemnify and hold harmless the City of Mineral Wells, Palo Pinto County, MWCoL AV&M Market Days, MWCoL, MWCoL management and associated staff, contractors and management from any and all liability.
