- 1.1. All travelers must carry a passport valid for at least 6 months post the departure date.
- 1.2. Non-U.S. passports must be accompanied by a valid U.S. visa or green card. NomadMinds bears no responsibility for lost or stolen passports.
- 1.3. Travelers must possess the required visa for each country they visit.

2. PAYMENT

- 2.1. We accept payments through PayPal and Debit/Credit cards.
- 2.2. Payment is due as outlined during the booking process. Failure to make timely payments may result in reservation cancellation.

3. CANCELLATION AND REFUND POLICIES

- 3.1. Payments are final. Not cancellations after 48 hours of purchase.
- 3.2. Refunds, if applicable, will be processed according to our specified cancellation policy minus card charges fees.
- 3.3. No refunds or adjustments will be made for any unused services such as accommodations, meals, or activities outlined in the itinerary.
- 3.4. In specific cases, subject to availability and timing, a different traveler can replace a scheduled participant for a processing fee of \$350.
