The Instructions in this email are for registering for the End Of Year Exhibition.

The End of the Year Exhibition for Gymnastics students will be on **Friday May 7 & Saturday May 8, 2021**. Friday is Tentative depending on number of students.

The sessions will run all day Saturday But your child will only participate in One session. Each session will be approximately 1 ½ hours long. Put the Dates on your calendar.

We will be allowing 3 Spectators per family in order to maintain safe distancing. This INCLUDES children. You will be able to come up and take Pictures of Your Child on the Award Stand at the end of their session. MASKS are Required for the Exhibition.

Tumble classes and Competitive Teams Do NOT Participate in the Exhibition Nor Pay the Fee.

Your child Must be Enrolled for All of May and Tuition and Exhibition Fee must be paid in Full to Sign Up or Participate in the Exhibition.

Sign Up for the End of the Year Exhibition will be done **ONLINE**.

Sign Up will be **OPEN** Monday **March 29, 2021 5:00 p.m.**

Sign Up will **CLOSE** on Sunday **April 15, 2021 at 10:00 pm**. No Late Sign Ups will be accepted.

When you Sign Up online, your child will be put on the list to Participate in the Exhibition.

If you do Not Sign up online your child Will Not participate in the Exhibition and will receive their Award the Next week at the End of their Regular Class. The last week of class is the week of May 17, 2021.

PLEASE SIGN UP IF YOU HAVE ANY PLANS TO COME. IF YOUR PLANS CHANGE AFTER SIGNING UP ONLINE YOU CAN JUST CALL OR EMAIL THE OFFICE TO LET US KNOW THAT YOUR CHILD WILL NOT BE ATTENDING.

Registration/Sign up Instruction notes will be given out Next Week at the end of class. The instructions are listed below if your note gets lost or your child misses their class.

IF you do not know the Name of your child's current class, you can Log In your account and the First page that comes up says My Schedule. It will show you your child's Class Name.

To Sign Up you should... **1.** Log In to your online account by Clicking the CLASSES, REGISTER, ENROLL Page in the Menu on the website. Scroll down and click the “LOGIN” link in **2.** For Those that are Currently Registered.

After you log in... **2.** Click on “Find Classes”. All of the Exhibition classes are listed First. (This should make it easy to find your child's DAY & CLASS NAME.)

The Class List will come up... **3.** Select the child you wish to enroll then scroll until you find the Exhibition DAY And CLASS NAME your child is enrolled in now.

Click on that Exhibition class then click “Enroll in this class”. You will have to agree to the Rules & Policies again. Click the GREEN “Enroll” at the top of the page.

Examples- Exhibition Thursday Girls Beginner, Exhibition Wednesday Preschool 4-5 year olds, Exhibition Monday Girls Intermediate.....

***If your child takes Two regular classes a week, just sign up for One of them. Your Choice which one.**

***TRANSITIONAL CLASS-** Enroll in your Beginner Girls Class.

4. You will receive an Enrollment Notification EMAIL after you enroll in the Exhibition. READ IT. It will show the Exhibition class you enrolled in. If you have made a Mistake, Email us and we will help you correct it.

5. The Exhibition **SCHEDULE** showing the Day and Time your child will come to the Exhibition will be sent to you sometime After Sign Up is Complete. It takes a long time to organize the students for the Exhibition. We hope to get the Schedule to you Two Weeks before the Exhibition.
