

WEST SHORE DOODLES HEALTH WARRANTY AND PURCHASE AGREEMENT

This contract is entered into between Jennifer Shamel (hereinafter referred to as the "Seller") and _____ (hereinafter referred to as the "Buyer").

SELLER'S REPRESENTATIONS

The following conditions apply to the sale of the above-described dog:

HEALTH WARRANTY

A warranty against genetic defects is provided for a period of two (2) years from the date of sale. Any cumulative reimbursement related to covered genetic defects shall be limited to fifty percent (50%) of the puppy's purchase price.

Covered genetic defects are limited to conditions affecting the hips, heart, elbows, and eyes.

Reimbursement for a covered genetic defect will be made only upon submission of:

- A diagnosis from a qualified veterinarian;
- A second opinion from another qualified veterinarian; and
- Proof of surgery-related expenses, if applicable.

An official OFA hip rating shall qualify as the required second opinion.

In the rare event of the puppy's death before reaching two (2) years of age, the Seller will provide a replacement puppy at no charge. A necropsy report completed by a qualified veterinarian must confirm that the cause of death was due to a genetic condition. Any shipping or transportation costs associated with the replacement puppy shall be the responsibility of the Buyer.

This warranty applies only to the original purchaser. Any transfer of ownership of the dog shall void all provisions of this warranty.

The Seller makes no guarantee that this dog will be non-shedding or that it will not cause allergic reactions.

RETURN POLICY

If the Buyer returns the puppy to the Seller within six (6) weeks of the puppy leaving the Seller's home, the Seller will make reasonable efforts to resell the puppy. Upon resale, the Buyer may receive a refund equal to the purchase price less the original deposit and a rehoming fee.

After six (6) weeks from the date the puppy leaves the Seller's home, no refunds shall be provided if the puppy is returned.

The Buyer understands that any estimates regarding the puppy's future coat type, height, and adult weight are predictions only and are based on the Seller's experience and goal of appropriately matching puppies with families.

EXCLUSIONS

This warranty does not cover viral illnesses, infections, improper bites, hernias, hypoglycemia, Giardia, or Coccidiosis.

This warranty also does not cover any illness or condition resulting from:

- Ingestion of foreign objects;
- Foods or chemicals;
- Physical injury;
- Environmental factors; or
- Conditions whose cause is unknown or cannot be conclusively determined.

Upon execution of this contract, all veterinary care and all associated costs become the sole and exclusive responsibility of the Buyer.

SPAY/NEUTER REQUIREMENT

This dog must be spayed or neutered by seven (7) months of age. Failure to comply with this requirement will void the health warranty.

Proof of spay or neuter by seven (7) months of age must accompany any request for warranty reimbursement.

This puppy is being sold strictly as a family pet and does not convey breeding rights.

If this puppy is bred, the Buyer agrees to pay the Seller ten (10) times the original purchase price of the puppy for every litter produced.

CONSIDERATION

The dog identified above is being sold for the sum of:

MAINTENANCE

The Buyer agrees to maintain this dog in good health and provide preventative veterinary care, including monthly heartworm preventative medication, as well as flea and tick prevention when seasonally appropriate.

The Buyer agrees that the dog will be housed indoors and fed a quality dog food diet. The Buyer further agrees to maintain the dog at a healthy weight.

The Buyer agrees to postpone strenuous or repetitive exercise, including activities such as agility training or running long distances, until the dog reaches a minimum of one (1) year of age.

The Buyer agrees to provide basic obedience training within the first year of ownership.

The Buyer agrees never to surrender or place this dog in a pound, animal shelter, research laboratory, or similar facility.

FULL AND FINAL AGREEMENT

The parties agree that this document represents the entire agreement between them and that no other representations, whether oral or written, have been made regarding the dog described above.

The parties further agree that no changes to this contract shall be binding upon either party unless such changes are made in writing and signed by both parties.

The Buyer acknowledges that he or she has read, fully understands, and agrees to the terms of this contract.

This contract shall be governed by and construed under the laws of the State of Michigan, with jurisdiction in Mason County, Michigan.
