PARADE GUIDELINES AND RULES for MARCHING BANDS

Thank you for your interest in the Downtown Chambersburg Christmas Parade! Months of planning go into coordinating this large-scale event that has been beloved by our community for over half a century! We are happy to present a Juried Parade with scoring and feedback available to participating band directors. To ensure that participants and attendees all have a safe and memorable evening, we have established a few guidelines that we ask you to follow...

- Santa, in any form, may NOT appear with any float/group/entry. The "real Santa" is the highlight at the end of the parade.
- Only holiday music may be played during the parade.
- Distribution of candy, flyers, or other items is prohibited.
- A prize will be awarded to the winning band in both Class A and B.
- Chambersburg Area Senior High School Band is the hometown/host marching band with the lead position in the parade and not prize eligible.
- Applications are due by 11/8/24. Mail or email accepted.
- Information regarding arrival time, parking, and staging will be emailed by Nov 20th.
