IMPORTANT:

- 1. DUE TO COVID-19, THERE WILL BE NO IN-PERSON DISTRIBUTION. All applications will be processed in a non-contact manner.
- 2. Applications must be submitted with the waiver form in order to receive pool passes. A waiver must be completed for <u>each</u> member in your household. Adults must complete a waiver for minors.
- 3. The waiver must be signed each time you use the pool. No digital signatures for the daily waiver.
- 4. Parents must download & complete & sign the waiver for teens, 13-17. No digital signature for daily waiver.
- Applications may be emailed to <u>WLA@waterslanding.org</u>, mailed to 20000 Father Hurley Blvd or dropped in the suggestion box at the office.
- 6. All passes will be mailed directly to your Waters Landing address. There will be no in-person pick-up. A "Rec Pass" is required for entrance to the Association pools. An individual's Rec Pass may be suspended for violation of the published recreation rules. Rec Passes for all residents in a home may be suspended for delinquent assessments or unresolved architectural violations. Passes will not be issued to anyone from a unit in such status. Applicants with an unusual number of "residents" may be asked for proof of the persons listed on the application: applicant who cannot or do not provide such evidence will be denied passes.

TENANTS AND NON-RESIDENT OWNERS, PLEASE NOTE:

A COPY OF THE <u>CURRENT</u> LEASE, LISTING AUTHORIZED TENANTS MUST BE PROVIDED THIS MUST BE PROVIDED TO THE ASSOCIATION EVERY POOL SEASON, NO EXCEPTIONS!!!

I agree that I will comply with all rules governing use of the Pool, including but not limited to the rules and regulations adopted by the Association and any code or regulation of any local, federal, or state governmental authority, and will use the Pool in accordance with all appropriate health and safety precautions and instructions for proper use.

Waters Landing Association, Inc. 2020 Community Swimming Pool Rules & Regulations
Pool A 20000 Father Hurley Blvd. Pool B 13501 Waters Landing Drive

The following rules and regulations govern the use of the Waters Landing Association swimming pools. Their purpose is to ensure safe and sanitary operation of pool facilities and to maximize the enjoyment by all residents. Each resident is requested to read the rules carefully; parents should be sure their children understand the rules and obey the lifeguard, who is responsible for enforcement. The Association has contracted with a professional pool management company, RSV Pools, Inc. (301-330-0073) to operate the pools. A qualified lifeguard will be on duty at all times. The pool management company maintains final discretion in enforcement of pool rules and regulations. Your cooperation with pool personnel will make the pools safe and pleasant for your enjoyment.

<u>HOURS OF OPERATION</u>: The schedule is posted separately on the Association website. *The pool will be closed temporarily when lightning or severe weather is present or approaching, and must remain closed until the storm has passed our area--as determined by the Manager. The pool may close for the day if extended storms or low temperatures are expected.*

MANAGEMENT & AUTHORITY: The pool manager, lifeguards, and staff are in charge of the facility. Being responsible for the safety of patrons and equipment, they are called on to make important decisions that users may not always agree with or like. Please cooperate with them and direct your constructive comments to the Pool Manager or Association Staff. The pool may be closed at any time due to weather or operational difficulties. The pool may also be closed if lifeguards, management, or staff determine that the pool area and facilities need to be cleaned or sanitized.

CAPACITY & SIGN IN: Capacity limitations will be imposed and posted per the current stage of pool guidelines. All residents must sign in with the pool staff to use the pool. All residents will be required to sign a daily COVID-19 waiver to use the pool.

SOCIAL DISTANCING: Residents must maintain at a six (6) foot distance from other patrons not of the same household.

<u>SUPERVISION</u>: Lifeguards are to monitor and control the overall use and conditions of the pool, not to keep an eye on individual swimmers. *All Children (members & guests) 12 years of age and under must be accompanied and supervised at all times by a responsible adult pool member 18 years of age or older.*Sitting on the edge of the pool chatting with others is not considered adequate supervision of small children using the pool. The wading pool is for children 5 years of age or younger and must be directly supervised at all times by an adult. The wading pool will be closed during the 2020 season due to COVID-19.

<u>PERSONAL RESPONSIBILITY AND WAIVER:</u> Persons using the pool area do so at their own risk and sole responsibility. The Association and the pool management assume no responsibility for any illness, accident or injury in connection with such use, or for loss or damage to personal property. The cost of any property damage will be charged to the responsible party. <u>All residents must sign a Pool Use Agreement and Waiver of Liability before being allowed in the pool area. Waivers will be available on the Association website and at the pool sign in desk. Parents will need to sign a waiver for teens, ages 13-17, to bring with them to gain admittance to the pool. Digital signatures will not be accepted for the daily waiver.</u>

<u>PASSES</u>: Each eligible resident will be issued a recreation pass. All patrons require a pass to gain entrance to both pools. Each member must present their pass & sign in prior to entering the pool facility. Passes are not left at the guard gate. Children (12 & under) must be accompanied by an adult, but require their own "child" pass. Teens (13 – 17) may come without an adult, but require their own "teen" pass. Children & Teens will NOT be permitted to enter the pool utilizing an adult pass. If recreation passes are lost, replacement passes may be obtained by contacting the Association office.

GUESTS: Guests will not be permitted during the 2020 season due to COVID-19.

ATTIRE: ALL RESIDENTS MUST WEAR FACE MASKS WHEN NOT IN THE WATER. Proper bathing attire for a family-oriented environment must be worn in the pool. Street clothes (cut-offs, t-shirts, shorts, etc.) are not proper attire and will not be permitted in the pool. In accordance with Montgomery County Department of Health codes, children in either cloth or disposable diapers must wear tight-fitting waterproof pants in the pools; disposable diapers alone do not qualify. Hair longer than shoulder length must be tied back. All patrons must shower before entering the pool.

SWIM PROFICIENCY: Any person using the main pool may be required to demonstrate swimming proficiency to the lifeguard before continued use of the pool without direct supervision.

RSV POOLS: SWIM SAFE PROGRAM

The program has the following 4 purposes:

- 1) Identify the children who cannot swim independently to assure proper guardian supervision.
- 2) Identify the children who cannot swim for easier identification of potentially dangerous situations.
- 3) Provide motivation for non-swimmers to reach a goal, producing more water safe children at each pool.
- 4) Provide recognition for children who have achieved basic swimming skills.

The program will be conducted in the following process:

- 1) Lifeguards will have all children take a swim test during designated adult swim periods of the pool operation.
- 2) The swim test will vary depending on pool size.
- 3) The basic swim test will include a swim covering the length of the pool.
- 4) Following the swim, each child will tread water for 60 seconds.
- 5) The children who successfully pass both requirements will be issued a SWIMSAFE bracelet that needs to be worn at all times the child is at the pool through the entire pool season. Children will receive their first SWIMSAFE bracelet free of charge. Replacement swim safe bracelets can be issued for a charge of \$3.00 each.
- 6) Each child passing the swim test will be recorded in a notebook.
- 7) Bracelets are not transferable. Any replacement bracelets issued will require a signed waiver by each child's guardian stating that the bracelet is for that child's use only.
- 8) A lifeguard can retest a child with a SWIMSAFE bracelet on if there is uncertainty regarding the child's ability to swim.
- 9) Children who cannot pass the swim test will be allowed in the pool with an adult guardian in the pool within arms' reach of the child per county requirement.

This program will require flexibility and patience from parents.

DIVING BOARD: The diving board and diving well will be closed during the 2020 season.

<u>FLOATATION EQUIPMENT/TOYS</u>: US Coast Guard approved life jackets & water wings may be used in the pools at the Lifeguard's discretion, as long as an adult is within arms' length of the child. No play equipment will be allowed. No inner tubes or rafts allowed. Absolutely no floatation devices allowed in the well.

ADULT SWIM PERIOD: To be determined.

FURNITURE: There will be no furniture provided by the Association during the 2020 season. No furniture may be moved from the locations they are placed by the Association.

<u>REFRESHMENTS & TRASH/RECYCLING:</u> Please feel free to bring your own NON-ALCOHOLIC refreshments; however, glass containers are prohibited items. Please place trash & recyclables in the appropriate containers. NO food may be brought into the pool area.

<u>DISTURBANCES</u>: Running, pushing, wrestling and other horseplay pose an unacceptable safety hazard and cannot be tolerated. Undue disturbances, including but not limited to, loud music that detract from the enjoyment of the facility by other patrons are prohibited. Members may be asked to cease, directed to take a short "time out" or to leave for the day.
