Regarding your question about parking in the neighborhood, hunters may park only in designated areas within the park and no hunting is permitted on the eastern shore side of the park directly adjacent to the Waters Landing neighborhood.

Applications for architectural changes can be found on the Association website or at the Association office. Please follow instructions carefully. Failure to follow instructions in completing your application may result in your application being returned to you or the application being disapproved.

Any date that falls on a weekend, deadline would be pushed to the following Monday.

Bulk items are collected on Thursdays. Requests for bulk pick-up may be made by calling J & J Inc. at 1-800-465-2350.

## Recycling

Recycling is a Montgomery County contract. Montgomery County will not collect materials not designated for recycling and that are not properly recycled. Collection day for recycling is Monday. Recycling should be placed at the curb on Sunday evening, after dark, or Monday morning by 7:00a.m. Recyclables and recycling containers are not to be left out at any other time of the week.
