NEIGHBORHOOD NOTES

Waterbury Downs South

 There continues to be a drainage issue due to a private property pipe. If you notice low water pressure or your water bill is higher than normal, you should contact a plumber.

Waterbury Downs North

- Pets left outdoors for long periods of time and barking, is a violation of the noise ordinance law. Please be mindful of the law and respectful of your neighbors.
- Vehicle maintenance in not allowed in the parking lot.
- Residents are parking their motorcycle in unassigned parking spaces, along with their vehicle, which prevents others from parking in the parking space. This is not allowed.

Lakecrest

 Evictions: When an eviction takes place, items are dumped on the nearest county road, which is Waters Landing. It is the responsibility of the landlord who requested the eviction to remove the items from the dumped sidewalk within 24 hours. If items are not collected, the Association assumes the responsibility to remove items.

- Rodents caused damaged to a resident's car. Please be mindful of trash being placed outside of trash pickup days.
- Residents parking improperly, which prevents others from parking.


SCHOOL BUS SAFETY
