

2022 Waters Landing Association, Inc. Recreation Pass Application Form

1. *There will be no in-person distribution.*
2. *Applications may be emailed to WLA@waterslanding.org (WLA@waterslanding.org), mailed to 20000 Father Hurley Blvd or dropped in the suggestion box at the office.*
3. *Prior to May 25th, passes will mailed. After May 25th, passes will be available at Pool A for pickup.*
4. *Applications must be received by 2 p.m. in order to be processed for next business day pickup.*

No weekend pick-up. EXAMPLE

<i>Before 2 p.m. Monday</i>	<i>Pick-Up Tuesday</i>
<i>After 2 p.m. Monday</i>	<i>Pick-Up Wednesday</i>

A "Rec Pass" is **required** for entrance to the Association pools. An individual's Rec Pass may be suspended for violation of the published recreation rules. Rec Passes for all residents in a home may be suspended for delinquent assessments or unresolved architectural violations. Passes will not be issued to anyone from a unit in such status. Applicants with an unusual number of "residents" may be asked for proof of the persons listed on the application: applicant who cannot or do not provide such evidence will be denied passes.

A COPY OF THE CURRENT LEASE, LISTING AUTHORIZED TENANTS MUST BE PROVIDED.
THIS MUST BE PROVIDED TO THE ASSOCIATION EVERY POOL SEASON, NO EXCEPTIONS.

Due to capacity limits of the pools, passes may be issued to owners or their tenants, but not both.
