## Adult Waiver Student Contract

Safe Road Driving Academy, LLC agrees to provide the following: Fourteen (14) sessions of Behind the Wheel instruction, which consists of seven (7) 50-minute periods of driving and seven (7) 50-minute periods of observation. Each session is 1 hour and 40 minutes in length. Final session will include the DMV "road skills test" for eligible students.

Student agrees to pay all fees in full prior to training. (Cash, Check, Credit/Debit Card, PayPal)

Student must provide evidence of successful completion of a state approved classroom drivers ed program

### DMV POLICIES:

- Adult students over the age eighteen (18) years are required by the State of Virginia to successfully complete a 36-period minimum, state approved classroom driver's education program. Additionally, the requirements for Behind the Wheel are fourteen (14) fifty (50) minute periods of which seven (7) periods are spent driving and seven (7) periods are spent observing.
- The instruction provided by this school does not guarantee that any student will pass the state license examination or that the student can secure a driver's license, or the student will be guaranteed employment upon completion of the course.
- A full or partial refund, depending on the number of hours completed, will be made upon request only if this school is incapable of or unwilling to perform its part of this agreement within 120 days of registration.
- Student has permission from parents if under eighteen or gives permission if he/she is older than eighteen, to receive one on one training with an instructor. The student is required to meet the observation requirements with at least one other student in the vehicle during in-car vehicle training.
- Students eighteen (18) years of age and older may hold the learner's permit for 60 days in lieu of completing a driver's training.

### The School and the Student/Parent/Guardian agree to the following terms and conditions:

- Full payment is due at or prior to the first session
- There is a **\$35.00** fee for returned checks.
- Behind the Wheel instruction is conducted by appointment only and the Student will be charged a **\$25.00** service charge for any appointment he/she does not meet, unless the school is given at least 24 hours of notice.
- No Certificate for Completion will be issued until all fees have been PAID IN FULL.
- The School will not refund any monies or any part thereof when actual services have been rendered.
- The School will complete the course in a reasonable length of time. However, it cannot be held responsible for delays caused by mechanical failure, unsafe driving conditions due to weather, or any other reason over which it has no control.
- The School will give the Student as much notice as possible if any delay becomes necessary (or foreseen).
- The School will notify the Student in the event the School cancels classes. Cancelled classes will be made up at the end of the course.
- Student is fully accountable for their conduct. They can be dismissed from the course for misbehavior without refund.
- No food, drink, smoking, or sleeping and cell phones must be turned off.
- A **\$25.00** fee will be charged for replacement of lost certificates.

- The School agrees to exert its best efforts in teaching the Student to meet the requirements of the examinations. However, there is no guarantee the student will pass the DMV road test, secure a drivers license or be granted employment at the conclusion for this course.
- Under this Agreement, an Instructor may not provide Behind the Wheel training to more than 3 students and no less than 2 students.
- The fees set out herein are guaranteed for ninety (90) days from the date of this contract.
- The Student understands that certain hazards and risks are inherent in the operation of motor vehicles.
- The Student does hereby specifically assume all risks as may be incurred in the normal operation of a motor vehicle during the course instruction. All vehicles are fully covered with Liability Insurance.
- It should be emphasized that successful completion of a Behind the Wheel course does not and should not imply that the Student is a safe accomplished driver. During the course, students are instructed in the basic skills necessary for the safe operation of a motor vehicle. However, as with any skill, it is only with repeated practice that the skill is developed and perfected.
- It is the responsibility of the student or in case of a minor, the parent/guardian to report to the Department of Motor Vehicles of any concerns regarding the School, instructor behavior or quality of instruction at the School. DMV is committed to promoting transportation safety through the certification of quality driver training programs.
