Our core members, Bob, and Jack, have extensive experience working on major contracts, employing many types and backgrounds of employees, and government classified projects.

Some of the major contracts have been:

• The Pentagon Renovation Program:

The utilization of an innovative design and build approach. The reconstruction of the Pentagon (named Project Phoenix) enabled this complex and extremely sensitive project to be completed in less than 1 year at a savings of over \$246 million dollars. Our government was not only thankful but deeply touched by which the entire project was handled. Our successful efforts were lauded by the passing of House Resolution 368 by the 107th Congress of the United States.

• J.W. Marriott:

Resolving resurfacing conditions within the construction of the J.W. Marriott in Washington D.C. We developed a slurry wall foundation system thereby the contract was completed 5 months earlier than projected and within budget.

• Military Family Housing:

In order to support an ambitious schedule, we devised and implemented a unique Panelized Framing System for the military family housing project in Columbus, Mississippi. The development of this process doubled the house framing production rate. The project finished well within its schedule and budget.

• Federal Aviation Administration:

Both budget and schedule were threatened by the need to remove significant quantities of rock, to support FAA facility guidelines in Dubois, Pennsylvania. We developed an innovative Rock Anchoring System for the facility's foundation. Thus, avoiding costly rock removal and scheduling delays.
