# **Executive Director Report for June 2025**

# **Legislative/Policy Work**

- Organic Dairy Assistance, Investment, and Reporting Yields Act of 2023 (O DAIRY Act of 2023) – Senate Bill 3097
- 2. "The Organic Dairy Data Collection Act" House Bill 6937
- 3. Fiscal year 2026 spending bills
  - a. White House proposal includes \$6.7 billion reduction in discretionary USDA programs
- House Republicans passed a significant budget package through the Reconciliation process
  - a. Includes tax changes, increased funding for military and border security and some ag programs, while proposing cuts to safety- net programs like Medicaid and Supplemental Nutrition Assistance Program (SNAP) and some green tax incentives
  - b. This bill must still pass through the Senate, where Republicans are expected to make further changes, aiming for presidential approval by June or July
  - c. This House budget bill includes funding for Organic Certification Cost Share Program, Organic Transition Initiative, Organic Data Initiative

#### 5. USDA updates:

- a. Dudley Hoskins was confirmed as Undersecretary of Agriculture
- b. Dr. Jenny Tucker returned to the NOP
- c. Organic Market Development Grants existing contracts are being honored
- 6. Proposed Rescission of Mushroom and Pet Food Rule
  - a. Removes the regulatory foundation needed to allow the market to grow
  - The potential for organic livestock producers and other businesses to access organic pet food markets – particularly for slaughter by products- will remain out of reach

#### 7. FMMO Update

- a. Members of the Coalition for Organic Dairy Exemption late last week filed 15A petitions with the U.S. Department of Agriculture (USDA) seeking to exempt organic dairy from the Federal Milk Marketing Order (FMMO) Program.
- b. Coalition Members include Organic Valley, Horizon and Aurora.
- c. Petition attached for review.
