Legislative/Policy Work

- 1. ODMAP payments should be out (including initial payments & top up).
- Organic Dairy Assistance, Investment, and Reporting Yields Act of 2023 (O DAIRY Act of 2023) Senate Bill 3097
 - 1. Some parts have been included in the Farm Bill proposals
- 3. "The Organic Dairy Data Collection Act" House Bill 6937
 - 1. Full proposal text included in current Farm Bill proposals
- 4. Elections/ Appointments:
 - 1. Nominations update
 - i. Brooke Rollins has officially been sworn in as our Secretary of Agriculture.
 - 2. Farm Bill update
 - Federal government to remain running at 2024 levels through March 14, 2025
 - ii. Farm Bill extended one year (set to expire September 30, 2025)
 - iii. No funding for "orphan programs" including organic certification costshare, the Organic Data Initiative and the Organic Certification Trade & Tracking Program
 - iv. Final 2025 appropriations package is now due to be completed by March 14th
 - v. 2026 appropriations package is due September 30th
- 5. Implemented Tariffs
 - Canada: 25% tariffs on all goods, except for energy and energy resources, which will face 10% tariffs
 - 2. Mexico: 25% tariffs on all goods
 - 3. China: 10% tariffs on all goods and elimination of de minimis exemptions
 - 4. Mexico & Canada tariffs are paused for 30 days (through March 3rd)
