Origin of Livestock: Public Comments Needed

The USDA is now accepting public comment on the Origin of Livestock (OOL) proposed rule. Take action by submitting a unique comment to the USDA via the federal register (www.regulations.gov/document?D=AMS-NOP-11-0009-1572). The deadline to submit comments is **December 2, 2019**.

Organic stakeholders need to speak with a unified voice to demand that the USDA finalize the proposed rule to ensure a level playing field for organic dairy producers and to protect organic integrity.

As some of you have heard, both the House and the Senate Congressional Appropriations Committees passed identical verbiage in regard to Origin of Livestock (OOL). OOL will move forward toward the final bill, probably in the next six to 12 months. Not exactly what we wanted, as sooner would be better. But nevertheless, a final rule will help level the playing field for organic dairy.

All organic dairymen and our allied industry will need to submit new comments on the OOL in response to NOP reopening a 60-day comment period. Please see WODPA's newsletter for information to assist any and all making comments. Looking back to 2015, 99 percent of the approximately 1,500 comments submitted were positive and supported the proposed OOL rule. **Those comments will be considered**, along with the newly submitted comments, as we look toward a final rule in 2019.

More great news! WODPA's 2019 Annual Conference and Trade Show is planned for November 19 and 20, 2019 at the Nugget in Sparks, Nevada. Our annual conference is a great place to expand your knowledge, network and connect with fellow producers, and organic milk allied industry members. NATIONAL ORGANIC STANDARDS BOARD (NOSB) FALL MEETING: UPDATE

The National Organic Standards Board Fall meeting just wrapped up in Pittsburg, PA. Prior to the meeting, WODPA provided comments to the board. Comments highlighted:

- The challenging and uncertain times for organic dairy farmers and their families.
- Urging USDA to move as quickly as possible on amending the Origin of Livestock (OOL) rule.
- The need to uphold the organic label to ensure consumer trust.
- Restore fairness including effective enforcement of organic pasture rules, consistency across certifying agencies, updated OOL rules, NOP transparency with enforcement, and continued monitoring of high-risk operations
- The relisting of substances used in livestock production were recommended for relisting
- The need to continue to have access to preventative tools for the health and welfare of our animals.

Unsure what to include in your comments? Below are a few suggestions crafted by WODPA's Policy Consultant, Jill Smith.

- *Include information about your personal farming situation.* Unique comments that include details about how this proposed rule impacts your farm, company, organization, and/or your stakeholders are the most meaningful. Include any personal details regarding the reasons you support the proposed rule.
- *Discuss how the market has been distorted by those who continuously cycle dairy animals in and out of organic management.* We've seen rapid expansion of cow numbers, larger operations with lower production costs, and an economic disadvantage for organic farmers who are complying with the intent of the organic regulations.
- *A final rule can help level the 'playing field' for all in the organic dairy industry.* With a finalized rule, this will create more consistency across certifying agencies, not leaving rules open to interpretation by certifiers.

As organic dairy farmers, we need to ensure the integrity of the organic seal. We must ensure our organic consumers that organic rules are being followed and enforced. When we chose to be organic producers, we chose to follow organic rules. We must hold everyone to the same standards for the sake of the organic production community and for the sake of our consumers.

A final rule with immediate implementation is needed! More information about how to submit a public comment to the USDA can be found on WOPDA's website.

Only western organic dairy producers can vote, only one vote per active dairy. Any dairyman wanting to cast a proxy vote must have attended at least one day of the

conference. If a State Representative moves into an Officer position, their vacated position will become available for election. She also supported an appropriations bill that directly addressed the Origin of Livestock issue.

There are times when members of Congress and the Senate can be helpful and very effective. But it takes us, the citizens, to meet with them and ask them to act on our behalf.

Each one of us should know who our representatives are in Washington, DC and feel comfortable enough to send them an email or place a phone call whenever there is an issue that impacts our industry.

So, when WODPA puts out a "Call to Action," I encourage you to be part of the change for our industry. Tell your story. Make your voice heard. It's important!

- Support for continued evaluation of vaccines utilized in organic livestock production (without promoting the use of GMI vaccines) yet acknowledging the need for vaccines using excluded methods.

WODPA's full written testimony can be found on WOPDA's webpage.

WODPA also provided oral comments directly to NOSB. These comments focused on the immediate finalizing and implementation of the OOL rule. The organic dairy sector has come together to present a united front to the USDA NOP and asked for the proposed rule to be put in place as soon as possible.

The National Organic Coalition hosted a pre-NOSB meeting. WODPA participated on the Farmer Panel as well as led a round table discussion on the economic impacts of OLL and other organic regulations.
