



- Organic Dairy Assistance, Investment, and Reporting Yields Act of 2023 (O DAIRY Act)

Organic Dairy Assistance, Investment, and Reporting Yields Act of 2023 (O DAIRY Act)

- Senate Bill 3097
- Improved Data Collection
- Extension of ELAP
- Safety Net Program for Organic Dairy
- Investments in organic Dairy Processing infrastructure

The Organic Dairy Data Collection Act

- House Bill 6937
- Improved data collection for organic dairy

Withstanding Extreme Agricultural Threats by Harvesting Economic Resilience (WEATHER) Act

- Senate Bill 3401
- Development of an index-based insurance policy that would better support farmers facing income losses after extreme weather events
- Reduces administrative hurdles and ensures that insurance payouts are based on ag income losses

Converting Our Waste Sustainably (COWS) Act

- Senate Bill 2479
- Establishes an alternative manure management program
- Awards producers contracts to support carbon sequestration and greenhouse gas emissions reductions
- USDA may provide 100% federal cost share up to \$825,000 every 5 years

“Orphan Programs”



- **Organic Cost Share Program**
 - aids in obtaining and renewing organic certification – up to 75% or \$750 per scope
- **Organic Data Initiative**
 - collects info to maintain stable markets, create risk management tools, and assist in negotiating equivalency agreements with foreign governments
- **Organic Certification Trade & Tracking Program**
 - fraud prevention; this has mandatory funding but ends after 2024

Organic Dairy Marketing Assistance Program (ODMAP)

- Program aims to offset marketing costs incurred in 2024
- First launched in 2023 with \$104 million allocated
 - \$58 million remaining as of program relaunch on 9/26
- Program improvements for 2024 include:
 - increased payment rate \$1.68 per cwt
 - Production cap increased to 9 million lbs.
 - Initial amount paid out is 75% of \$1.68
 - If money remains after application deadline, the remaining 25% will be automatically distributed

Application deadline was just extended to December 13th.

Organic Dairy Marketing Assistance Program (ODMAP)

- Apply at your local FSA Office
 - EVERYONE needs to re-apply this year
 - Applications are open until November 29th
 - To apply, you will need your 2023 production, proof of organic certification and a completed application form

Organic Dairy Product Promotion (ODPP)

- Allocated \$15 million to expand access to organic dairy products in educational institutions and youth programs
- The program will help children and young adults access organic dairy products while also creating new markets for small and mid-sized organic dairy farmers

New NOP rule - OLPS

- Organic Livestock and Poultry Production Standards (OLPS) Rule
 - Full compliance date: January 2, 2025
 - Link: [Federal Register :: National Organic Program \(NOP\); Organic Livestock and Poultry Standards](#)
 - Prohibiting certain physical alterations (wattling, tail docking, face branding)
 - Lameness monitoring, management and treatment
 - Euthanasia requirements have been added to ensure prompt, humane and effective plans and methods are documented and used
 - Parasite control is now formally required
 - Requirements have been added for what sufficient shelter:
 - Animals have sufficient space & ability to express normal behavior patterns
 - Youngstock can be housed individually until weaned but must be designed so animals can hear, see and smell each other.

OLPS continued

➤ New requirements for transportation:

- Organic livestock must be clearly identified as organic, and their identity must be traceable for the duration of transport.
- Fit for transport; calves must have a dry naval cord and be able to walk on their own
- For transport that exceeds 8 hours, operation must describe how animal welfare and organic management was maintained.

Impacts of SOE

SOE = Strengthening Organic Enforcement Rule

- Compliance Date: March 19, 2024
- Harsher requirements for certifiers and accreditation requirements
- Increased the entities who need to be organically certified
- Increased the amount of traceability paperwork and record keeping


