



Affidavit of Fact

Vaccination Exemption

1. It is fair and just to protect oneself against and person, group, organization, or entity that attempts to violate rights and force covid tests and or vaccinations.
9. I reserve the right to freedom of movement, freedom from not being detained, freedom from unlaw imprisonment, freedom from not bring forced into quarantined.
10. Any attempt to detain me or force vaccinations upon me or my family is a violation of privacy rights, assault, inhumane treatment, attempted murder and or manslaughter, murder, and or kidnapping. All lawful charges apply.
