RESOLUTION # 7E-22-007
ANC 7E Resolution Regarding the Establishment of an Infrastructure and Transportation Committee

WHEREAS, Advisory Neighborhood Commission 7E sees the need for a more resilient economy for the long-term investment, and that means investing in a modern, sustainable infrastructure and sustainable engines of growth-from roads to bridges. Traffic safety issues as well as policy and infrastructure have a significant impact on our residential neighborhoods and business districts. With the involvement of knowledgeable, experienced, and engaged community members it increases the likelihood of a resolution which will help facilitate a more vibrant and safe neighborhood which is vital to the success of family, personal, commercial and community life. By examining traffic safety issues as well as policy and infrastructure and providing recommendations for how they need to be addressed we have an opportunity to help shape the future of our Advisory Neighborhood Commission 7E.

BE IT RESOLVED:

I. Charge of the Committee

1. The Committee on Transportation and Infrastructure shall advise Advisory Neighborhood Commission 7E on all issues relating to transportation, policy, and infrastructure.
2. The Committee shall advocate for modern, multimodal transportation policy that serves BOTH Ward 7 residents and commuters. The Committee shall ensure that all projects conform to the multimodal policies put in the MOVE DC Plan, Vision Zero, Build Back Better, and Ready DC.
3. The Committee shall coordinate with neighboring Advisory Neighborhood Commissions on transportation issues.
4. The Committee shall communicate directly with representatives from the District of Department of Transportation (DDOT), Washington Metropolitan Area Transit Authority (WMATA), Metropolitan Police Department (MPD), The DC Mayor’s Office, Offices of the DC Council Members, and relevant Federal Agencies. The Committee shall serve as a primary point of contact on transportation issues for the commission.
5. The Committee shall establish a communications and outreach strategy, and will provide regular updates at community associations. The committee shall receive feedback from the associations and use it shape their discussions. Representatives to this Committee can bring forth concerns/issues and reports back/update any other group as necessary.

6. The Committee shall meet monthly to perform its duties. It shall meet no less than four times a year.
7. The Committee shall draft monthly reports to the Commission that may include the following: a description of the manner in which the committee undertook its charge, facts uncovered or information obtained the committees' findings or conclusions and a resolution or recommendation to the Commission. The committee's report shall be placed on the agenda for the first ANC meeting after they are drafted.
8. The Committee shall have the right to request the ANC 7E Chair to make special meetings of the ANC or the ANC Executive Committee.
9. Committee members shall disclose any conflicts of interests and recuse themselves in cases which they may personally gain from an ANC decision.

II. Composition of the Committee

1. The Committee shall have up to eleven members appointed by the Commission. At least one member shall be an Advisory Neighborhood Commissioner; all efforts shall be made to ensure a second shall be a young person aged 16-24. No more than three members may be from a particular Single Member District. All residents of ANC 7E are eligible to serve on a committee. It shall be a goal of the Commission to ensure a diversity of membership amongst the committee including transportation mode and demographics.
2. Committee members shall serve for one year, and may be renewed multiple times. Standing committee memberships are reviewed at a public duly noticed ANC meeting.
3. The Committee shall have a Chair and a Vice Chair. The Chair shall be advisory neighborhood commissioner. The Vice Chair shall be elected by the committee. The terms of all committee officers are one year. They may be renewed multiple times. The Committee Chair schedules and conducts committee meeting. If the Committee Chair shall transfer a copy of all committee records to the ANC Secretary each month.
4. Candidates must provide proof of residence. Candidates may self nominate for a committee Interested nominees should provide a short written statement explaining their interest in the topic area as well as any relevant experience, knowledge or credentials.
5. In the event of a vacancy, the ANC may nominate replacement numbers at their next public meeting. A committee member's position is vacant if the member provides written notice of their vacancy to the Chair of the ANC, is deceased, or has failed to attend three consecutive meetings.
6. Anything not set forth in these rules revert to Robert's Rules of Order.
