I acknowledge and agree to the following:

Assumption of Risk & Liability Waiver

I understand that participation in a painting event involves the use of art materials, studio furniture, tools, and shared spaces, which may involve inherent risks, including but not limited to slips, falls, spills, allergic reactions, or minor injuries.

I voluntarily assume all risks associated with participation for myself and, if applicable, for all members of my group.

I hereby release, waive, and hold harmless **Meme Mugs & Memories**, its owners, employees, contractors, and representatives from any and all claims, injuries, damages, or liabilities arising from participation in the event, including those resulting from negligence, to the fullest extent permitted by law.

Photo & Video Release

I grant **Meme Mugs & Memories** permission to photograph and/or record video of me and, if applicable, members of my group and minors during the event.

These images and recordings may be used for lawful business purposes, including website content, social media, marketing, and advertising (digital or print).

I understand that no compensation will be provided and waive any right to inspect or approve the final materials. This release remains valid indefinitely unless revoked in writing.

BYOB Policy

- Guests may bring their own beverages in accordance with studio rules and local laws.
 - Alcohol is **not provided** by **Meme Mugs & Memories**.
 - Guests providing and/or consuming alcohol must be **21+** and agree to drink responsibly.
 - **Meme Mugs & Memories** is not responsible for incidents, injuries, or damages related to alcohol consumption.
 - The studio will not allow anyone to be unsafe or present disruptive behavior **Meme Mugs & Memories** reserves the right to remove anyone from its studio/event.

Booking & Payment

- A **50% non-refundable deposit** is required to secure your event date.
- The remaining balance is due **48 hours prior** to the scheduled event.
- Bookings are not confirmed until payment is received.

Cancellations, Refunds & No-Shows

- Cancellations made **10 or more days** before the event receive a **full refund**.
- Cancellations made **less than 10 days** before the event are **non-refundable**.
- One reschedule is allowed if requested within 10 days of the event and must occur within **60 days** of the original date.
- No-shows are **non-refundable** and cannot be credited toward a future event.

Guest Responsibility & Disclaimers

- **Personal Belongings:** The studio is not responsible for lost, damaged, or paint-stained personal items.
- **Allergies/Sensitivities:** Non-toxic materials are used; guests are responsible for managing any allergies, sensitivities, or medical conditions.
- **Unforeseen Circumstances:** Events affected by severe weather, power outages, or emergencies will follow the studio's rescheduling policy.
- **Unclaimed Artwork:** Artwork left more than **15 days** after the event will be discarded. Shipping may be arranged at the guest's expense.
