

About the American Rescue Plan Act

A Brief Background

In May 2021, the U.S. Department of the Treasury announced the launch of the Coronavirus State and Local Fiscal Recovery Funds, established by the American Rescue Plan Act of 2021, to provide \$350 billion in emergency funding for eligible state, local, territorial, and Tribal governments.



\$350 Billion Distribution



\$195 billion

to states, distributed based on each state's share of *unemployed* people after an initial allotment of \$500 million per state



\$65 billion

to counties, distributed based on each county's share of the general population



\$65 billion

to municipalities, distributed using the Community Development Block Grant formula, which considers a variety of measures largely focused on population, poverty, and housing overcrowding



\$20 billion

to tribal governments, distributed primarily using a method that the Secretary of the Treasury will determine




\$4.5 billion

to other U.S. territories

The American Rescue Plan Act

- Bolster agencies' response to the COVID-19 emergency and its economic impacts;
- Replace lost public sector revenue to strengthen support for vital public services and help retain jobs;
- Support immediate economic stabilization for households and businesses
- Lay the foundation to rebuild for a prosperous future


Timeline



Who is Eligible?

The funds provide substantial flexibility for each jurisdiction to meet local needs—including support for households, small businesses, impacted industries, essential workers, and the communities hardest-hit by the pandemic.

Four Eligible Categories

#1) ECONOMIC DEVELOPMENT & PUBLIC HEALTH

- to support small business, deliver assistance to workers and families
- to reach people with particularly significant barriers to
 accessing support, including immigrants and people of color with low incomes
- investments in housing and neighborhoods
- to respond to the pandemic and its negative economic impacts
- funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and public health

#2) PUBLIC SECTOR REVENUE

- targets schools, child care, and housing to avoid additional layoffs and funding cuts
- restore jobs and public services lost over the last year

#3) PREMIUM PAY TO ESSENTIAL WORKERS

• The term 'premium pay' means an amount of up to \$13 per hour that is paid to an eligible worker, for all work performed during the COVID–19 public health emergency.

#4) INFRASTRUCTURE

• invest in water, sewer, or broadband infrastructure.






How to Find Funding & Apply:

Preferred applications will seek to create:


- Catalytic projects with a strong local impact.



The County will grant \$1,200 per household to families where childcare is a barrier to employment. The grant is limited to 1,000 households who qualify at up to 300% of the U.S. federal poverty guidelines or meet Oakland County Michigan Works! Agency's Workforce Innovation and Opportunity Act Dislocated Worker, Adult, or Youth Program Eligibility guidelines.



Get Organized: Facts & Figures

For Individuals or Families

IMPORTANT DOCUMENTS & PERSONAL STATEMENTS

- Verification of identity and residency in City/ County.
- Information describing the applicant's financial situation and need proof of income/bank statements.
- Documentation demonstrating that the applicant meets the eligibility criteria.
- Attestation from the applicant as to the planned use of funds.



For Small Business Owners/ Developers

PROJECT PLANNING

- Feasibility
- Promote economic growth
- Timeline
- Business Plan
- Budget
- Indicate loss of revenue

How to Submit a Successful Application

- Read the priorities
- Align with the agency's guidelines
- Follow instructions
- Draft your application in advance
- Submit the first round (you can reapply if you get denied in the second round)
- Don't miss the deadline
