Women NICs and Voter Registration Campaign

Details of Activities and Achievements (2019-2020)

Overall Progress of the Project & Impacts- support with the help of numbers, volunteers' engagements, improved the status of NIC and voter registration of women. how your objectives and interventions contributed in overall results

Through this project, SCI has managed to achieve a remarkable breakthrough in terms of giving identity to 21772 out of identification/listed by team SCI 32162 unregistered women in the District Vehari & Pakpattan through NIC registration and Civic and voter education. This will surely lead to reduced gap of female's voters in the both districts. Ensure the voting on election day also educate women for importance of vote and NIC in selected Census Blocks/villages, through community meeting/Mobilization session to orient on NIC important, NIC registration and Voter education.

Coordination Meeting with Key Stakeholders also played key role in smooth implementation & success in Phase III and Extension with ECP & NADRA to sort out registration issue and build relationship in Joint Coordination Meetings, decided working hours to increase more facilitation also avoid any unconvinced, Role of Zonal Head of region Vehari and Pakpattan Mr. Manzoor ul Haq & Mr. Shoaib Ghauri most important stakeholder District Election Commissioners of both Districts very appreciate able because they take action on serious field related issue also instructed to related center in charge to increase facilitation number. Tehsil level Meeting with NADRA Official also held with help of ECP to coordinate with NADRA. Methodology follow accordingly NADRA officer guide/support us how many females SCI allow forward towards NRC center Vehari Tehsil, Burewala Tehsil, Arifwala, Pakpattan for fresh registration of NIC. Through this project SCI able to register 21772 unregistered women for new NIC through SCI Facilitation at NRC & MRVs.

SCI Team start mobilization campaign with help of local activist/volunteer to aware and list down Women not having NICs and unregistered voters. Women have been mapped out from more than 270 Census Blocks 184 Census Blocks of District Vehari and 87 Census Blocks of Pakpattan. This was done in consultation with local community activists/volunteers to enlist women from village to village, door to door visit, mobilization support is being taken from already available resource persons'/ community activists of SCI. During the project period 32162 unregistered females are listed for fresh NIC registration. Social mobilization team started community meeting/corner meeting/ social mobilization meeting in each community to orient them on project and aware them on project and process of NIC registration and voter registration. SCI team mobilize more than 24741 women/men during different session with local community women without NIC also list down for fresh registration and their details have been documented from 270 Census Blocks.

Under this Project consultation meeting with key stockholders of project to orient them on project purpose & objective. Project activities and their role in effected implementation of project. SCI start Voter Education, NIC registration, WNVR campaign through IEC Material Distribution with females & males in targets area, in colleges and other institutions' team Mobilize and Facilitate Women's for NIC Registration – in NADRA NRC Office Vehari. Have organized meetings with heads and session with youth to aware them how low NIC & Voter registration will efforts their

development funds. Information spread in all over district to highlight this public campaign, giving message to more people living without Identity.

During the project implementation, also gets benefits from TDEA team's efforts after received email/instruction for Joint Coordination Meeting with NADRA/ECP for discuss issue and solve problems of selected NRC, it's really help to increase number of registration specially on NRCs SCI team have move more than 35 to 50 on this day in each NRC to achieve maximum targets help us to promote campaign. Throughout project the community support remained positive, Volunteer are backbone of this project really help in listing and moving females on NRC from village to village. Other stakeholders such as NADRA official, local notables also remained very supportive and actively engaged in project activities. The role of ECP, NADRA team remained very positive and supportive throughout the project life.

Month of March 25, 2020 was last day for facilitation with deadline to achieve target for facilitation but due to Corona Virus wave Covid-19 effects progress in start of March and after getting dangerous NADRA close operation for better interest of Nation also make restriction to achieve targets, before this Corona Wave Team working with new spirit to obtain remaining facilitate for unregistered women from listed area on peak. March, 2020 to work hard with good team work, but bad luck heavy rain almost first week and second week effects registration also, Mission is not achieving on remaining target mission is to give identity to unregistered women as a Pakistan. With technical support of TDEA team achieving maximum target of registration with work hard for smooth implementation and facilitation for unregistered women all the month with kind support of ECP/NADRA, infect TDEA team help us to solves issue faced in field or at NRCs/MRVs of During the reporting month of March, 2020. SCI team facilitate of unregistered women at four MRV each in each tehsil including Pakpattan and NRC centers in all over in both districts after listing of unregistered women from selected census Blocks/village to village.

Joint meetings with NADRA and ECP (MRV/ NRC) for finalizing work plans (in support of above mentioned number please provide text)

ECP/NADRA with technical Support of TDEA start a Great Initiative Joint Coordination Meeting with Key Stakeholder of Project, District Election Commissioner & Deputy Director NADRA Zone & Partner organization to minimize issues and coordination gap faced in district wise.

In a detail of Coordination meeting all activities shared with ECP/NADRA staff. District Election Commissioner vetted the list provided by TDEA Partner and share with NADRA to facilitated in coming week after Coordination meeting. ECP Official Decided Joint Coordination take place on DEC Office on every 1st and 15th of each month to discuss issues and Main Key Stakeholder of Project was DEC, achievement of project due his special support and technical help. Both DEC, Pakpattan & Vehari give special importance to this campaign and take action if SCI staff face issue in field regarding work. Coordination with NADRA and provision of MRV also due to both DEC. DEC organized fifteen days meeting and share problem and achievement with each other.

Community Meetings

SCI Team started mobilization campaign with help of local activist/volunteer to aware and list down Women not having NICs and unregistered voters. During listing campaign at village level SCI team also conduct mobilization sessions for women to orient them about project and importance of NIC & Vote registration.

SCI Vehari organized Mobilization session with female to orient them about importance of NIC.

In this session key message deliver are following:

- SCI staff shared detail information about NIC & voter registration after detail introduction of SCI
- SCI staff informed women about Facilitation process at MRV camp & NRC visit
- Advantage and disadvantage of having NIC also brief them
- Right to Vote and power of Vote
- SCI staff oriented them about project objective and goal

This was done by local community activists/volunteers to organized female and guide them about registration process. Listing of unregistered women from village to village also a part of mobilization session, mobilization support is being taken from already available resource people's/ community activists of SCI. During Project Duration SCI team 9460 females and 428 males and 16 transgender Mobilized and listed for fresh NIC registration. Community encourage the initiative of SCI towards important problem of their life having not NIC. Community notable also appreciate voter education part of project.

During the project implementation, the community support remained positive. The role of ECP, NADRA team remained very positive and supportive throughout the project life. Through this project, SCI has managed to achieve a remarkable breakthrough in terms of giving identity to unregistered women in the tehsil through NIC registration and women empowerment. This will surely lead to reduced gap of female's voters in the district.

Project orientation Meeting with NADRA MRV In charge and Centre In charge, detail project presentation delivered to NADRA staff and purpose of project decrease number of women having not CNIC and strategy planning also made to reduce gender gap with help of NADRA through MRV movement in back word area where women, girls are not registered with NADRA. Also, a coordination meeting held NADRA office with Zonal Head Manzoor Sb Vehari Region.

Through village volunteer's, awareness has been raised on the importance of having ID Cards especially for women. This awareness campaign has created a change in their attitude to get their women registered with the NADRA for ID cards. This step leads to the empowerment of women in district Vehari. These volunteers/activists are connected with the District network which has already developed linkages with the NADRA and district administration authorities. This linkage will facilitate the people to get ID cards for their female beyond the project life and will ensure the sustainability of project outputs.

Activity D 1.3. Number of Mobile Registration Vans (MRVs) visits requested (Narration required)

SCI team started facilitation of women at MRV after listing of unregistered females from village to village. SCI team request for MRV in the start of Project but MRV not provided by NADRA. After that SCI team sign and stamp the MRV request from DEC and then send to NADRA Multan office after this process NADRA office granted MRV to SCI team for 3 days in a week and one MRV in each tehsil for facilitation at door step. SCI team arrange 117 camps in 102 Villages for facilitation of

women at their own village, other hand SCI team working hard to move female on MRV for registration for this purpose meeting with community notable done before the camp so that they have arrange or informed all remaining or unregistered women from village and nearest village.

In start of phase III NADRA not allow SCI for MRV just allow in NRC but after Close Coordination of TDEA in month Oct 2019 NADRA finally Allow SCI for MRV Camps and in district vehari grants 3 MRVS each for each tehsil, and One MRV in district Pakpattan allow by NADRA office. NADRA office granted MRV to SCI team for 3 days in a week and one MRV in each tehsil for facilitation at door step. SCI team arrange 117 camps in 102 Villages for facilitation of women at their own village, other hand SCI team working hard to move female on MRV for registration for this purpose meeting with community notable done before the camp so that they have arrange or informed all remaining or unregistered women from village and nearest village.

SCI team have work hard before the MRV camp, SCI field staff and volunteers informed all unregistered women to be prepare before arrival of MRV and get ready. SCI team also arrange safe water for women at camp and ECP staff also visit Camp to check facilitation camps. Public announcement was made to avoid any unconvinced at the time of camp.

- SCI conducted Project Introductory meeting in start of project with Key Stakeholder of Project like Government official for getting NOC from district administration. SCI give a detail orientation to all official regarding project objective and goal and issue face in field regarding implementation of project. Behavior of government official very supportive specially District Officer Social Welfare Very Supportive and kind with us also participants in all district level event and encourage SCI team to achieve objective of project.
- Educated people play important role in their society or village development but nowadays lots of fraud with community and field team also faced difficulties during data collection and listing because lawyer of every village call the police that someone collecting information etc. solve this issue SCI team have planned a detail meeting with District Bar Association official and give detail presentation on project objective and activities, after presentation District Bar President encourage SCI team and also inform all Bar member from one notification to help SCI in registration of unregistered women.

B.6: Sustainability of project

With Technical support of TDEA team SCI increase capacity of volunteers and local community now they are able to write a request to NADRA deputy Zone for MRV and also able to request to provided NIC at door step. TDEA team manual create awareness in this regard, its because team SCI selected all volunteers from local community and hired local staff after training throughout project life they also seen progress of MRV request management and how to request NADRA for special time for women special.

Its need to change way of responsivity change activity design a create a VMC (Voter Mobilization Committee) in every Census Block based on 7 members (2 female member must) which trained by TDEA/partner organized about registration at NRC level and how to request for MRV at Village/CB level. Partner organization also provided them all related formats and request forum which useful in further if they want listed women or require MRV at Village level. Project sustainability depends on Volunteers because volunteers only hope for sustainability of Project. If we learn from last two campaign most of volunteers still working after TDEA ask for stop facilitation they have point we have listing so we have to facilitate till the last women not facilitation in their area or village. In last coordination meeting with Volunteers SCI team and volunteers decided to work together no matter if project ends. In end of meeting decisions have made by all participants that monthly meeting held in SCI office to share issue and problem regarding registration of women NIC and also volunteers share progress with team. SCI team ensure volunteers that SCI & TDEA always with them in this noble cause & try their best in the betterment of Vehari.

Hafiz Usman voluntarily said that he also wants to take part in this campaign and want to help his women the basic right that is identity that will help them take part in the election and change the fortune of the country. Hafiz Usman Promised the SCI team that he will work day and night to achieve the required target.

She is an educated lady and understands that the women involvement is very necessary for the prosperity of every nation. She keeps an eye on the current scenario that Most of the women don't have the right to vote as they don't have identify cards. She is also an active member of District voter education committee which educates the women on voter education and helping the women to get their Identity cards.



As she was already working on the women NICs the Team SCI briefly introduced the Project and the Procedure for implementation as this is a national campaign sponsored by Election Commission of Pakistan and is carried across the Pakistan.



Miss Ghazala Hussain enrolled himself to SCI as a Volunteer and said that she will do whatever she can to help the women take part in election process by giving them identity which is a basic right of every citizen.

Miss Ghazala Hussain on his own identified 1000 un-registered women in his nearby villages and shared the data with SCI. Mr. Shahid Imran is a habitant of 230/EB from a humble background. Helping the society & solving their social problems is his mission. His dream is to see every woman of his village having his ID Card and taking part in upcoming General elections. Shahid Imran is a committed and educated person and he believes that it was education through which he became capable of helping the women and highlighting their problems.

Not having the identity card is the big problem and he says that woman don't know the benefits of id card and they spend their whole life being unregistered and as a result not taking part in the national stream.



Team SCI visited his village & a brief introduction was given about the key features of the project about Women NIC & voter registration, Shahid Imran registered himself as a volunteer and asked the team how he can help the SCI team. SCI team presented the goal of project and the role of volunteer in the project.

Shahid Imran started worked on collecting the unregistered data of women. He worked in 10 villages helping the social mobilizer in door to door registration campaign and then later on facilitating the women getting their identity through mobilization towards NADRA registration centers. SCI team believes that people feel safe when someone of their own person is collecting data and they cooperate in helping themselves.

Shahid Imran also helped SCI for arranging the Mobile registration camp where unregistered women got their id card at their door step and organized more than 18 MRV Camps in Tehsil Mailsi. The women of his town are thankful to as they feel at home getting their id cards.
