CRITICAL ACTIVITIES

Community Prosecution Collaboration with APD

- Expanded efforts continue in all 6 APD zone precincts by regularly staffing, training, and supporting the APD Watch Teams.
- Attorneys are assigned to zones to build relationships, support with charging decisions PAD referrals, and preliminary screening.

Bond Hearings

871 Arrest Cases resulted in 753 Bond Hearings 726 Resets/ 46 Bind Overs / 117 Dismissals /1 Dead Docket

Record Restriction

Eligible records on your official criminal history report are restricted from public view and are only accessible to law enforcement agencies for criminal justice purposes.

Total Record Restriction requests processed from October
 1, 2020 - December 31, 2020: 20

Diversion & Non-traditional Prosecution

The successful transition of diversion and alternative prosecution programs to remote processes allowed the Solicitor's Office to review more than 13,000 new cases giving approximately 9300 defendants the opportunity to resolve their cases without personal appearances in court.

CODE ENFORCEMENT TEAM DETAILS

DURING THE COVID-19 PANDEMIC

The Code Enforcement Team continues weekly details amid the 2020 COVID-19 pandemic. On March 12, 2020, Mayor Bottoms announced the City was implementing a full telework deployment for all non-essential employees due to the COVID-19 Pandemic. This emergency resulted in the suspension of weekly Code Enforcement details and the Municipal Court closure.

Following CDC guidelines and exercising safety precautions, the Code Enforcement Team resumed detail inspections and issuance of warnings for commercial and private properties in May 2020. The details provide critical support to our partners in APD Code Enforcement, Department of Public Works, and Department of Zoning.


