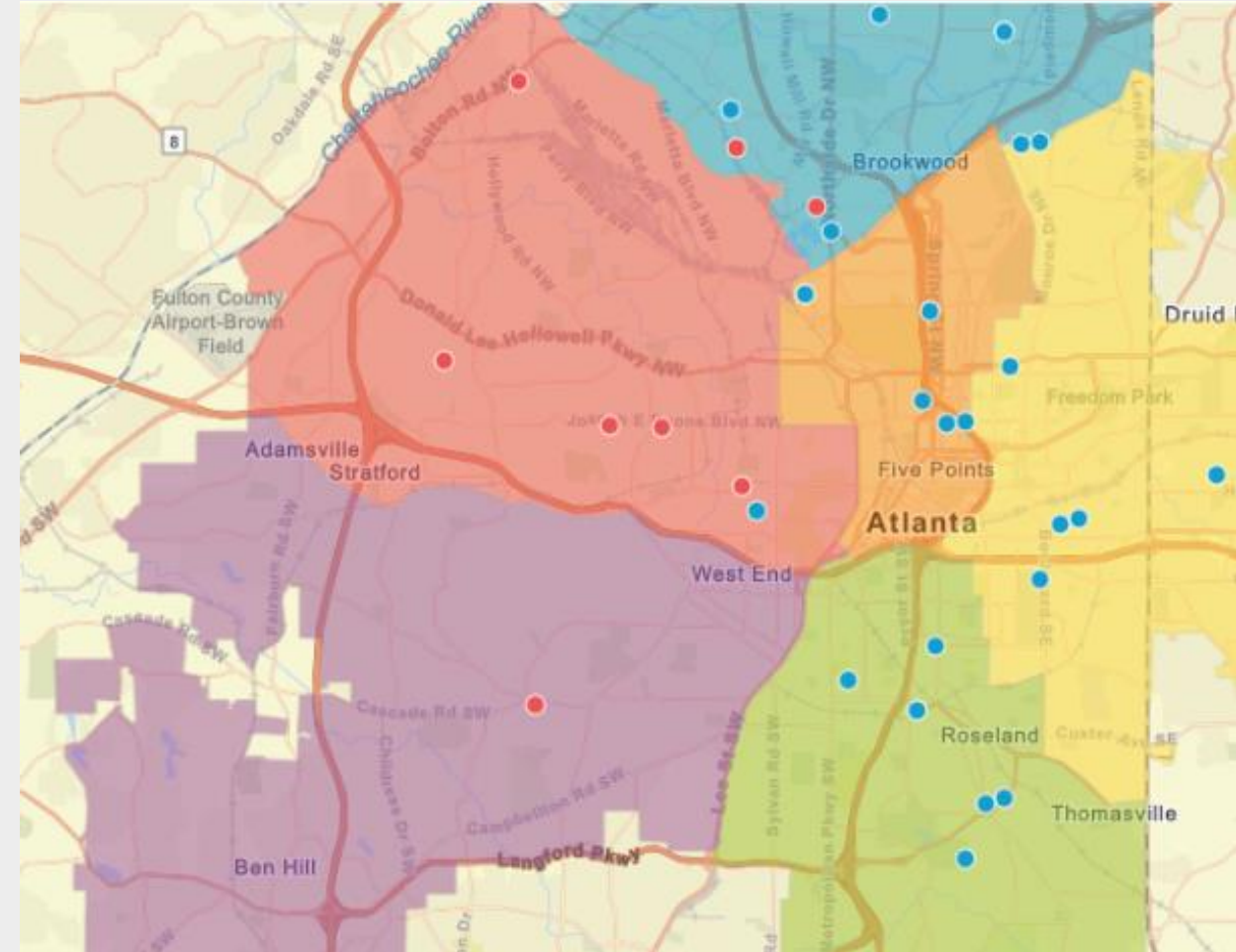

INSPECTIONS

VIOLENT CRIME CODE ENFORCEMENT INSPECTIONS

- **October 2020**, a proactive inspection initiative was formulated to assist in fighting violent crime
- **36 proactive inspections** have been conducted in response to violent crimes that occurred
- **Over 30 violations** have been discovered and notices processed
- No code violations were located at **7 of the locations**

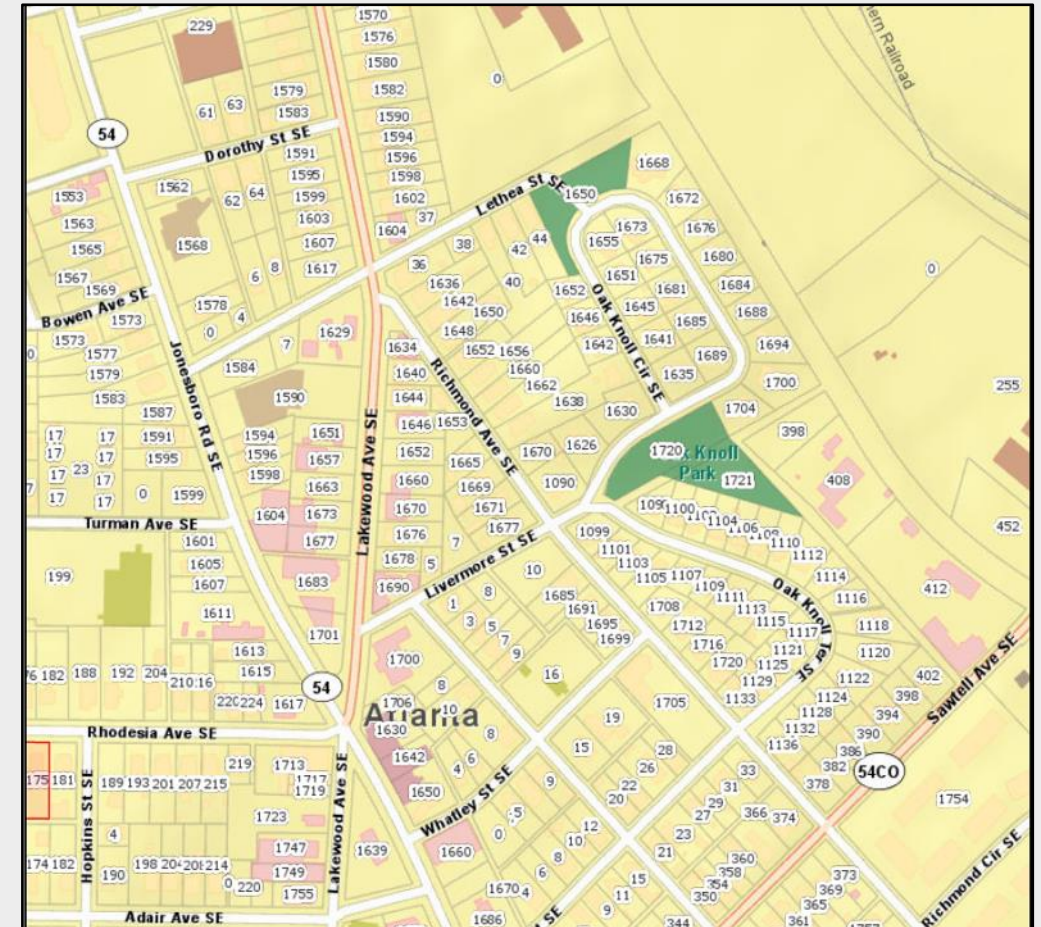

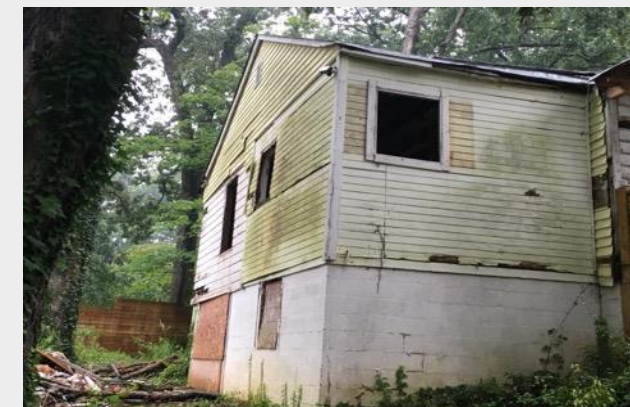
