Due date April 15

Due to safety precautions and health care guidelines during the pandemic, the IRS has determined that the Volunteer Income Tax Assistance (VITA) and Tax Counseling for Elderly (TCE) programs will not be operating at full capacity, with many sites temporarily closed for an undetermined period of time. There are several alternative ways for eligible residents to receive free income tax filing assistance - online or by phone.

Facilitated Self-Assistance (FSA) services

In consultation with the IRS, the Northern Virginia CASH coalition VITA and TCE sites will change from in-person services to Facilitated Self-Assistance (FSA) services. This is similar to the traditional VITA/TCE programs but uses IRS-certified income tax preparers to assist filers in their tax return preparation. The main difference between the traditional volunteer preparation and FSA boils down to who does most of the preparation. As the name suggests, FSA puts the taxpayer in charge of their taxes by walking them through their taxes (online or by phone) with free computer tax preparation software.
