

## 2. Comprehensive Sex Education (CSE) the second Educational Curricula that can be harmful to our children's culture.

Comprehensive Sex Education (CSE) has been required in multiple states and the curriculum goes far beyond the usual pregnancy prevention and sexually transmitted disease prevention. CSE encourages student to have open conversations about sexuality and identity, and CSE standards mention consent and establishing boundaries beginning in kindergarten.

CSE has not passed in Georgia. Keep in mind this curriculum can be adopted by individual school districts in many states. Texas voted no for statewide CSE yet Austin still voted yes. In Cherokee County our children will be faced with gender identity issues through LGBTQ clubs, instruction tools like BrainPop, and library electronic and book references.

Planned Parenthood has been involved in curriculum development for CSE which promotes ten concerning concepts at inappropriate ages:

1. As young as kindergarten, teaching an abstract thought that you can choose your gender.
2. As young as kindergarten, teaching can pleasure selves sexually.
3. In elementary school, teaching children to use "I like it when you touch me here".
4. Teaches children are sexual beings with sexual needs, desires, and fantasies. This adds confusing concepts – choosing my own identity is not truth.
5. In elementary school, teaching anal and oral sex without teaching physical danger or emotional damages. In high school, teaches anal sex is a form of birth control.
6. Students are taught how to obtain contraception without parental consent. School-based health clinics (SBHC) can offer contraception without parental consent. Georgia has 35

comprehensive SBHCs. What would come next? Abortion or hormones for sex change?

7. In middle school, sexually graphic material used for instruction normalizes pornography.
8. Teaches sexual consents and satisfaction rather than emotional consequences.
9. Demonstrates condom application in the classroom.
10. In the third grade, teaches diverse sexual orientation and gender identity issues – 106 identities and LGBTQ-MAP. MAP stands for minor attracted people or pedophiles.

CSE has not passed in Georgia, but it is still a threat. House Bill 516/Senate Bill 226 were proposed to change the obscenity law in Georgia so it would be illegal for school libraries to provide access to online pornography. It failed twice.

What should our family do? Family should pray because this is a spiritual battle. Talk to your children about their Core Needs of Security, Identity, Belonging, Purpose, and Competency. Look to resources like No Left Turn in Education, Beacon Life, Stop CSE, and Parents Rights In Education. What should our community do?

Community should talk to teachers regarding what to opt-in or opt-out, attend school board meetings, and vote for a school board candidate who will not bring these threats into our schools.

**I believe** that CSE normalizes inappropriate behavior and grooms our children for predators. Transparency in education is important to protect our children.
