We had a lot more miles than what we had. We are able to get \$30,000 opposed to last year \$606 that were received last year.

#### Letter Grade celebration

We had a great celebration for recognizing students who showed growth and proficiency on the state test. Parent were very happy.

#### **Data Meeting**

We had a data meeting with teachers and they are very responsive to data and using it for instruction. Using reports to help with student growth and for instruction. Teachers were expected to teach a lesson and were excited about learning from their lessons.

### IV. Old Business

A. Discussion and possible action on Auditor General – Corrective Action Plan Report - Update on withheld funds

It was noted that the district has not yet received formal notification of release from the audit; however, funds are being disbursed. A deposit of \$28,000 has already been received, with an additional \$42,000 anticipated. This reflects positive progress, as the release of funds indicates that corrective actions are being recognized. Importantly, these are dollars the district had not been able to access in prior years due to unresolved findings from the Auditor General.

- B. Discussion and possible action regarding Social Security letters to the district regarding FY23 and FY24
   Update on Social Security that all years have been updated.
- C. Discussion and possible action regarding the SFD Kitchen Fire System Grant We are still waiting for a letter from the fire department in order to move forward.
- D. Discussion and possible action of water quality report
  Update: Sam reported that the filters have been replaced, and we confirmed
  that all water stations now have functioning filters. Our review of the water
  system raised concerns regarding the building's water pipes. Without a
  mineralization system, there is a risk of damage to the system over time. We
  will continue gathering bids and plan to present options to the board for
  consideration of a comprehensive water filtration system for the building.
- E. Discussion and possible action on creating a high school

  The District has contacted the Arizona State Board of Education to explore
  the possibility of establishing a high school at Cedar Hills. The Board
  informed us that, in order to move forward, we must submit a formal letter
  from our governing board requesting approval to expand Cedar Hills
  School to a K-12 institution that includes high school grades.
