SPOOKY TO BE HUNGRY

SHOULD WE BURN YARD DEBRIS? (CONT.)

The state-mandated burn ban runs from May 1 through Sept 30 every year so we can burn debris now. But should we?

Lt. Thornton of the Columbia County Fire Department encourages people to reconsider setting fire to that pile of trimmings: "I always tell people don't burn but they are within their rights" – as long as they follow the rules.

Georgia law effective July 2021 mandates that the person burning take full responsibility for keeping their fire contained and is required to follow five safety standards.

The first step is to figure whether your property is large enough to meet the two space requirements for burning. That is the first thing Lt. Thornton checks when he responds to a fire report or smoke complaint. If you do not meet the requirements, the fire must be put out. Check the weather, too. Do not burn if the wind will pick up in a few hours.

"Take Five" before you burn and remember the five-letter acronym "S-S-T-A-R" for the safety requirements.

Space: Burn location must be no less than 25 feet from any woodlands, forestland or field that contains brush, grass or other flammable material.

Space: Burn location must be no less than 50 feet from structures, which includes homes, outbuildings, sheds and barns

Time: Burning must take place between sunrise and sunset

Attendance: Person responsible must attend burning at all times until fire is completely extinguished and there is no risk for burning to escape control

Reasonable Precautions: Person responsible must take reasonable and necessary precautions to prevent fire escape or spread

Keep this in mind: Escaped debris burning is the number one cause of wildfires in Georgia, according to the Georgia Forestry Commission.

Call 911 – not the fire station – to report smoke or burning. 911 operators can locate the closest engine.
