In this regard, it must be recognized that it is impossible for the Prophetstown Park District to guarantee absolute safety.

**WAIVER AND RELEASE OF ALL CLAIMS**

Please read this form carefully and be aware that in signing up and participating in the above identified programs/activities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damage or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with said programs/activities (including transportation services/vehicle operation, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of all injuries, damages or loss, regardless of severity, which I or my minor child/ward may sustain as a result of said participation.
