In this regard, it must be recognized that it is impossible for the Prophetstown Park District to guarantee absolute safety.

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of all injuries, damages or loss, regardless of severity, which I or my minor child/ward may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the Prophetstown Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred to as "Prophetstown Park District").
