

ARTICLES OF INCORPORATION OF

RANCHCREST HOMEOWNERS ASSOCIATION, INC., A Texas Non-Profit Corporation

Corporations Section

The undersigned natural person, who is a citizen of the State of Texas, and who is the age of eighteen (18) years or more, acting as incorporator of a corporation under the Texas Non-Profit Corporation Act, does hereby adopt the following Articles of Incorporation for such non-profit corporation:

ARTICLE ONE

NAME

The name of the corporation is RANCHCREST HOMEOWNERS ASSOCIATION, INC.

ARTICLE TWO

NON-PROFIT CORPORATION

The corporation is a non-profit corporation.

ARTICLE THREE

DURATION

The period of its duration is perpetual.

ARTICLE FOUR

PURPOSES

The purposes for which the corporation is organized are:

- A. Specifically and primarily to provide an organization consisting of the owners of the subdivided lots out of the Ranchcrest Addition, to the McLennan, Texas, in order to provide for the management, maintenance, preservation and control of the Ranchcrest Addition, as such is more particularly described in the plats for the Ranchcrest Addition which are recorded in the Official Public Records of McLennan County, Texas, in the office of the County Clerk of McLennan County, Texas.
- B. Generally:

- To promote the health, safety and welfare of the lot owners of Rancherest Addition;
- To exercise all of the powers and privileges and to perform all of the duties and obligations of the association as set forth in the Declaration of Covenants and Restrictions for Ranchcrest Addition;
- 3. To fix, levy, collect and enforce payment of the charges or assessments as set forth in the Declaration of Covenants and Restrictions for Ranchcrest Addition; to pay all expenses in connection therewith and all office and other expenses incidental to the conduct of the business of the association, including all licenses, taxes or governmental charges levied or imposed against the property of the association;
- To acquire (by gift, purchase or otherwise), own, hold, improve, build on, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the association;
- To borrow money, mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- To have and exercise any and all powers, rights and privileges which a corporation organized under the Texas Non-Profit Corporation Act by law may now or hereafter have or exercise;
- To act in the capacity of principal, agent, joint venturer, partner or otherwise.

ARTICLE FIVE

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 2040 Bear Creek Crossing, McGregor, Texas 76657, and the name of the its initial registered agent at such address is Walter D. Keeler.

ARTICLE SIX
