### **2-year limited warranty on entire PT Fishing bracket**

PT Fishing Corp. extends the following limited warranty to the original retail purchaser only. Warranty coverage is not transferable. PT Fishing Corp. warrants to the original retail purchaser only that the purchaser's new PT Fishing bracket will be free of defects in materials and workmanship appearing within 2 years after the date of purchase. PT Fishing Corp. will (at its option) either repair or replace, free of charge, any parts found by PT Fishing Corp. to be defective during the term of this warranty. Such repair or replacement shall be the sole and exclusive liability of PT Fishing Corp. and the sole and exclusive remedy of the purchaser for breach of this warranty.

### **Exclusions and Limitations**

This warranty does not cover normal wear and tear, Blemishes, or scratches that do not affect the operation of the product, damage caused by accidents, abuse, alteration, modification, shipping damages, acts of God, negligence of the user or misuse, improper or insufficient care or maintenance.
