SKY HI RETREAT PROPERTY OWNERS ASSOCIATION ANNUAL MEETING MINUTES

Sky Hi Domestic Water Co. Pump House
Saturday August 4, 2018
(3rd/4 required yearly meetings)

POA President Tim Provencher called the meeting to order at 10:15 AM and led the Pledge of Allegiance. The quorum requirement for the POA was met.

Board members present were Ron Shaw, Bill Lucas, Bill Jordan, Terry Patrick, Karen Johnson, Mark Johnson, Jim Polston and Greg Scandrett.

Flood Control Update

Three representatives from Navajo County attended to provide an update on the flood control project in Sky-Hi Retreat:

John Osgood, Public Works Director Sandra Phillips, Assistant County Engineer Bill Best, County Engineer

The improvements made were started from the downstream side of the drainage. The culvert removal was completed to allow for a larger drainage channel. POA members Tim Provencher and Bill Lucas, along with the fire district reps were notified of the plan to remove the culvert. Residents of Baron Circle were concerned about the loss of a fire escape route and about lack of advanced notification to residents impacted by the removal of the culvert. The county reps stated that the fire department determined that there was sufficient egress in case of a fire in Sky-Hi. A suggestion was made to have the Fire Marshal address the POA. John Osgood said he would have the county attorney provide a written response to residents regarding the procedural process followed for the culvert removal.

<u>Approval of 2017 Meeting Minutes</u> —The contents of the 2017 annual meeting minutes were read for the attendees. It was moved and seconded, and approved by the members to accept the minutes as written.

It was moved, seconded, and approved to accept the Treasurer's Report.

Sky Hi Water Board Update

Bill Lucas provided the water board update. Bill reviewed the pump house building improvements that were completed (\$30K worth of improvements):

- A 50 year, steel roof with an ice shield was installed.
- The leaky windows were replaced
- Fire alarms were hooked up for the pump house
- The cracks in the floor were sealed
- Booster pump addition (\$2,500)

Residents were asked to report any water line breakage to Barry Harville or Bill Lucas.

The water board sends out a newsletter twice each year.

The board is checking into drilling a deeper well to better serve residents when there is a drought. Currently the wells get water from the Dakota layer. The plan is to drill deeper to the Coconino level. Bids will be obtained for the new well – it will take a year to get a new well. Initial outlay would be \$5K for an engineer.

Spring Clean-up –

Once again this year <u>lots</u> of green waste was removed from Sky Hi during the Spring Cleanup, on Memorial Day Weekend. The County pays for this trash collection (around \$900), and it is therefore open to all Sky Hi residents, but it is planned and coordinated by the POA and required an extensive effort (Thanks to Ron Shaw). The guidelines for green waste only were followed by the Sky Hi community, so thanks to all for their efforts.

<u>Social</u> –The July 4th picnic this year had a great turnout. It was combined with the water board open house.

Fall Clean-Up - Fall Dumpster

The POA will arrange for a dumpster at the pump house for the Labor Day weekend. This clean-up is paid for by the POA and open only to POA members who are current on their dues. The cost for one 40 yd dumpster is \$500. This is for anything except hazardous items like tires, paint, chemicals, poisons, refrigerators etc.
