**Cancellation:** THIS CONTRACT MAY BE CANCELLED ONLY UPON THE MUTUAL AGREEMENT OF THE PARTIES. NO REFUND WILL BE PROVIDED FOR CANCELLATIONS DUE TO INCLEMENT WEATHER OR OTHER NATURAL DISASTER, INCLUDING UNSAFE PLAYING ENVIRONMENTS/CONDITIONS.

**Enforcement of Agreement:** This agreement is an agreement between the schools and binds all successor principals, athletic administrators, athletic directors and coaches. Contracts with other CIF section schools, or out of state schools, must be in writing and the section commissioners/executive director shall have the final authority to resolve any dispute in case of a breach of any provision or cancellation of the contract without proper notice.
