Poe's Gym Metallic Powerlifting and Strength CS145 Secondary Membership

1. FIRST AND FOREMOST: This contract is for 6 consecutive months. Unexpected geographical re-location of you, unforeseen personal problems of you, sudden injuries/illnesses/physical dysfunctions/addictions/mental diseases, and deaths of friends, of pets, and of family of you are not grounds to terminate this agreement or receive a refund or credit of any means. This contract is non-transferable to another person and not refundable to you.
2. You are billed and obligated for (6) months in duration of \$145.00 per month plus a PayPal transaction charge of \$5.75 equaling a \$150.75 total payment to Poe's Gym Metallic Powerlifting and Strength per month on the date that you initially signed your membership agreement. Note that PayPal may periodically increase fees during an active contract. You are obligated and will be notified to pay any increased fees incurred by PayPal.
3. There is yearly gym maintenance fee each year of \$35.00 to be paid on the same day of your contract sign up and any contract renewal of any kind. You can pay this fee by Venmo @poesgym (Create Separation) and, if applicable, the last four digits are 8760. Please pay friend to friend to avoid fees. If not, all applicable fees will apply to you.
4. You lift and exercise at your own risk at Poe's Gym.
5. Poe's Gym is equipped with 24-hour surveillance cameras for liability, security, and safety purposes.
6. We have no supervision in the gym. Do not attempt to do anything that will harm our equipment, our facility, or yourself as result of no supervision. Ask for help or a spot to be safer while lifting. If you feel a situation is dangerous and or you are in need of a spot, please leave the gym and or contact (615)-668-8760 for assistance or 911 for a life-threatening emergency. Emergency phones can be found on the walls throughout the gym. All equipment in the gym is in working condition. <i>If you break the equipment, you buy it.</i>
7. Poe's Gym reserves the right to terminate this contract at any time with or without cause and/or to protect the health and well-being of the Poe's Gym membership and the financial stability at Poe's Gym, and, reciprocally, to protect the health and well-being of you.
8. All members must obey all rules which are subject to change at any time during a membership. Poe's Gym's never changing foundational rules are: 1) Do not drop the dumbbells of any weight 2) Wipe down and disinfect all things touched by you or your ass 3) Mop all areas of sweat (includes all your sweat droppings left on the floor from walking around the gym) and all areas that work has been performed by you (even if you do not sweat), and 4) Do not enter the gym if you are feeling less than 100% healthy.
9. If you have had any illness or feel less than 100% healthy, get to 100% healthy and <i>non-contagious</i> , then, re-enter Poe's Gym.
10. During and after this agreement, if you are a trainer/coach, a real estate agent of any kind, an orthopaedist, a physical therapist, or an attorney to name a few, you may not solicit services to Poe's Gym members (in or out of the gym) as Poe's Gym has "exclusive right contracts "with the forementioned professionals. Please ask Poe's Gym about current relationships or forming a relationship with Poe's Gym.
11. Any desired contract settlements must be directed to Matt Castle, Poe's Gym's third-party administrator (TPA), at legalpoesgym@gmail.com.
12. At no time or under any circumstance (including possible membership settlement discussions) may you cancel your payments/contract to Poe's Gym. No matter the results of any situation, Poe's Gym, is the only one permitted to officially close your membership through PayPal merchant services.
13. If you, unknowingly to Poe's Gym, decide to cancel your account/contract, our TPA will automatically receive a member cancelation notice which triggers our TPA's collection process. This process starts by reporting cancelation of membership and or non-payment on an obligated contract to all three credit agencies. Our TPA will execute immediate means to make record through applicable credit reporting agencies such as TransUnion, Equifax, and Experian.
14. Poe's Gym does not allow guests, visitors, or pets unless approved by Poe's Gym. No person is allowed in Poe's Gym without Matt Poe's approval. This rule will be explained in depth for your safety and the safety of the gym upon orientation.
15. After you complete the "BUY NOW/SUBSCRIPTION" process through PayPal, these two steps officially consummate the (12) month agreement with Poe's Gym. Your name, date of payment completion, and driver's license number will be auto-filled on the contract which will be saved in a file by Poe's Gym and available upon request by you at any time.
16. All members at Poe's Gym will receive a hard key not be shared at any time. Poe's Gym does not own the warehouse. All members may use the gym at any time. There is a \$20.00 fee to replace a lost key if you are a current member. The key is the "property" of the landlord and Poe's Gym which gives you access to not only Poe's Gym, but alos gives you access to other businesses in the building.
If the key is not returned to Poe's Gym, 1) you will be prosecuted for trespassing if you are found in the gym or on any part of the 6100 Centennial Blvd. property, 2) Poe's Gym and the landlord reserve the right to serve a warrant based on the stolen property, and 3) there is an immediate \$1,000.00 stolen property penalty that Poe's Gym reserves the right to collect from you in a court of law. Non return of this key is considered petty theft and is Class D felony in the State of Tennessee.
17. Poe's Gym will close on certain holidays and snow days. During these closings, the gym will be closed to all members and a different lock will be placed on the gym. Poe's Gym will be closed during the Christmas Holidays for a duration of a week and possibly more than a week depending on the day of Christmas. During these closings, the gym will be
