



Terms & Conditions

(PLEASE PRINT AND KEEP FOR YOUR RECORDS): You are a valued customer of Rolling With JV's, LLC. (JV's) and we want you to enjoy your use and worry-free travel with OUR vehicles. We want to ensure that the integrity of OUR vehicles are maintained for future business. Therefore, these rules apply to all transportation provided by Rolling With JV's without exception.

Age Requirement: To reserve any Rolling With JV's, LLC vehicle, the booking person must be 21 years of age or older. This person assumes ALL responsibility for the booking including but not limited to itinerary changes resulting in additional fees, injuries, and any damages to the bus due to passenger negligence. This person is responsible even if they do not accompany the party.

ZERO-TOLERANCE POLICY: We have a strict Zero-Tolerance Policy for our Drug & Alcohol Policy, NO WEAPONS, No Smoking/vaping, & No Fighting/Overly-Rowdiness Policies. Please be sure to read and abide by all policies to be sure your booking is not subject to any additional fees, fines, and/or immediate cancellation.

No Fighting/Overly Rowdiness: Any fights on board will result in the JV's Party Bus being pulled over to a safe location and the proper authorities being called immediately. Booking will also automatically incur an additional 2 hours due immediately in cash or charged to the credit card on file. If charged to the credit card on file, additional credit card fees will apply. If the client does not wish to pay time overage- if applicable, while officers are present, all passengers are to exit the JV's Party Bus with their belongings and are to find an alternate mode of transportation. If everything is resolved and payment is received- if applicable, the person who booked the reservation is responsible to make sure the aggressor(s) do not reboard the bus. **Overly Rowdiness:** Keep in mind that you and your passengers are on a Party Bus, so turn up! BUT be sure to remember at a certain point the party has the potential to become more destructive than fun. Broken TV's, windows, damages to structures or vinyl on seats, walls, & bar due to the excessive out of control turn ups will not be tolerated. Damage fees will be charged for any damages caused by the booking party that are found during or after a booking. Rolling With JV's and or Driver reserves the right to gauge the "rowdiness" level and let the party know if they are a bit on the extreme side to prevent any possible damages. If the turn up continues to get out of control the booking can be immediately terminated without a refund. Having intimate relations in our vehicles is prohibited. *NO STANDING ON SEATS OR SITTING ON TOP OF THE SEAT BACKS *NO SITTING ON THE BAR *NO SITTING OR STANDING ON ENTRY STEPS WHILE THE BUS IS IN MOTION.

NO FIREARMS OR WEAPONS are allowed on any Rolling With JV's, LLC vehicle. The only exception is for on-duty Law Enforcement/ or on-duty licensed Security/Bodyguard. Please let us know if your party will include an armed on-duty officer.

Bus Capacities: Each bus has a maximum capacity for safety and comfort. Maximum capacities are not to be exceeded under any circumstances. Bookings are subject to immediate termination without refund if the party decides not to abide by the maximum capacity policy.

No Smoking/Vaping Policy: ALL Rolling With JV's, LLC vehicles are 100% smoke & vape free. If you or someone in your party violates the smoking/vaping policy, the booking client will be charged a \$350.00 fine for each occurrence. This fee is due in cash or can be charged to the credit card on file + card processing fees. Your booking will also be subject to an immediate termination without a refund. **We DO make smoke stops!**

Alcohol/Drug Policy: In Florida, it is unlawful to sell, furnish, or provide alcohol to a person under the age of 21. The possession of alcohol by anyone under 21 years of age is illegal. Rolling With JV's, LLC strictly enforces such laws. Violators are subject to an immediate non-refundable cancellation of their booking, criminal prosecution, and imprisonment. The possession, sale, or distribution of any controlled substance is illegal under both state and federal laws on ALL Rolling With JV's, LLC vehicles.

Credit Card Deposit: To secure your booking with Rolling With JV's, LLC, we require a completed and signed credit card authorization form with a matching ID on file for the non-refundable \$250.00 deposit + card fee. This deposit will be applied to your total balance. Any other additional charges that your booking incurs will also be charged to the credit card on file (i.e., additional hours and cleaning/damage fee). Please carefully read and abide by ALL policies to ensure your booking does not incur any additional charges.

Cancellation Policy: Cancellations before 7 days of booking, deposits remain nonrefundable & remaining balance is not due. Cancellations within 7 days, but before 72 hours of booking will result in the client being responsible for 50% of the invoiced amount, including credit card processing fees. Cancellations 72 hours and after are responsible for 100% of the invoiced amount. After payment is received as an alternative, the booking person has the option of (1) rescheduling based on availability within 6 months of original booking date. There is a NO CANCELLATION POLICY for Proms, Holidays, & New Year's Eve, 100% of the invoice is due and nonrefundable.

Payment: Rolling With JV's, LLC accepts major credit/debit cards and cash as forms of payment. To secure your booking, a deposit of \$250.00 + credit card fees will be charged to your credit card provided on the credit card authorization form. Any credit card or cash unpaid balances will be due/charged 3 days prior to pick up. Passengers are not allowed to board any Rolling With JV's vehicle until the remaining balance has been collected in advance or in full by the driver. Any additional hours needed can be made in cash to the driver or otherwise will be charged to the credit card on file immediately. There is no refund for any unused time.

Prom Policy: To reserve any Rolling With JV's vehicle, the booking person must be 21 years of age or older. Like any other booking, this person is responsible for the booking and any additional fees resulting from damages, cleaning fees, smoking/vaping, time overages and most importantly, the behavior of the teens onboard attending the prom. Please have an understanding with the teens regarding our policies and inappropriate behavior. For prom, we require a 6-hour minimum, and gratuity is included in all prom quotes.

Booking Time: When booking with Rolling With JV's, LLC your time begins at the scheduled pickup time (or when the bus arrives if behind schedule) and ends at final drop off. All time in between including travel time and time spent at any venues or restaurants is to be included. Time changes may only be accommodated if communication is made up to 2 hours before scheduled pickup and if the change does not conflict with another booking. Also, do account for multiple pick-ups and drop-offs if applicable. Last drop-off must be made by the end of the contracted booking time. Any overages are charged by the hour.

No-Show Policy: Failure of passengers to meet at the designated pickup address and or at the agreed time will result in 100% of funds that are due to be charged to the credit card on file. Drivers will be in touch with the contact person at least two hours prior to the agreed pickup time. Our drivers aim to arrive no later than 10 minutes before a scheduled pick-up time, traffic pending. If the party is running behind, there may be a 15-minute grace period (at the drivers' discretion). If extended, after the grace period your time will begin.

Out of Area Fee: Any pickup or drop-off address and bookings that travel outside the South Florida area or exceeds the allotted 100 miles are subject to an Out of Area Fee.

Rates: Rates are subject to change without notice due to holidays, special events, fuel prices, adverse weather conditions, etc.

Damage/Cleaning Fee Policy: The booking client is 100% responsible for ALL damages to the vehicle caused by passengers or client-added decorations. **ANY** damages to the Rolling With JV's, LLC vehicle caused by passenger's conduct and or added decorations will be billed to the booking client at the cost of repair. No décor is to be hung from the ceiling or attached to windows with any type of adhesives. At the end of your booking, all trash should be placed in the trash bin provided. Should the Rolling With JV's, LLC vehicle require excessive cleaning, including but not limited to, trash left behind, stains, and bodily fluids, there will be an additional \$350.00 cleaning fee due in cash or charged to the credit card on file.

Lost & Found: Rolling With JV's, LLC is not responsible for any items that are left behind in our vehicles during and after any booking. Although our drivers inspect for possible damages beyond normal wear and tear after each booking and for items that are left behind, it is the passenger's responsibility to check for all personal belongings. If you feel you have left something behind, give us a call and we will try to locate it for you. In some cases, personal items are placed in the trash during cleanup by passengers or even possibly taken by other passengers (by mistake of course).

Gratuities: Gratuity is not required but is strongly suggested. Although our drivers are appreciative of any amount of gratuity, the typical gratuity is 15% +. Remember this part when the night may not be going as planned and the party wants that extra stop or the party runs over time a little. Take care of your driver. *Gratuities are included in all prom quotes.

Parking: Clients are responsible for any required parking permits and paid parking lots during their booking. Prior parking arrangements are able to be made with advance notice.

Parking Lots/Driveways: It is the client's responsibility to be sure that addresses are bus friendly. The driver has the final decision when pulling into certain driveways or parking lots that may damage the bus. This includes places that may be too narrow, have low clearances or low-hanging trees, or foundations that may not support the weight of the bus (i.e wet grass or dirt). This also includes parking lots or driveways that are steep or have large humps that may cause the back or front of the bus to drag the ground or even cause the middle of the bus to get "hung".

EMERGENCY EXITS/WINDOWS: Emergency Exit Windows are to only be opened during an emergency. At no time are passengers to open, extend any parts of the body or throw objects from the bus. Any resulting damages or injuries are the responsibility of the booking client.

Medical Disclaimer: Rolling With JV's, LLC vehicles may contain strobe lighting and flashing lights that could cause difficulties for people with photosensitive epilepsy and other conditions with sensitivity to light. This service may also contain haze, fog, lasers, and other effects that may adversely affect some people. Onboard most of our buses we also have dancing poles. Rolling With JV's, LLC is not responsible for any injuries that may occur from negligence, sudden stops or turns while the bus is in motion, dancing on and using the pole as support, entering and exiting the bus, or any other medical issues.

Delays: Any delays beyond our control due to traffic, accidents, weather, construction, or road conditions may result in additional charges at the hourly rate. Payments are to be made in cash or charged to the credit card on file. JV's reserves the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties or scheduling reasons. Any delays due to mechanical issues will be dealt with on an individual basis with the booking person only. Keep in mind the times you decide to travel and the normal traffic conditions during that time.

VIDEO/PHOTOGRAPHY: Any photos or video captured in good taste are solely used for the purposes of Rolling With JV's, LLC promotional material and publications. Booking client understands that they waive any rights of compensation or ownership thereto.

COVID-19 Notice: Under Florida law, there is no liability for injury or death of an individual entering our party bus if such injury or death results from the inherent risk of contracting COVID-19. During this sensitive time, temperatures may be taken before boarding ANY Rolling With JV's vehicle. When necessary, for the safety of our driver and passengers any person(s) with a temperature of 100.4 or higher will not be allowed to board the vehicle and as always, hand sanitizer is provided. Our bus is disinfected after each completed booking.

****At the discretion of Rolling With JV's, LLC & the driver, bags are subject to be searched, IDs can be checked for age verification, and trips can be terminated without a refund at any point if any of the policies set forth in this document are broken.***

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT FOR JV's Elegant Events, LLC & Rolling With JV's, LLC

1. in consideration for receiving permission to participate with JV's Elegant Events, LLC & Rolling With JV's, LLC (JV's), I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, JV's Elegant Events, LLC and/or Rolling With JV's, LLC. their officers, agents, servants, or Employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me and/or other family members that are utilizing the transportation service, or any of the property belonging to me and/or other family members that are utilizing the transportation service. WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on, or upon the premises where the activity is being conducted.
2. I am fully aware of the unusual risks involved and hazards connected with this activity, including but not limited to travel risks and/or road hazards. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
4. I understand that JV's does not maintain any insurance policy, other than fleet insurance coverage, covering any circumstance arising from my participation in this event or any activity associated with or facilitating that participation. As such, I am aware that I should review my personal insurance portfolio.
5. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Florida.
