



## **D&T BOSS BULLIES PUPPY WARRANTY**

As breeders we strive to always produce our American bullies to meet the breed standards with conformation and with the best possible health. We can ensure this by doing our best to see that we select great studs and dams capable of what we believe will produce healthy bully babies for our families to enjoy...But please remember that we are working with live animals, that may develop illnesses common to the breed, viral infections that can be found anywhere in the environment, and even sometime congenital illnesses that may have been present in either bloodline several generations back. For this reason and your peace of mind D&T Boss Bullies offers a one-year limited health warranty. Our one-year limited health warranty does not cost you extra but does require your full understanding and acknowledgment of the agreement below.

1. Puppies will be health checked and de-wormed at time of pick up, and a normal de-worming should follow as recommended by your vet. 1st set of shots will be given along with one deworming. Follow up shots and deworming are the responsibility of the buyer. Any puppy that develops an illness related to lack of shots or deworming will not be replaced. it is the responsibility of the new owner to keep up with all vaccinations.
2. Purchaser should take puppy to a licensed veterinarian within 2 business days from receiving their American Bully puppy. If you receive your bully puppy on a Friday, you have until the end of the following Tuesday to visit the veterinarian for a wellness exam to confirm the puppy is fit to join a new family as their new pet. If it is determined by the vet that the puppy has any physical problems considered to be life-threatening, we will provide you with a healthy replacement puppy of the same value. If there are no puppies available, one will be provided from our next available litter. (Should you select a puppy with a higher price, you will be responsible for the difference).

### **D&T Boss Bullies is NOT responsible for any veterinarian expenses.**

To make a claim, you must return the puppy back to us in Fort Worth, TX within (4) days of receiving him/her. If the puppy was delivered by D&T, it will be your responsibility to get the puppy back to us. A signed statement from the veterinarian providing the date of the examination and an explanation as to why the puppy's health is at risk should be given. The statement must include a description of the symptoms supporting the opinion of the veterinarian. Depending on the findings we as breeders have the right to request a second opinion from an un-associated veterinarian.

If the puppy dies of a birth defect within one year of the time of purchase, D&T Boss Bullies will provide you with a replacement puppy. You can make a claim only if you have kept the puppy under the care of a licensed veterinarian. This must include all vaccinations recommended by the veterinarian. You must also provide a signed statement from your veterinarian including the cause of death and a copy of ALL your puppy's health records. Failure to have the puppy examined within two (2) business days from receiving your new American Bully pup, **VOIDS THIS WARRANTY**. Under no condition will a replacement puppy will be granted, if we are not informed of the illness diagnosis before treatment, or if the puppy is euthanized "put to sleep" without our permission. Our one-year limited health warranty **DOES NOT** cover the following: alopecia, hypoglycemia, cherry eye, entropion, giardia, internal/external parasites, coccidia (coccidiosis), Bordetella or kennel cough, parvovirus, distemper virus, allergies, viral/bacterial infections, mites, fleas, ticks. ALL types of mange, (collapsing trachea, tracheal hypoplasia, elongated soft pallet, stenotic nares "American Bullies are brachycephalic breeds") hernias, non-descending testicles, prolapsed urethra, open fontanel, hip dysplasia, physical problems which is or could be the result of an injury or any other disease or health condition that is treatable.

There is no guarantee your puppy can be shown or bred.

3. A deposit is required to hold/reserve any puppy. Puppies are required to be paid for in full at the time of pick-up (between 9 and 12 weeks). If you change your mind on a puppy, your deposit may be used to purchase a puppy during any of the next upcoming breeding's. Your deposit will not be refunded. Deposits are **NON-REFUNDABLE**.
4. For final payments our preferred method of payment is Cash/Zelle. For your convenience payments may also be made via Cash App, Pay Pal or Apple Pay.

By signing this agreement, you understand what you have read, and understand that we enforce this agreement 100%. You also understand that deposits are non-refundable and may only be transferred to another litter or puppy.
