9.	The Seller represents and warrants that the Seller has the necessary qualifications, experience and abilities to provide the described

qualifications, experience and abilities to provide the described services to the Purchaser. If the representations of the Seller are untrue upon the Closing Date, the Purchaser may terminate any Agreement without penalty.

Copyright Assurance & Liability Waiver

10. The Seller affirms that all original work provided under this agreement, including production, mixing, and mastering services,

will be free of unlicensed or infringing material unless the Purchaser provides such material for inclusion. If the Purchaser submits any samples, stems, or external audio files, the Purchaser assumes full legal responsibility for securing any necessary rights or licenses.

- 11. The Purchaser will receive full ownership of the final delivered work, including the right to distribute, monetize, modify, or release the work commercially without credit or attribution to the Seller. The Seller retains no rights or royalties to the final product unless a separate agreement is executed in writing.
- 12. This agreement does not constitute a collaboration or feature. Any co-authored or jointly released material will require a separate written agreement outlining terms of creative contribution and rights attribution.
- 13. The Seller is not liable for any legal disputes, copyright claims, or distribution conflicts arising from materials provided by the Purchaser or from use of the final work after delivery.
