Terms and Conditions

1. Pet sitter is authorized to perform care and services as outlined in this contract and on the service request. Pet sitter is also authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by veterinarian. Client agrees to reimburse pet sitter for expense incurred, plus any additional fee for attending to this need or any other expenses incurred for any other home/food/supplies needed. Pet owner is responsible for providing necessary supplies needed for the care of their pet including collar, harness, leash, vaccination tags, litter boxes, litter, food, cleaning supplies and medication.
2. In the event of inclement weather or natural disaster, pet sitter is entrusted to use best judgment in caring for pets and home. Pet sitter will be held harmless for consequences related to such decisions.
3. Pet owner is responsible for pet proofing house and yard, including fences and latches. Pet sitter will not be liable for any injury, death, disappearance or fines of any pet with unsupervised access to the outdoors.
4. Pet sitter agrees to provide the services stated in this contract and on the service request in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition herof, the client expressly waives and relinquishes any and all claims against said pet sitter except those arising from negligence or willful misconduct on the part of the pet sitter.
5. Client understands that this contract also serves as part of the invoice, in signing, client agrees advance payment is requested for all new clients. Returning clients may leave payment, along with the signed service request, to be picked up by the sitter on the first visit. Payments accepted in cash and check for new customers and returning customers may be invoiced by Paypal if they choose. Reservations are made to plan your sitter's availability. Therefore, clients returning home early are still responsible for the reserved amount of time. In case of an emergency, credits towards future visits may be arranged. There will be a \$25 service charge for any returned checks.
6. In the event of a personal emergency or illness of the pet sitter, client authorizes pet sitter to arrange for another qualified person to fulfill responsibilities as set forth in this contract. The client shall be notified in such an event.
7. Client is responsible for all medical expenses and damages resulting from an injury to a pet sitter or other person caused by the pet. If there is any history of aggression or biting, it is the client's responsibility to disclose this information to the pet sitter.
8. Pet sitter reserves the right to terminate this contract at any time before or during its term if the pet sitter, in its sole discretion, determines that a danger exists to the health or safety of the the pet sitter. If concerns prohibit pet sitter from caring for pets, client authorizes pet to be placed in kennel, with all charges being the responsibility of the client.
9. Client authorizes this contract is valid approval for services so as to permit No Furry Worries to accept all future telephone, online, mail or email reservations and to enter the clients home without any additional signed contracts or written authorization.
10. The client states that he/she has read this agreement in its entirety and fully understands and accepts its terms and conditions.
