SESSION POLICIES

As your child's swim instructor/coach, my goal is to provide a productive, dedicated lesson time to improve stroke technique and water safety skills. In order to accomplish this goal, we will be meeting regularly at designated times. We will both be setting aside time for our lesson, and I ask that you observe the following practices:

- **Facility:** The facility that we will be at is someone's home. Please respect their home and property. Parents should keep their distance from the lesson. If a swimmer is crying or afraid of the water please let the instructor deal with that. Their attention will stay with the instructor in the lesson much better if they are not focused on the parents. I am completely comfortable with handling kids when they are crying or upset. I will call the parent over if they are needed.
- **Web Information:** Please make sure to read the information for the lesson on my website thoroughly. By signing this document you are agreeing to the lessons as defined on the website as well as this form. The website is www.swimzone.us
- **Timeliness:** Lessons have been scheduled in advance so they meet the needs of the child, and parent(s) as well as the availability of the instructor. Our lesson will begin and end at an agreed upon time. Late arrivals will simply reduce the amount of time we have together. Please stay at the facility during the lesson. Understanding that schedules may change due to weather, we can work together to change the lesson time if the need should arise.
- **Payment:** Payment for each lesson will be due by the end of the lesson. Please be prompt with your payment. Please see the price list below for your payment amount. My preference for payment is Cash or Apple Pay. My online option is Apple Pay Use my mobile number 503-544-7010. If you don't bring cash to the lesson then I will assume that you are doing the Apple Pay version and I will send you a request through Apple Pay if you have not already sent it.
- **Cancellation policy:** Payment is required even if you forget about your scheduled lesson or cancel last minute. For private, semi-private, and private group lessons I require a 48 hour notice in order to reschedule the lesson. All parties in the lesson must agree. There will not be any refunds. For group lesson packages there will be a package price for a class which will happen on set days and times. There is no substitution, cancellation or rescheduling of these classes. If you miss your class then the lesson is considered completed.

- **CASH PAYMENT Preferred If you would like to pay in cash you my take \$5 off of the price of the lesson.**
- **Apple Pay is preferred online payment.**

Release of Liability and swimmer Assumption of Risk:

1. I agree to use Coach Keith Rountree's services and equipment at my own risk. I understand the inherent risk involved in the use of a swimming pool, and I expressly assume the risks of severe bodily injury, permanent disability, and death. I agree to follow all rules and regulations and to use the pool and equipment at any of the agreed facilities that Coach Keith is teaching at.
2. Prior to participating in any activity at the agreed facility, I will inspect the area and all equipment to be used. If I determine that anything related to this activity appears unsafe, I will immediately advise Keith Rountree prior to engaging in any activity, I will confer with my doctor or other health care professional to ensure that it is safe to do so.
3. I will not hold Keith Rountree, the property owners, or other instructors or staff liable for any injury or damage to my person, or property, or that of my family, arising from or related to my use of the agreed facility. I forever release and discharge Coach Keith, property owners, and other instructors from all claims, demands, and/or causes of action relating to any such injury or damage. Despite this Release, if I or anyone on my behalf makes a claim against Coach Keith Rountree, property owners or other instructors, I will indemnify Keith and Luan from any and all litigation costs, attorney fees, damages or other expenses arising from such claim.
4. I, the undersigned parent or legal guardian of the child(ren) under Coach Keith Rountree's care, have read the above Release and agree to its terms on behalf of my child(ren) and myself. I understand that by signing below, I am giving up substantial rights on behalf of my child(ren) and myself.
5. I understand the policies change, and that I may be asked to sign a new version of this waiver occasionally.

I have read and understood the policies set forth by Keith Rountree and agree to be responsible for them while my son or daughter is receiving services from her. I understand that services may not begin until this contract is signed by all parent and guardians and delivered to Coach Keith Rountree
