EON is the first touchless, robotic body contouring device that is challenging today's industry standards. EON is currently FDA Cleared for non-invasive lipolysis of the abdomen, flanks, back and thighs. EON autonomously tracks body contours, which guide its movements in real-time. Its proprietary cooling technology cools the skin to unprecedented levels, allowing its laser to deliver more fat-reducing energy, more consistently and more comfortably.

While 1064nm laser energy induces apoptosis, the patient's comfort is maintained via a revolutionary cooling system. The entire abdomen can be treated in 60 minutes, while the flanks can be done in 40 minutes. The body then naturally eliminates the fat cells through the lymphatic system with the best results seen at 12 weeks.




FRONT DESK TRAINING



THE FRONT DESK IS THE FIRST POINT OF CONTACT FOR NEW PATIENTS. MAKING SURE THEY UNDERSTAND EON WILL HELP INCREASE BOOKINGS FOR TREATMENTS.

The front desk personnel is your practice's first point of contact with any new customer that calls. For this reason, it is of vital importance that the front desk staff is very knowledgeable about EON to answer any questions successfully. Aside from attending EON training sessions, we encourage every member of your team (especially those responsible for answering questions) to experience EON treatments to successfully answer questions and book consultations for new and existing leads.

THE WHO, WHAT, WHEN, WHERE, AND WHY WAYS TO EDUCATE PATIENTS ABOUT EON

WHAT IS EON?

- EON is a revolutionary robotic, non-invasive body contouring device.
- EON provides personalized treatments that target and reduce your stubborn fat.
- EON induces permanent removal of subcutaneous fat cells by utilizing heat created by a well-controlled robotic laser.
- The treatment head, driven by a robotic arm, delivers consistent laser energy while heating adipose tissue up to 51°C at which apoptosis occurs.
- EON employs breakthrough jet-impingement cooling technology and real-time monitoring to create a comfortable patient experience.

WHY Should I Choose EON?

- EON is safe and effective with proven results.
- The treatment is completely touchless and comfortable.
- Treat the full abdomen in 60 minutes or both flanks in 40 minutes.

HOW THE FRONT DESK SHOULD ANSWER FREQUENTLY ASKED QUESTIONS

Are treatments painful, and are there side effects?

EON's unique cooling system will keep you comfortable during treatment. In addition, a "Quick Cool" function can be activated by the operator for comfort, or the intensity of EON can be reduced if necessary. Side effects may include light redness, mild to moderate discomfort during the treatment, soreness, or firm areas beneath the skin surface, which will resolve on their own. No cases of PAH occur with heat-based laser body contouring.

• How long is a treatment segment?

Each segment area takes 20 minutes, so, for instance, an EON treatment on the upper and lower abs would require 2-4 segments lasting 40-80 minutes. The flanks would take 20 minutes each. A Total Abdomen Treatment consists of both flanks and 2-3 segments on the stomach, taking less than 2 hours to complete. All areas can be treated in one visit.

- How many areas can I have treated, and how often can I get treatment in the same area? We suggest no less than two segments to deliver the results you are looking for; however, there is always the option for you to choose additional treatments if there is sufficient fat to treat in that area. Because EON utilizes the normal bodily function to remove fat particles, it is recommended to wait 6-8 weeks before a second treatment in the same area.
 - What about after treatment?

NO-POST TREATMENT CARE NEEDED – No straps, gels, or post massages. Patients can receive their treatment and go on with their daily life. With increased circulation, exercise and hydration have been shown to speed the body's ability to remove particles of destroyed fat cells.

• How safe is EON?

With 42 unique robotic sensors that monitor temperature, scan, and map a patient's topography for personalized treatments, EON is very safe. During treatment, the operator will check in with you periodically to ensure you are remaining comfortable. EON programming allows the operator to administer a 10-second "QuickCool" or even reduce the intensity if you become uncomfortable during the 20-minute treatment.

HOW THE FRONT DESK SHOULD ANSWER FREQUENTLY ASKED QUESTIONS

• How long before I see results?

Because EON utilizes the body's natural functions to remove the damaged fat cells, it can take up to 12 weeks to fully realize the results of your treatment. Many patients have reported seeing results as early as six weeks, especially when coupled with lifestyle changes like diet and exercise.

• What kind of results can I expect? Patients in our studies experienced the full efficacy of the treatment by 12 weeks after 2-3 segments with 20 -25% fat loss in the upper and lower abdomen.

• How long do results last?

The removal of fat cells is permanent in the area treated.

• How does EON differ from other non-invasive treatments?

EON utilizes a heated laser to induce apoptosis (damage to the fat cell membrane) while relying on normal bodily function to remove the damaged cells over time. EON's unique jetimpingement cooling maintains patient comfort while allowing for targeted heat to reach the programmed subcutaneous fat layer. (See Quick Reference Competitor Guide)

• How much does it cost?

Great question. We offer several packages depending on your consultation and the number of segments your provider chooses for treatment. A consultation is the most accurate way to determine those things. Let's get you on the schedule.



FRONT DESK PHONE SCRIPT



THE FRONT DESK SHOULD CONVERT A TELEPHONE INQUIRY TO A CONSULTATION

STAFF: Hello. Thank you for calling (name of practice). This is (staff member name). How may I help you today?

PATIENT: Hello. I wanted to learn more about body contouring/fat loss procedures. Do you offer such services at your practice?

STAFF: Yes! We have EON - Smarter Body Contouring. It is the newest device on the market and utilizes the latest technology. It typically removes about 20-25% of fat cells in the treated area. I have tried it and love my results!

I would be more than happy to set up a free consultation for you. When would you be available to come in?

PATIENT: Can you tell me more about how EON works?

STAFF: Sure! It is a non-invasive procedure that uses heated laser energy to target and permanently eliminates fat cells. Our staff can explain more during your consultation and provide visuals that make it easy to understand the technology. I would be more than happy to set up a free consultation for you. Would you be available to come in this week or next?

PATIENT: Well, how much does it cost?

STAFF: The cost will depend on your areas of concern and body goals. That is why it is best to come in for a consultation. We can answer all your questions, and you will leave here with everything you need to know to make the best decision for your body contouring treatment. Luckily the consultation is complimentary and will take a little bit of your time - probably faster than searching on Google! I would be more than happy to set up an appointment at your convenience. We have some availability (provide the earliest date and time available on the schedule). Would that work for you?

PATIENT: You said non-invasive. Does that mean that the doctor doesn't have to cut anything? What is the downtime for this procedure?

STAFF: That is correct. EON treatments are non-surgical, so there is no downtime at all. You can return to your normal activities immediately after the treatment. You could even put a bikini on right after and go to the pool if you so wished!







THE FRONT DESK SHOULD CONVERT A TELEPHONE INQUIRY TO A CONSULTATION

PATIENT: Can I do this during my lunch break? Can I return to work?

STAFF: Yes! Most patients can treat the whole abdomen in just one hour. You can certainly return to work right after! I would be more than happy to book a free consultation for you. During the consultation, we can determine a plan and tell you exactly how much time you would need for treatment so that you can plan accordingly.

PATIENT: Is the treatment painful? What does it feel like?

STAFF: It depends on the person and their pain threshold. For example, when I had my treatment, I felt nothing whatsoever. It was super comfortable, and I was on my phone the whole time watching a show. Our EON tech will be there with you the entire time, and if you feel any discomfort, there are things that we can do to make your treatment more comfortable. However, most people find it more tolerable than any other device on the market.


PATIENT: I have recently heard about the issues with CoolSculpting and Linda Evangelista. Is EON safe? Do the issues Linda faced happen with EON?





HOW TO SPEAK ABOUT EON SMARTER BODY CONTOURING

Autonomous technology maps the body's unique topography for personalized treatment while accurately delivering an unprecedented degree of fat-reducing energy. EON keeps the skin substantially cooler, all without ever touching the patient. An entire abdomen can be treated in 60 minutes with unrivaled efficacy, free from time-consuming gels, applicators, or post-treatment massages needed with other body contouring devices. Although results vary among individuals, studies show patients experienced a 21.6% average fat reduction (25.3% in the lower abdomen) after a single 60-minute treatment. EON is FDA cleared for treatment of the thigh, flank, abdomen, and back.

How long is a treatment?

YOUR EON MARKETING KIT WILL INCLUDE AN EON FLOOR STICKER AND AN LED RING LIGHT TRI-POD WITH AN IPHONE HOLDER.

SETTING UP A DEDICATED PHOTO AREA

- Use a dark, non-textured background in your office.
- Place the first EON sticker 12 inches away from the backdrop or dark non-textured wall. This is where the patient will stand.
- Use the measuring tape to place the second EON sticker 36 inches away from the first sticker on the floor. This is where the TRIPOD will be placed.
- Plug in the tripod and turn the switch on.







TAKING BEFORE AND AFTER PHOTOS

- Position patient in front of the dark background on the patient sticker facing the tripod.
- Adjust the tripod to be level with the patient's abdomen.
- The patient should take a deep breath and exhale.
- Patient places their arms above their head (as shown in the photo below).
- Take pictures from the 8 angles per EON recommendations.
- Patient is to return after 6 and 12 weeks to take EON progress photos.





INFORMED CONSENT DOCUMENT AGREEMENT TO RECEIVE LASER TREATMENT

INTRODUCTION

EON is a non-invasive abdominal fat reduction device. EON uses a 1064nm laser to heat the fat layer up to 51°C / 123.8°F. The treatment head simultaneously delivers laser energy and cooling air to keep the skin safe and comfortable (39.5°C / 103.1°F).

INCLUSION CRITERIA

You must:

- At least 18 years of age.
- Have abdominal adipose (fat) thickness of at least 20 mm (about 3/4 inches) thickness.
- NOT be Pregnant.
- NOT have any piercings or tattoos in the treatment area.
- NOT have scar tissue, rash, or previous surgical incision in the treatment area.

PATIENT RESPONSIBILITIES

You must:

- Wear your Dominion-provided laser safety glasses as long as the device is on.
- Tell the device operator about any criteria that may disqualify you.
- Ask questions as you think of them.
- Tell the device operator if you change your mind about receiving treatment.

RECEIVING TREATMENTS

It is your choice whether to receive an EON laser treatment or not. You may choose to stop the treatment at any point.

TREATMENT

PREPARING THE PATIENT FOR BACK OF THIGH TREATMENT

- Take before photos of the patient's full thigh.
- Mark the treatment area on the patient with a white pen.
- The patient should be in a comfortable position lying on their stomach.
- The top of the back of thigh should be at the handlebar level.
- The treatment area should be facing up and as flat as possible with the EON lumbar pillow under the top of thigh and a rolled towel under the front of the ankle.
- Stay 1-2 inches away from the groin area and 2-3 inches away from the knee joint and tendons.







PERFORMING THE TREATMENT

- 1. Inspect the device before powering it on.
- 2.Use reflective stickers to cover scars or small tattoos in the treatment area.
- 3. Select Treatment Parameters-
 - Male/Female
 - Select Horizontal (Rt to Lt for Thigh)
 - Small/Medium/Large
- 4.Extend Arm
- 5. Stage Head (Never more than 3/4 inch away)
- 6.Scan Area

- 7. Test Area.
- 8. Confirm safety check.
- 9. Begin treatment-
 - Treatment starts at Maximum by default.
 - Adjust treatment power level as needed.
 - o Maximum, Normal, or Lite
 - You can end treatment at any point.
 - Use the pause button to briefly stop treatment and apply stickers.



For banana roll come 1 inch down from the buttocks fold so that the feathering of the laser does not kill fat in the buttocks and only on intended area.

PREPARING THE PATIENT FOR BACK TREATMENT

- Take before photos of the patient's full back.
- Mark the treatment area on the patient with a white chalk pen.
- Avoid the spinal structure which needs covered with laser stickers prior to treatment.
- The patient should be in a comfortable position lying on their stomach without any clothing in the treatment area. Bra should be removed for bra fat treatments.
- The top of the back should be at the handlebar level and the treatment area should be facing up and as flat as possible. For Bra Fat treatment, place a rolled pillow under the chin and tuck arms under patient as shown below. Alternative positioning is to use a full size pillow under head, shoulder and stomach to fully flatten the back and bra fat area.

INSPECT THE DEVICE BEFORE POWERING IT ON

- Before turning EON on, inspect the device and its surroundings.
- Inspect the umbilical (A) for any visible damage, tear, kinks, or twists.
- Inspect the treatment head (B) for any visible damage.
- Ensure that the robot is in the retracted position (C).
- Make sure the power cord is not a trip hazard.







- Connect the Door Interlock (A).
- Insert the power cord into the device (B), twist to lock!
- Insert the power cord into the wall receptacle (C).
- Turn on the circuit breaker (D).
- Press the power button.














START-UP, COUPONS, AND SETTINGS

- Start up the device and enter your 6-digit operator code when prompted.
- Coupon codes can be entered by clicking the coupon icon in the upper left-hand corner.
- Settings can be accessed by clicking on the settings icon in the upper right corner.
 - Change color from dark to light on interface.
 - Turn the device on to demo mode (no laser emitted).
 - Shutdown, Idle, and Logout options.
















START TREATMENT

- Press Next
- Confirm Safety Check
 - Physically tap the screen to check off Safety Check List.
- Press the physical button on EON Device below the screen that is blinking - when ready to start.

TREATMENT SCREEN

- Treatment starts at Maximum by default.
- Adjust treatment power level as needed.
 - o Maximum, Normal, or Lite
- You can end treatment at any point.
- Use the pause button to briefly stop treatment and apply stickers.
- Resume within 30 seconds, or treatment will end.









MANAGING TREATMENTS

- Treatments are generally very comfortable.
- If the patient reports any discomfort, ask:
 - Is it a hot spot? If yes, use a reflective sticker to block the laser from heating that spot.
 - Is the entire treatment area hot? If yes, use QuickCool as needed and/or lower the power setting.
 - Is it hot along the edges? If yes, you may be treating an area that doesn't have enough fat. Stop the treatment and try a smaller size.

USING REFLECTIVE STICKERS

- Ask the patient to point to (using a finger, pencil, etc.) the spot where they feel the discomfort.
- Prepare the reflective sticker (peel it off and have it ready).
- From the EON treatment screen, press "Pause."
- Apply the sticker and quickly (30-second timeout) press "Resume" on the EON treatment screen.
- Use to cover any localized areas of discomfort (a.k.a. hot spots).
- The discomfort spot is usually small in size but tricky to pinpoint.
- If you cover a spot and the patient says it's still the same (still not comfortable), DO NOT apply a second sticker to cover a larger area but rather move the existing sticker around.
- Only use Dominion-provided stickers!















SAFETY REMINDER

- An operator must be in the room when the laser is active.
 - Blue LEDs turn on when the laser is on.
- In case of emergency, push the E-Stop.
 - Immediately will cut all power to the device.

IDLE

- The device will go into Idle mode if left unused for 30 minutes.
- To manually set the device to Idle, press the Idle button.
- Dehumidification cycle:
 - 15 minutes
 - Once the dehumidification is complete (15 minutes), the device turns off the air and runs the screen saver.
- You can cancel out of the idling cycle and return to cool down.
- Press "Activate" to reactivate the device.
- Press "Shutdown" to shut down the device.

SHUTDOWN

- Press the Shutdown button.
- Press "Yes" to confirm the shutdown.
- The device will go through a shutdown cycle.
- Takes 15 minutes (dehumidification).
- Prevents internal condensation.
- Once complete, the device turns off automatically.
- DO NOT USE E-Stop/Power buttons to shut down the device.





REFERENCE WORDS

STARTUP (COOLING) TIME

- This is the time the device takes to perform a self-check, get the laser ready, and cool down the air.
- It is usually between 5 and 7 minutes.
- If there is an issue with the cool down process, the device will display an error message.

SHUTDOWN (WARMING) TIME

- This is the time it takes the device to complete a dehumidification cycle.
- It is always 15 minutes.
- The operator doesn't have to be present; the device will shut down automatically after 15 minutes.
- It's the only proper way to turn the device off.

DOOR INTERLOCK

- If the door interlock is open, the device will turn on, but the laser won't fire.
- The aiming beam won't turn on.
- The software won't allow you to start treatment.

POWER PLUG

• Make sure the room is equipped with a 110V/20A receptacle.



REFERNCE WORDS



E-STOP

- E-Stop should only be used in emergency situations!
- It requires some force to press it
- If you try to turn on the device while the E-Stop is pressed, the device will beep but will not turn on.
- E-stop cuts power to all internal components, including the robotic arm.
- Once you hit e-stop, and if the arm is extended, the arm will fall down due to gravity.
- Whenever possible, catch the arm and prevent it from falling down to prevent any damage to the sensitive optics in the head.
- Same rule (catch the arm) if you have to do a hard-reset (press and hold the power button for 5 seconds).
- Do not use the power button or e-stop to turn off the device in normal conditions. Doing so may cause device issues and/or void your warranty. The device sends a warning to Dominion every time a hard shutdown (using an e-stop or power button) is performed.

REFLECTIVE STICKERS

- Ask the patient to point to (using a finger, pencil, etc.) the spot where they feel the discomfort.
- Prepare the reflective sticker (peel it off and have it ready).
- From the EON treatment screen, press "Pause."
- Apply the sticker and quickly (30-second timeout) press "Resume" on the EON treatment screen.

QUICKCOOL & POWER LEVELS

- QuickCools stop laser energy and blast only cold air onto the skin's surface.
 - Use QuickCool to manage patient comfort as needed.
 - When dropping laser energy, an automatic 10-second Quickcool will occur before laser energy comes back on.
- The difference between the three power levels is how hot the fat gets in the initial heating part of the treatment. Max, normal, and lite.
