Dear Elizabeth's Landing Homeowner,

As a member and homeowner in Elizabeth's Landing, you have the opportunity to select the individuals who voluntarily serve the community as members of the Elizabeth's Landing (ELCA) Board of Directors. The Annual Meeting is scheduled for May 20, 2024, at 7:00 p.m., in the Community Farmhouse.

This ballot gives members the opportunity to vote, in person or by proxy, for ELCA Board members. There are two (2) Board positions open. You must complete the ballot(s) form and proxy form, if you are unable to be present at the meeting, for your vote to count. After you have marked and completed the enclosed ballot/proxy form you may:

- Mail it to ELCA at P.O. Box 656, Pasadena, MD 21123, or
- Hand-deliver it to the Association Office front door drop box, or
- You or your proxy may bring it to the meeting.

It is required that we receive valid ballots or proxies from at least 25% of the community members entitled to vote — one vote per unit according to our Association By-Laws. If we do not receive at least 25%, we will not meet quorum and this first 2024 Annual Meeting cannot be held. However, we will have the program and invited speakers. If a quorum is not present, in person or by proxy, at the Annual Meeting scheduled for May 20, 2024 pursuant to Md. Corporations and Association Code, Section 5-206, another meeting may be called for the same purpose; in accordance with this law, if the number of owners present in person or proxy at the original meeting is not enough to establish quorum, a second meeting may be called if the meeting notice so states and a majority of the owners present in person or by proxy call for the additional meeting.

If we cannot hold the first meeting, we will be required to hold the Annual Meeting at a later date. Those present, in person or by proxy, who attend this second meeting would constitute a quorum. If we are required to have a second meeting it would be held on June 17, 2024, at 7:00 p.m. in the Community Farmhouse. (ELCA By-Laws, Article IX, Meetings of Members, Sections 1, 3, 4, 5, and 6).

Information for both meetings is included in this mailing and will also be posted on elizabethslanding.com.
