The Public Hearing for the adoption of the budget amendment to the FY 2023 – 2024 budget for the Cedar County Emergency Management Commission was called to order at 6:25 pm on Thursday, April 11, 2024 by Jon Bell, Chair, Cedar County Emergency Management Commission. A roll call vote was taken.
